SOMALIA SUPPORT GROUP

You will see from the attached telegram 194 from Washington that Camdessus is asking for our early agreement to participate in a Support Group (SG) for Somalia. The Italians have agreed to Chair a group and the US and Saudi Arabia have already indicated that they will participate. The Somali Fund-monitored programme will be discussed in the Board on 5 July and we are asked for a steer on this proposal by close of play on Thursday, 29 June.

- 2. We cannot at this stage agree to any financial contribution Somali Support Group because we have suspended aid disbursements on human rights grounds. But UKDEL believe we can join nonetheless.
- We support the intensified collaborative approach to arrears cases at the IMF. Given that this is a relatively small case (arrears of \$76 million to the Fund), prospects for success in meeting the financing target are reasonably satisfactory. agreed a programme with the Fund staff. The participation of the UK and other G5 is viewed as critical to the success of We, the French, the Germans, and the Japanese are all being approached in parallel.
- We have discussed Somalia with the Bank of England, ODA and 4. FCO. The Bank agree that UK participation would be justified and ODA officials are content provided that:-

- i. We make clear at the outset that there is no prospect of providing any more finance than the £5 million already offered (and in the Aid Budget) to co-finance a World Bank programme.
- ii. We make it known to the SG that we are unable, at this stage, to give any indication as to timing of disbursements and that this would depend on satisfactory performance on human rights, which will be reviewed by us later this year.
- iii. In any case there could be no disbursements this financial year.
- 5. We think that there is every justification for making our participation conditional not only on the points above, but also on the participation of others. We propose to say that we would agree to participate only on the basis that France, Germany and Japan participate as well. (But point 4(i) above may be hard to sustain in practice).
- 6. Are you content with this line? If so, we shall draft an instructing telegram accordingly provided Mr Patten is also content.

#### SUMMARY

- 1. CAMDESSUS CALLS FOR EARLY AGREEMENT TO PARTICIPATE IN SOMALI SG. SAUDI ARABIA ANNOUNCES PARTICIPATION.

  DETAIL
- 2. CAMDESSUS (FUND MD) CALLED A MEETING OF FUND EDS ON FRIDAY TO URGE PARTICIPATION IN THE SOMALI SG. HE STRESSED THE IMPORTANCE OF SUCCESS WITH SOMALIA FOR THE FUTURE OF THE FUND'S COOPERATIVE STRATEGY ON ARREARS. HE EMPHASISED ALSO THAT SOMALIA NEEDED, AND DESERVED, AN EARLY RESPONSE FROM THE FUND ON WHETHER THE SG PROCESS WOULD BE TAKEN FORWARD.
- 3. CAMDESSUS' COMMENTS WERE ECHOED BY FINAISH (LIBYA, REPRESENTING SOMALIA) AND FILOSA (ITALY, CHAIRMAN OF SOMALI SG). FINAISH RECALLED THAT SOMALIA HAD BEEN COOPERATING WITH THE FUND IN ADOPTING APPROPRIATE POLICIES SINCE LATE 1988. HE FELT THAT THE RESPONSE FROM THE INTERNATIONAL COMMUNITY SO FAR WAS NOT COMMENSURATE WITH THE EFFORTS THE SOMALIS HAD BEEN MAKING. FILOSA SUMMARISED THE PAPER HE HAD CIRCULATED BEFOREHAND (SENT SEPARATELY BY BAG TO LONDON). HE WOULD BE READY TO DISCUSS ALTERNATIVE FINANCING SCENARIOS SOON.
- 4. AL-ASSAF (SAUDI) ANNOUNCED THAT HIS AUTHORITIES HAD AGREED TO JOIN THE SG, THROUGH THE SAUDI FUND FOR DEVELOPMENT. HE URGED OTHERS TO COME FORWARD. WARNER (US) RE-STATED HIS AUTHORITIES' COMMITMENT TO THE SG. HE REPORTED THAT THE US WAS RE-EXAMINING THE BALANCE OF ITS CONTRIBUTIONS TO SOMALIA BETWEEN CONTINUED BILATERAL SUPPORT AND MULTILATERAL SUPPORT THROUGH THE SG.
- 5. CAMDESSUS ASKED SERRE (FRANCE) AND FINAISH, IN RESPECT OF OTHER MEMBERS OF HIS CONSTITUENCY (WHICH INCLUDES KUWAIT, UAE, OMAN AS WELL AS LIBYA) WHETHER ANY ADDITIONAL PARTICIPATION WAS IN PROSPECT. NEITHER WAS ABLE TO GIVE ANY COMMITMENT.
- 6. GOOS (GERMANY), STRESSING THAT HE WAS SPEAKING IN A

PERSONAL CAPACITY, SUGGESTED THAT A FIRM DATE SHOULD BE SET BY WHICH COMMITMENTS TO PARTICIPATE IN THE SG SHOULD BE SOUGHT: WITHOUT SUCH A DEADLINE THERE WAS NO PRESSURE TO REACH DECISIONS. HE SUGGESTED ALSO THAT IT WOULD BE COUNTERPRODUCTIVE TO INTERMINGLE THE ISSUE OF WHETHER COUNTRIES WERE WILLING TO PARTICIPATE WITH THAT OF HOW MUCH CONTRIBUTION THEY MIGHT MAKE. HE ADDED THAT THERE WAS SO FAR NO CHANGE IN THE GERMAN POSITION.

- 7. NO OTHER DIRECTOR SPOKE.
- 8. AFTER SOME DISCUSSION BETWEEN CAMDESSUS, ERB (FUND DEPUTY MD) AND FILOSA, IT WAS AGREED THAT THEY WOULD HAVE TO RESPOND TO THE SOMALIS BY THE END OF JULY AT THE VERY LATEST WHETHER AN SG WAS FEASIBLE. TO THAT END THEY URGED DIRECTORS TO BE IN A POSITION TO MAKE A COMMITMENT BY THE TIME OF THE FORTHCOMING DISCUSSION ON SOMALIA'S ARREARS AND PROSPECTIVE FUND-MONITORED PROGRAMME, SCHEDULED FOR 5 JULY.
- THIS WAS AGAIN A SOMEWHAT AWKWARD MEETING, WITH CAMDESSUS WAITING FOR RESPONSES FROM DIRECTORS TO HIS EXHORTATIONS, WITH APPARENT DIFFERENCES EVEN WITHIN FUND MANAGEMENT ON TIMINGS OF DECISIONS, AND WITH NO CLEAR FEELING OF FORWARD MOMENTUM. IN PART THIS REFLECTS THE CHAIRMANSHIP OF FILOSA, WHO DOES NOT HAVE THE CHARISMA AND DRIVE WHICH MASSE BROUGHT TO THE GUYANA SG. IN PART, HOWEVER, THIS REFLECTS THE FACT THAT FILOSA SO FAR HAS VERY LITTLE AUTHORITY FOR ANY DECISIONS, WITH ONLY THE US OF THE G7 YET COMMITTED TO THE SG. THE UK IS CLEARLY CENTRAL TO THIS, AS INDEED WE WERE TO GUYANA, IN ESTABLISHING THE GROUP AS GENUINELY MULTILATERAL. AFTER THE MEETING BOTH MASSE (CANADA) AND YOSHIKUNI (JAPAN) SPOKE TO ENOCH ASKING WHAT THE UK POSITION ON SOMALIA WAS. LATER, AT AN INFORMAL FUNCTION, CAMDESSUS TOOK THE OPPORTUNITY TO SAY TO ENOCH THAT HE HAD BEEN DISAPPOINTED THAT THE UK HAD NOT BEEN ABLE TO COMMIT ITSELF YET TO THE SG, AND THAT HE HOPED VERY MUCH FOR A COMMITMENT SOON. (ALL THREE RECEIVED NON-COMMITTAL ANSWERS: ONLY FILOSA HAS BEEN INFORMED OF THE UK'S HUMAN RIGHTS CONCERNS.)
- 10. THESE APPROACHES BY FUND STAFF AND OTHER EXECUTIVE DIRECTORS CONFIRM OUR SUSPICION THAT UK (AND ALSO CANADIAN) PARTICIPATION IN INDIVIDUAL SGS IS CRUCIAL TO THEIR SUCCESS. STRONG INTELLECTUAL PARTICIPATION DOES NOT NECESSARILY MEAN COMMENSURATE FINANCIAL CONTRIBUTIONS, PARTICULARLY AT A TIME WHEN THE SURVIVAL OF THE GENERAL ARREARS STRATEGY, RATHER THAN THE DETAILS OF ANY PARTICULAR FINANCING PACKAGE, IS

PAGE 2 CONFIDENTIAL UPPERMOST IN THE MINDS OF IMF MANAGEMENT AND OTHER EDS. IN THE CASE OF SOMALIA, FILOSA IS, OF COURSE, WELL AWARE OF OUR HUMAN RIGHTS CONCERNS AND THAT WE CANNOT MAKE ANY FINANCIAL CONTRIBUTION TO THE SG UNTIL THE RESULTS OF THE AMNESTY MISSION (DUE IN JUNE?) HAVE BEEN STUDIED IN LONDON. GIVEN THESE REALITIES, WE FEEL CONFIDENT THAT AN INFORMAL ARRANGEMENT COULD BE REACHED WITH FILOSA WHEREBY WE JOIN HIS SG ON THE UNDERSTANDING THAT: (A) HE DOES NOT PRESS THE UK FOR A FINANCIAL CONTRIBUTION UNTIL WE SIGNAL WE ARE READY TO MAKE ONE (ALTHOUGH HE IS, OF COURSE, AT LIBERTY TO USE THE BRITISH LINKAGE BETWEEN AID AND HUMAN RIGHTS TO PRESSURE THE BARRE REGIME TO SOFTEN THEIR JACKBOOT IMAGE) AND (B) IF AND WHEN WE ARE READY TO CONTRIBUTE, HE DOES NOT PRESS THE UK FOR MUCH MORE THAN THE AMOUNTS WE INITIALLY OFFER (E.G. OUR PROPOSED COFINANCING OF THE WORLD BANK'S ASAP II). IF WE COULD REACH SUCH AN UNDERSTANDING, WE BELIEVE THAT JOINING THE SOMALIA SG BY JULY 5, WHEN THE FUND-MONITORED PROGRAMME IS DISCUSSED BY THE BOARD, WOULD BE VERY HELPFUL IN RAISING THE UK PROFILE AND SHAPING THE RULES OF THE GAME FOR FUTURE SGS WITHOUT INVOLVING DIPLOMATIC EMBARRASSMENT OR HEAVY FINANCIAL COST. GRATEFUL FOR A STEER ON THIS PROPOSAL BY C.O.P. ON THURSDAY, 29 JUNE. 11. FCO PLEASE PASS TO EVANS AND WALSH (HMT), WARE (BOE),

RICHARDSON (ERD), AINSCOW, HUDSON AND POWER (ODA).

The Italian Authorities hope that your Gouvernment will play an active role in contributing to the success of this action aimed at easing major problems that Somalia is facing.



Dear Colleague,

As you know, the Managing Director of the Fund has informed the Board of his intention to request\_the formation of a .... Support Group for Somalia to favor the clearance of arrears and the economic recovery of this country, thus laying the basis for the medium-term viability of its balance of payments. It has also been indicated that Italy should chair the Support Group.

Such an international function does involve a number of risks and heavy responsibilities. Nonetheless — though not withour concern — my country is ready to accept the leadership of the Support Group for Somalia to give increasingly more meaning to the spirit of the "Cooperative Approach" we all endorsed in the Interim Committee, and offer this country the benefit of the much needed international support in the effort to adjust its economy. Besides, we consider it one of the G-10's duties to contribute actively towards fostering international cooperation. Finally, to address successfully the case of Somalia would help to indicate clearly that a workable solution of the issues affecting the use of Fund's resources and its income position has been found.

However, although we are prepared to stretch our efforts, we do not think to be able to start this operation to a favourable outcome without prior commitment in principle and substantial support on the part of all major industrial countries. It is my Government's firm belief that those who inevitably share a larger portion of responsibilities in the international context and have the utmost interest in its stability and orderly functioning, should avoid sending a wrong signal to the international community by excluding themselves from, or limiting their, participation in this initiative. Following the success of the Support Group for Guyana, a positive outcome in the case of Somalia would reinforce international confidence and have an important catalytic effect on future similar operations. I am sure you will concur with me that what is at stake here is not only the future of Somalia, but the present strategy to tackle the most difficult cases of poor, indebted countries and to preserve the Fund's liquidity.

It is clear that any effort on our part will be vain without the support of some relevant parties like your country. I therefore sincerely hope you will be willing to join Italy in the effort to solve the problems of Somalia and that you will, accordingly, instruct your representative in the IMF to inform the Italian Executive Director, Mr. Filosa, — who will be appointed Chairman of the Support Group — of your country's intention to support this operation and the likely size of your country's contribution. My Government is prepared to



commit 15 million U.S. dollars for this exercise in international solidarity.
