

THE INDEPENDENT, IN A PIECE BY THEIR POLITICAL CORRESPONDENT HEADLINED QUOTE SIX COUNTIES BOSS SCUTTLES US SUMMIT UNQUOTE RECORDS THE HISTORY OF GOVERNOR CAREY'S INITIATIVE, AND ALSO GOES ON TO STATE THAT MR O'KENNEDY'S REACTION TO MR ATKINS ANNOUNCEMENT WAS VERY LOW KEY (SEE MIFT). BUT THE ARTICLE ALSO SUGGESTS QUOTE A NEW ROW COULD DEVELOP BETWEEN THE BRITISH GOVERNMENT AND MR LYNCH'S GOVERNMENT. THE LETTER FROM MR ATKINS STRESSED THAT THE FUTURE OF NORTHERN IRELAND WAS A MATTER FOR THE BRITISH GOVERNMENT, THE PARLIAMENT OF WESTMINSTER AND THE PEOPLE OF THE PROVINCE. THAT APPEARS TO RULE OUT ANY IRISH GOVERNMENT PARTICIPATION IN FUTURE NEGOTIATIONS UNQUOTE.
- 3. A BALANCED LEADER IN THE SAME PAPER SUGGESTS. THAT THE CONTENT OF MR ATKINS' STATEMENT IS NOT UNEXPECTED. QUOTE DESPITE ALL THE PUBLICITY SURROUNDING THE INVITATION IT WAS CLEAR FROM THE START THAT MR ATKINS HAD BEEN QUOTE CAUGHT ON THE HOP UNQUOTE BY THE INVITATION AND THAT HE WAS UNLIKELY TO ATTEND UNLESS THE BRITISH CABINET APPROVED HIS VISIT. FROM THE IRISH POINT OF VIEW A MEETING UNDER GOVERNOR CAREY MIGHT HAVE RESULTED IN SOME FURTHER PUBLICITY FOR THE NORTHERN PROBLEM BUT AGAIN IT MIGHT HAVE RESULTED IN NOTHING MORE THAN A FURTHER INSISTENCE THAT WE IN THE SOUTH ARE DOING NOTHING ABOUT CROSS-BORDER SECURITY - A PERPETUAL THEME OF ALL BRITISH COMPLAINTS UNQUOTE. THE EDITORIAL THEN REFERS TO A SEPERATE FRONT PAGE STORY SUGGESTING THE HMG ARE SELLING OFF OFFICIAL ASSETS IN THE NORTH AND CONCLUDES QUOTE THIS SHOWS THAT LONDON IS CLEARLY DECIDING THAT THE NORTH IS AN EXPENSIVE AND UNGRATEFUL AREA WHICH SHOULD NOT BE ALLOWED TO COST THE BRITISH TAXPAYER MORE THAN AT PRESENT AND LONDON KNOWS THAT THE BRITISH PEOPLE AS A WHOLE WILL APPROVE OF THAT ATTITUDE UNQUOTE.

4. THE IRISH TIMES IN A REPORT BY ITS LONDON EDITOR SAYS THAT THE FINAL DECISION TO TURN DOWN GOVERNOR CAREY'S PROPOSAL WAS TAKEN TA MID-DAY MEETING LASTING ABOUT AN HOUR BETWEEN MR ATKINS AND MRS. THATCHER. MR O'KENNEDY IS QUOTED AS SAYING THAT THE BRITISH REJECTION OF GOVERNOR CAREY'S INVITATION WAS A REFUSAL TO ATTEND THAT PARTICULAR MEETING, NOT A REJECTION OF THE LEGITIMATE INTEREST IN IRISH AFFAIRS OF RESPONSIBLE IRISH/AMERICAN POLITICIANS. MR O'KENNEDY ALSO SAID THAT MR ATKINS HAD TELEPHONED HIM PERSONALLY YESTERDAY TO TELL HIM OF THE DECISION NOT TO ACCEPT THE GOVERNOR'S INVITATION BECAUSE THE PUBLICITY SURROUNDING IT HAD MEANT THAT IT WOULD NOT HAVE BEEN POSSIBLE TO HAVE HAD A SUCCESSFUL MEETING IN THE TERMS IN WHICH IT HAD BEEN ORIGINALLY UNDERSTOOD. EARLIER YESTERDAY MR O'KENNEDY SAID THAT HE BELIEVED THAT THE BRITISH GOVERNMENT RECOGNISED THE LEGITIMATE IRISH/AMERICAN INTEREST IN TRYING TO ENSU THAT THERE WAS NOT A CONTINUING STALEMATE IN THE NORTH. HE THOU I BRITAIN SAW THIS INTEREST AS A POSITIVE THING.

5. THE IR'SH PRESS NOTES THAT MR ATKINS SAID THAT IT WOULD BE WRONG FOR A BRITISH MINISTER TO PARTICIPATE IN DISCUSSIONS OR NEGOTIATIONS ABOUT THE POLITICAL FUTURE OF A PART OF THE UNITED KINGDOM IN THE UNITED STATES OR ANYWHERE ELSE CUTSIDE THE UK AND GOES ON TO STATE QUOTE THEIS APPARENT REJECTION BY THE BRITISH NOT JUST OF ANY AMERICAN INFLUENCE ... BUT ALSO OF THE IRISH GOVERNMENT'S ROLE IS EXPECTED TO BE CHALLENGED AT THE EARLIEST OPPORTUNITY BY THE TAOISEACH, MR LYNCH, IT WAS BEING POINTED OUT IN POLITICAL CIRCLES LAST NIGHT THAT MR ATKINS' STATEMENT SEEMED TO OVERLOOK HIS OWN RECENT TALKS IN DUBLIN AS WELL AS THOSE OF HIS PREDECESSORS AS NORTHERN I RELAND SECRETARY UNQUOTE. THE PRESS ALSO STATES THAT SEAMUS MALLON (SDLP) HAD CRITICISED MR ATKINS STATEMENT BECAUSE ITP PUT HIM INTO A NEGOTIATING STRAIGHTJACKET. MR MALLON IS QUOTED AS SAYING THAT MR ATKINS KNEW FULL WELL THAT THE PROBLEMS IN THE SIX ' COUNTIES COULD BE SOLVED ONLY THROUGH NEGOTIATION AND DISCUSSIONS WHICH INCLUDE THE IRISH GOVERNMENT AS A RIGHT. IT WAS TO BE HOPED THAT THE SECRETARY OF STATE FACED UP TO THIS REALITY BEFORE EMBARKING ON AN APPROACH WHICH WAS DOOMED TO FAILURE.

1. FOR THE RECORD FOLLOWING IS INFORMATORY TEXT OF LETTER DATED 23
AUGUST FROM SECRETARY OF STATE FOR NORTHERN IRELAND TO GOVERNOR
CAREY OF NEW YORK, COPIED TO YOU BY BAG. THIS TEXT WAS CONVEYED
CRALLY TODAY TO GOVERNOR CAREY'S SECRETARY BY CONSULATE-GENERAL NEW
YORK. SIGNED ORIGINAL LETTER BEING DESPATCHED BY HAND OF PILOT
FLIGHT BA 175 24 AUGUST ARRIVING JF KENNEDY AIRPORT NEW YORK AT
1335 HOURS (LOCAL TIME) SAME DAY FOR COLLECTION BY CONSULATE GENERAL.

2. TEXT AS FOLLOWS:

DEAR GOVERNOR

THANK YOU FOR YOUR LETTER OF 6 AUGUST. AS I TOLD YOU WHEN WE MET IN LONDON, THE UNITED KINGDOM GOVERNMENT WELCOMES THE INTEREST YOU HAVE SHOWN OVER THE PROBLEMS OF NORTHERN IRELAND IN PARTICULAR YOUR STAUNCH STAND AGAINST TERRORISM. IT IS HOWEVER CLEAR FROM THE TERMS OF YOUR LETTER THAT THE MEETING WHICH YOU ENVISAGE WOULD BE- AND COULD NOT FAIL TO BE - A MEETING TO DISCUSS AND INDEED NEGOTIATE ABOUT THE POLITICAL FUTURE OF NORTHERN IRELAND, A PART OF THE UNITED KINGDOM.

I AM SURE YOU WILL UNDERSTAND THAT IT WOULD BE WRONG FOR A MINISTER OF HER MAJESTY'S GOVERNMENT TO TAKE PART IN A DISCUSSION OF THAT NAT-URE IN THE UNITED STATES OR INDEED ANYWHERE ELSE OUTSIDE THE UNITED KINGDOM. HER MAJESTY, S GOVERNMENT RECOGNISE THE DEEP INTEREST OF IRISH PEOPLE WHEREVER THEY MAY BE IN THE PROBLEMS OF NORTHERN IRE-LAND. HOWEVER AS I MADE CLEAR IN THE STATEMENT I ISSUED ON 7 AUGUST FOLLOWING YOUP OWN PUBLIC STATEMENT IN NEW YORK, THE POLITICAL FUTURE OF NORTHERN IRELAND IS A MATTER FOR NEGOTIATION BETWEEN HER MAJESTY, S GOVERNMENT, THE PARLIAMENT AT MESTMINSTER AND THE PEOPLE OF THE PROVINCE.

THANK YOU FOR COMING TO SEE ME - I ENJOYED WHAT WAS FOR ME A VAL-WABLE DISCUSSION WHEN WE MET IN LONDON, AND I LOOK FORWARD TO SEEING YOU AGAIN. NORTHERN IRELAND

Note of a conversation between the Prime Minister and the Secretary of State for Northern Ireland at 10 Downing Street on 23 August 1979 at 12 noon

The Secretary of State for Northern Ireland called on the Prime Minister, at her request, at No. 10 on 23 August at 12 noon, accompanied by Mr. K.R. Stowe.

The Prime Minister told Mr. Atkins that there could be no question of talking to Governor Carey about Northern Ireland. Mr. Atkins said that he agreed, at this stage. The Prime Minister said that Governor Carey could come to the UK if he wished to do so: but Northern Ireland was part of the United Kingdom and she herself would not think of discussing with President Carter, for example, US policy towards their black population. Prime Minister said that she wished to set the record straight publicly, in view of misleading reports which had appeared in the Press.

Mr. Atkins said that he had already made it clear to the Press, in his own statement early in the month, that he had no intention of meeting Governor Carey. The Prime Minister said that the point had not been got across sufficiently. Mr. Atkins said that he did not totally exclude the possibility of meeting Governor Carey at some stage, along with other leading Irish Americans. Governor Carey was not a complete villain; he had, for example, condemned the IRA and terrorism, bracketing the IRA with the PLO and other terrorist groups. Governor Carey's position had helped to reduce the flow of supplies of money from the US to the IRA. The Prime Minister said that there could nevertheless be no question of discussing the future of Northern Ireland in the US.

Mr. Atkins asked the Prime Minister to reflect on what we really wished the US to do. The first objective should be to make the Americans realise that the more they talked the more difficulties

they created for is in Northern Ireland. Our second objective should be to reduce still further the flow of money and sympathy from the US to the IRA. The Prime Minister commented that this was all too complicated. She was not in the habit of discussing the internal problems of the US with the Americans and they should not attempt to do so with us. The Americans must be made to realise that for so long as they continued to finance terrorism, they would be responsible for the deaths of US citizens (as had happened in the Hilton Hotel explosion in Belfast) as well as others. They must realise that while this went on, the British Government would attack and condemn them. The UK should not be perpetually on the defensive; Governor Carey had already got away with a great deal so far as UK public opinion was concerned. The Americans must be brought to face the consequences of their actions.

Mr. Atkins conceded that this was one way of approaching the problem: there was another, which was to try to talk to the American people, who were basically friendly to the UK, and to reason with them about the consequences of their actions. The Prime Minister said that we should not always turn the other cheek. Mr. Atkins said that it was true that, in refusing to continue the supply of weapons to the RUC, the US was interfering in the internal affairs of another country. The Prime Minister said that she did not agree: this did not constitute interference, since the right to supply arms or to withhold them was sovereign to any Government.

Mr. Atkins told the Prime Minister that he wished to bring Mr. O'Kennedy to accept the view that the IRA was a terrorist organisation, posing as much of a threat to the Irish Republic as to the UK - a leading Provisional, Gerry Adams, had said as much. The Prime Minister said that she did not believe this - there was no evidence of hostility between the Irish Republic on the one hand and the IRA on the other. The only way of changing Dublin's attitude towards the IRA would be to deprive Irishmen in the UK of the vote and to bring them fully within the UK's immigration laws. The fact that both countries were members of the EEC was, however, a complicating factor in exerting pressure on Ireland.

In further discussion, it was agreed that a Press Statement should be put out from No. 10 later in the day to the effect that there was no truth in reports that the Prime Minister intended to visit the US in the context of the Northern Ireland problem; that there was no truth in reports that Mr. Atkins intended to discuss Ulster with Governor Carey; and that the UK assumed that the US, along with other democratic nations, was totally opposed to terrorism and to violence as a means of achieving political ends. It was also agreed that Mr. Atkins should reply later in the day to Governor Carey's letter of 6 August and that the substance of his reply should be released to the Press.

In a discussion of the US decision to withhold export licences for the supply of arms to the RUC, the Prime Minister said that the UK should make her own weapons and be independent of external sources of supply. Mr. Atkins pointed out that this would be very expensive and that it would be a long time before actual deliveries could be made. The Prime Minister asked that the possibility should nevertheless be investigated.

At the end of the discussion, <u>Mr. Atkins</u> told the Prime Minister that he would telephone Mr. O'Kennedy that afternoon in order to forewarn him of the nature of his reply to Governor Carey. In response to a question from Mr. Atkins, <u>the Prime Minister</u> agreed that the reply need not permanently exclude the possibility of a discussion about Northern Ireland with the Governor.



Northern Ireland and Governor Carey

As you know, your Secretary of State called on the Prime Minister this morning in order to discuss the response which should be given to Governor Carey's invitation to him, and to the Irish Foreign Minister, to discuss the problems of Northern Ireland in New York; and how the matter should be handled publicly, in view of the misleading press reports which had appeared. The discussion resulted in action being taken on a number of fronts this afternoon and this evening. This letter is simply to place on record the decisions which were taken.

The Prime Minister made it clear that there could, in her view, be no question of discussing Northern Ireland with Governor Carey in New York. If Governor Carey wished to engage in such discussions, he should come to London. Mr. Atkins agreed, while pointing out that Governor Carey's recent statements about the IRA and terrorism had been helpful to us. He explained that our objectives should be to make the Americans realise the consequences of their words and actions concerning Northern Ireland and to reduce still further the flow of American money and sympathy to the IRA. The Prime Minister agreed that it should be brought hometo the Americans that for so long as they continued to finance terrorism, American lives as well as those of others would be lost, as the Hilton Hotel explosion in Belfast had shown. The Prime Minister expressed the view that the British Government should not always turn the other cheek in the face of US criticism of our policies in Northern Ireland. Mr. Atkins agreed that the US Government's decision to withhold export licences for the supply of arms to the RUC should be vigorously criticised.

The Prime Minister enquired about the possibility of manufacturing the weapons that the RUC needed in the UK, or at least of finding an alternative source of supply. Mr. Atkins explained the practical difficulties which stood in the way of obtaining the particular arms which the RUC needed for their special requirements elsewhere than in the United States. The Prime Minister asked that an alternative possibility should nevertheless be investigated: I should be grateful if you could arrange for this to be done and for a report to be sent to Michael Alexander in due course for the Prime Minister's information.

Mr. Atkins explained that he hoped to bring Mr. O'Kennedy to accept that the IRA posed as much of a threat, in the long term, to the Irish Republic as it did to the UK, as recent statements by Gerry Adams had shown. The Prime Minister expressed some doubts as to whether this was really the case: she could detect no fundamental antagonism between the IRA and the Irish Republic. In further discussion of possible means of bringing pressure to bear on Dublin, it was agreed that although the British Government has in theory some cards in its hand, in relation to the British Nationality Act, there were difficulties about playing them including the fact that Ireland and the UK were both members of the EEC.

It was agreed that Mr. Atkins would despatch his reply to Governor Carey's letter of 6 August later today and that the substance of the reply would be made available to the Press. It was also agreed that the No. 10 Press Office would continue to emphasise that reports of a possible visit by the Prime Minister to the United States in the Northern Ireland context were without foundation; and would confirm that Mr. Atkins had discussed his reply to Governor Carey with the Prime Minister. The possibility of including in a Press Statement a veiled reference to the United States' refusal to supply arms to the RUC was considered but the Prime Minister subsequently accepted Mr. Atkins' view that there was nothing to be gained by raising this issue in the context of his correspondence with Governor Carey. The final form of the press releases from the NIO and from No. 10 has been worked out by our respective Press Offices.

As you know, the Prime Minister approved the draft which you sent across this afternoon of Mr. Atkins' reply to Governor Carey subject to minor amendments which I gave you over the telephone.

I am sending copies of this letter to Stephen Wall (Foreign and Commonwealth Office) and Martin Vile (Cabinet Office).

IN HIS REPLY, THE SECRETARY OF STATE SAID HM GOVERNMENT RECOGNIZED THE DEEP INTEREST OF IRISH PEOPLE WHEREVER THEY MIGHT BE IN THE PROBLEMS OF THE PROVINCE BUT HE REITERATED THAT THE POLITICAL FUTURE OF NORTHERN IRELAND IS A MATTER FOR NEGOTIATION BETWEEN HM GOVERNMENT THE PARLIAMENT AT WESTMINSTER AND THE PEOPLE OF THE PROVINCE. Dear Governor.

Thank you for your letter of 6 August. As I told you when we met in London, the United Kingdom Government welcomes the interest you have shown over the problems of Northern Ireland, in particular your staunch stand against terrorism. It is however clear from the terms of your letter that the meeting which you envisage would be - and could not fail to be - a meeting to discuss and indeed negotiate about the political future of Northern Ireland, a part of the United Kingdom.

I am sure you will understand that it would be wrong for a Minister of Her Majesty's Government to take part in a discussion of that nature in the United States or indeed anywhere else outside the United Kingdom. Her Majesty's Government recognise the deep interest of Irish people wherever they may be in the problems of Northern Ireland. However, as I made clear in the statement I issued on 7 August following your own public statement in New York, the political future of Northern Ireland is a matter for negotiation between Her Majesty's Government, the Parliament at Westminster and the people of the Province.

Thank you for coming to see me - I enjoyed what was for me a valuable discussion when we met in London, and I look forward to seeing you again.

THE SECRETARY OF STATE FOR NORTHERN IRELAND THINKS IT WOULD BE QUITE WRONG TO TAKE UP COVERNOR CAREY'S OFFER, THOUGH THE IRISH WOULD NO DOUBT LIKE HIM TO DO SO: AND HE REALISES THAT IT WOULD SUIT THE IRISH WELL, GIVEN THAT HE WILL NOT AGREE TO THE PROPOSAL, TO BE ABLE TO SAY THAT ONLY OUR NEGATIVE ATTITUDE HAD MADE THE CAREY MEETING IMPOSSIBLE. WE NEED THEREFORE TO PUT TO O'KENNEDY, AS QUICKLY AS POSSIBLE (AND WITHOUT WAITING FOR HIS PROJECTED MEETING WITH THE SECRETARY OF STATE FOR NORTHERN IRELAND) A POSITIVE PROPOSAL WHICH SUITS OUR INTERESTS AND HIS. WE HOPE THAT THIS CAN BE AGREED THROUGH THE DIPLOMATIC CHANNEL, SO THAT O'KENNEDY DOES NOT FEEL INHIBITED FROM MEETING SOSNI ON OTHER MORE SUBSTANTIAL ISSUES. THE REPORT IN CONSUL GENERAL NEW YORK'S TELEGRAM NUMBER 31 IS AN ADDED REASON FOR SPEEDY ACTION.

2. PLEASE ACCORDINGLY SPEAK TO O'KENNEDY ON THE FOLLOWING LINES. MR. ATKINS IS LOOKING FORWARD KEENLY TO HIS NEXT MEETING WITH MR. O'KENNEDY BUT ACCEPTS THAT A REPLY TO GOVERNOR CAREY CANNOT WAIT TILL THEN. HMG WOULD WELCOME AN OPPORTUNITY TO EXPLAIN THE POSITION ABOUT NORTHERN IRELAND ISSUES IN DUE COURSE TO THOSE INTERESTED FROM ALL POINTS OF VIEW IN THE UNITED STATES. THEY CONSIDER, HOWEVER, THAT IT WOULD ONLY BE PRACTICAL AND USEFUL TO DO THIS AFTER THEY HAVE TAKEN A GOOD DEAL FURTHER THEIR DISCUSSIONS OF SUBSTANCE WITH REPRESENTATIVES OF NORTHERN IRELAND OPINION

BOTH IN THE PROVINCE AND AT WESTMINSTER. MOREOVER, THEY WOULD WANT TO OUTLINE DEVELOPMENTS ARISING FROM THOSE TALKS TO THE IRISH GOVERNMENT ITSELF BEFORE SPELLING THEM OUT IN THE UNITED STATES (MR. ATKINS MAY BE ABLE TO SAY MORE WHEN HE SEES MR. O'KENNEDY). BUT SUBJECT TO THOSE STEPS, A VISIT BY SOSN! TO TALK TO INTERESTED PARITES, OFFICAL AND OTHER-WISE, IN WASHINGTON, NEW YORK AND OTHER MAJOR CITIES WOULD BE ATTRACTIVE. SUBJECT TO FURTHER CONSULTATION BETWEEN THE TWO GOVERNMENTS, WE SHOULD SEE MUCH MERIT IN MR. O'KENNEDY PARTICIPATING IN MEETINGS OF THIS KIND, IF HE SO WISHED. ON THE OTHER HAND, IT IS BY NO MEANS CLEAR THAT EITHER OF CUR INTERESTS ARE SERVED BY PLAYING THIS CARD FOR GOVERNOR CAREY'S SHORT TERM POLITICAL BENEFIT, WITH POSSIBLE COMPLICATIONS FOR OUR RELATIONSHIP WITH THE REMAINING 'HORSEMEN' WHO ARE POLITICALLY AND CONGRESSIONALLY OF GREATER SIGNIFICANCE.

3. YOU SHOULD THEREFORE GO ON TO SUGGEST TO O'KENNEDY WITHIN THIS FRAMEWORK, THAT OUR TWO GOVERNMENTS MIGHT RESPECTIVELY REPLY TO GOVERNOR CAREY ON THE LINES THAT WE WARMLY WELCOME HIS INITIATIVE AND INTEREST. CONTINUE TO COMMEND HIS STAUNCH STAND AGAINST TERRORISM, WOULD BE VERY WILLING TO COME TO TALK TO IRISH/AMERICAN INTERESTS TOGETHER ABOUT COMMON PROBLEMS (BUT NOT OF COURSE TO NEGOTIATE A SETTLEMENT, WHICH IS THE PROPER TASK OF THE PEOPLE OF NORTHERN IRELAND THEMSELVES), AND WOULD THINK IT PREFERABLE TO DO THIS A LITTLE LATER ON. WE HOPE THAT IT WOULD THEN BE APPROPRIATE TO ENCOMPASS DISCUSSIONS IN WASHINGTON AND OTHER MAJOR CENTRES AS WELL AS NEW YORK. FOR WHICH PURPOSE WE SHOULD BOTH (REPEAT BOTH) BE IN TOUCH WITH THE UNITED STATES GOVERNMENT AND GOVERNOR CAREY IN THE COURSE OF THE NEXT TWO OR THREE MONTHS (THIS WOULD, FOR YOUR OWN INFORMATION, HELP TO BRING SPEAKER O'NEILL AND THE OTHERS INTO THE ACT). YOU SHOULD MAKE IT PLAIN TO O'KENNEDY THAT, WHILE WE ARE DISCUSSING THE MATTER WITH HIM IN STRICT CONFIDENCE, WE WOULD INTEND TO PUBLISH OUR EVENTUAL RESPONSE TO CAREY AS SOON AS IT WAS DELIVERED,

SINCE

SINCE IT IS EVIDENT THAT THE INITIATIVE ON PUBLICATION IS
BETTER NOT LEFT TO HIM. WE ARE NOT SUGGESTING IDENTICAL
OR INDEED SIMULTANEOUS RESPONSES TO CAREY, SINCE WE
RECOGNISE THAT ANY APPEARANCE OF COLLUSION WOULD PRESENT
DIFFICULTIES FOR THE IRISH. BUT HE WILL, WE HOPE, RECOGNISE
THAT HMG HAVE MADE A VERY POSITIVE MOVE IN ACCEPTING THAT
THE TWO MINISTERS MIGHT TAKE PART IN MEETINGS WITH IRISH/
AMERICAN INTERESTS IN THE USA AND HE WILL UNDERSTAND THAT
MR. ATKINS WILL INCUR THE RISK IF NOT CERTAINTY OF SOME

GOVERNOR CAREY'S INITIATIVE

The Foreign and Commonwealth Secretary will be aware that Governor Carey's formal letter inviting the Secretary of State for Northern Ireland, in company with the Republic of Ireland Minister for Foreign Affairs, Mr O'Kennedy, to visit New York for a meeting with Irish/American interests, was received earlier this month. Governor Carey was told that Mr Atkins would reply to him after consultation with his colleagues. We think that it would be sensible to send a reply fairly soon, before Governor Carey takes some further step to publicise for his own purposes his vision of a Carey-inspired Camp David for Northern Ireland.

Mr Atkins is clear that he should not take up Governor Carey's proposal, but it must be our objective to convey this view in a way which does no damage to our interests in the United States and which attracts the support of the Irish Government: we wish in particular, to avoid giving the Irish Government the easy option of saying that if only Britain had agreed to participate then of course they would willingly have gone along with the idea. We had originally expected that Mr Atkins would try to reach agreement with Mr O'Rennedy on the handling of the Carey initiative when they had their next private meeting, but this will be some little way shead and it is the view, we know, of the Irish Government and of our Secretary of State, that a reply ought to be sent fairly soon. This means consulting the Irish Government about the substance of our response through HM Ambassador, Dublin. I attach a draft telegram to Dublin for this purpose: it reflects discussion earlier today between officials in FCO and NIO

(Fergusson/Stowe), and my Secretary of State's agreement with the course proposed. I should be grateful if, subject to any comments you may have on the wording of the telegram, it could be despatched urgently to HM Ambassador, Dublin.

YOUR TELEGRAMS NOS 197 AND 203: GOVERNOR CAREY'S INVITATION

Our objective is to get alongside Mr O'Kennedy for purposes much wider, of course, than merely to deal with Carey, but we want if we can to reach a common view on the handling of Carey. The Secretary of State for Northern Ireland thinks it would be quite wrong to take up Governor Carey's offer, though the Irish would no doubt like him to do so; and he realises that it would suit the Irish well, given that he will not agree to the proposal, to be able to say that only our negative attitude had made the Carey meeting impossible. We need therefore to put to O'Kennedy, as quickly as possible (and without waiting for his projected meeting with the Secretary of State for Northern Ireland) a positive proposal which suits our interests and his. We hope that this can be agreed through the diplomatic channel, so that O'Kennedy does not feel inhibited from meeting SOSNI on other more substantial issues.

2. Please accordingly talk to O'Kennedy on the following lines. HMG would welcome an opportunity to explain the position about Northern Ireland issues in due course to those interested from all points of view in the United States. Ministers consider that it would only be practical and useful to do this after they have taken a good deal further their discussions of substance with representatives of Northern Freland

opinion both in the Province and at Westminster. Moreover, they would want to outline developments arising from those talks to the Irish Government itself before spelling them out in the United States. But subject to those steps, a visit by SOSNI to talk to interested parties, official and otherwise, in Washington, New York and other major cities would be attractive. Subject to further consultation between the two Governments, we would see much merit in Mr O'Kennedy participating in meetings of this kind, if he so wished.


3. You should go on to suggest to O'Kennedy, within this framework, that our two Governments might respectively reply to Covernor Carey on the lines that we warmly welcome his initiative and interest, continue to commend his staunch stand against terrorism, would be very willing to come to talk to Irish/American interests together about common problems (but not of course to regotiate a settlement, which is the proper task of the people of Northern Ireland themselves), and would think it preferable to do this later on, when it could encompass discussions in Washington and other major centres as well as New York, for which purpose we should both (repeat both) be in touch with the United States Government and Governor Carey in the course of the next two or three months. You should make it plain to O'Kennedy that, while we are discussing the matter with him in diplomatic confidence, we would intend to publish our eventual response to Carey just as soon as it was delivered, since it is evident that the initiative on publication is better not left to him. If necessary you could concede to O'Kennedy that we are not insisting upon identical or indeed simultaneous responses to Carey, since we recognise that any appearance of collusion would

present difficulties for the Irish. But we will, we hope, recognise that HMG have made a very positive move in suggesting that O'Kennedy might join in any meeting of SOSNI with Irish/American interests in the USA and that this is devalued if he were to dissociate himself from our reply.



The text of Governor Carey's statement is annexed. 2. Humphrey Atkins saw Governor Carey in London on Thursday, 2 August, for a talk lasting 1½ hours. He thanked him for his consistent help in condemning terrorism but told him that his recent article in the New York Daily News alleging political neglect of Ulster by the British Government had given great offence here because it was not true. He explained the nature of the political initiative we had taken by way of private consultations with all shades of opinion representing Ulster, both at Westminster and in the Province itself. He told him that political progress could only be achieved with the support of both communities; that each had a veto over what it deemed to be unacceptable; and that therefore anyone peddling Irish unity or simple majority rule was making progress less not more likely. Governor Carey maintained that he was only being listened to in his condemnation of terrorism because he was also known to be working for political progress. This led on to his suggesting that it would be helpful if Humphrey Atkins were to visit New York privately and, at a meeting with leaders of Irish-American opinion which he would arrange there, explain to them as he had explained to him what we were trying to do for the political future of Ulster. Humphrey Atkins said that he would certainly consider this but made it clear that any such visit would have to take its place in the whole range of consultations on which we had embarked, and that in any case he would need to consult his colleagues before agreeing to it. When he suggested that the Secretary of State should join up -1-

with Michael O'Kennedy for this purpose Humphrey Atkins said that he had already been in discussions with Mr O'Kennedy and could certainly see no objection to talking to him again. Governor Carey telephoned Humphrey Atkins on Friday to say that after further consultation (including consultation with Mr O'Kennedy or his office) he would like to follow up his suggestion of a meeting in New York and would write to him about it within a few days. He developed his ideas to the point of saying that he thought it would be helpful if the meeting took place in New York in September and that of course it would be private. In the event Governor Carey for obvious political motives issued his statement without reference either to Dublin or London on Monday, 6 August. We have still not received a formal proposal from him. The US State Department and the other leaders of Irish-American opinion also seem not to have been consulted or warned in advance. UK reporting of Governor Carey's statement, because it conveyed the sense that he was convening a conference to negotiate a settlement, produced a predictable and strong reaction in Ulster: Protestant leaders condemned it outright and even the SDLP were doubtful what to make of it. 7. We have been making it clear to the media in London and Belfast that there is no question of the UK Government agreeing to "negotiate" a political solution to the problems of Ulster at such a meeting. Our briefing has emphasised the points put to Governor Carey in paragraph 2 above and stressed the importance we attach to ensuring that the initiative we have taken in our political discussions is fully understood both in the Republic and in the United States of America. We have also emphasised how necessary it United States of America. We have also emphasised how necessary it is to dispel misunderstandings about the current state of Ulster, the need to combat and defeat terrorism, to restore policing throughout the Province, and to give full support to the legally constituted forces of law and order - which has obvious relevance to the pressures being put on the United States Government over the supply of arms to the Royal Ulster Constabulary. FULL TEXT OF GOVERNOR CAREY'S PRESS STATEMENT

As you know, I have for many years worked for peace and justice in Northern Ireland. In congressional hearings and in meetings with leaders in Belfast, Dublin, Washington and now in London, I have sought the basis for a settlement to bring an end to decades - and even centuries - of strife.

In a recent series of articles in the New York Daily News, Dr Kevin Cahill and myself have tried to point the way to peace, seeking the common ground of conciliation. Today I am pleased to announce that on August 2nd during my visit to London I held extensive and direct discussions with Mr Humphrey Atkins, Secretary of State for Northern Ireland in the Cabinet of Prime Minister Margaret Thatcher. The two following days I held telephone discussions with Michael O'Kennedy, Foreign Minister of the Republic of Ireland, and members of his staff. I have obtained their initial acceptance as individuals to meet with me in New York to continue our work towards peace, security and an end to violence in Northern Ireland.

This invitation will of course require review by the Prime Ministers and Cabinets of their respective governments. Such review is in the normal course and since both individuals have already indicated to me their desire to attend I look forward to a positive response. I am announcing this now in order to begin the necessary preparations.

I shall send a letter of invitation today to both Mr O'Kennedy and Mr Atkins. The location and specific plans for the meeting are not yet firm. The agenda will be determined by the parties themselves, but New York I hope will provide a setting for achieving the elusive peace we all seek. I am pleased to serve as host.

I have discussed this meeting with the Department of State and with my New York colleague, Senator Moynihan. Later today I shall be in contact with Senator Kennedy, Speaker O'Neill and others who have worked with me on this matter.



Statement by Secretary of State for Northern Ireland

- 1. I saw Governor Carey at his request on 2 August, and took the opportunity to explain to him the nature of the initiative which the Government had already begun in Northern Ireland, emphasising the need for private, patient negotiation with the political leaders in Northern Ireland. I stressed that any settlement had to be acceptable to both the majority and minority communities in Ulster.
- 2. This talk was one of many I have had since taking office with concerned parties in Northern Ireland and beyond. I am anxious to listen to any views which may be helpful, and as is known I have talked not only to numerous politicians and others in Ulster but also to Michael O'Kennedy and Garrett Fitzgerald from the Republic and Senator Moynihan from the US.
- 3. After the meeting Governor Carey suggested it might be useful if I were to visit New York for the purpose of a private meeting with his colleagues at which I would explain to them, as I had done to him, the threat to peace and security posed by the current activities of the Provisional IRA, and the urgent necessity of dealing with their terrorist campaign. I said I would certainly consider this, and raised no objection when Governor Carey mooted the possibility of Michael O'Kennedy being present. It was left that the Governor would write to me with a firm proposal which I would consider in consultation with my colleagues in the Government. I now await that letter.

- 4. At no time was there any question of "negotiating" the future of Northern Ireland at such a meeting. The political future of the Province is a matter for negotiation between HM Government, the Parliament at Westminster and the people of Ulster.

- 1. THIS MORNING'S DUBLIN NEWSPAPERS REPORT A CAUTIOUS OFFICIAL REACTION BY THE DFA. A SPOKESMAN IS REPORTED TO HAVE SAID:

 QUOTE THE MINISTER FOR FOREIGN AFFAIRS, MR O'KENNEDY, IS AWARE OF GOVERNOR CAREY'S INVITATION AND THINKS THAT THE MEETING COULD BE OF INTEREST SUBJECT TO THE QUESTIONS WHICH ARISE. WE ASSUME THAT THE DETAILS WILL BE WORKED OUT IN DUE COURSE. DETAILS OF TIME, PLACE AND SUBJECT MATTER OF THE MEETING HAVE YET TO BE WORKED OUT. IT SHOULD BE UNDERSTOOD THAT ANY PROPOSED ARRANGEMENTS ARE SUBJECT TO THE APPROVAL OF THE TAOISEACH AND THE GOVERNMENT AND ALSO SUBJECT TO CONSULTATIONS WITH IRISH-AMERICAN POLITICAL LEADERS AND THE DEVISING OF AN APPROPRIATE FORMULA UNQUOTE.
- 2. THE PAPERS ALSO REPORT AN N.I.O. SPOKESMAN AS SAYING THAT MR ATKINS HAD AGREED TO CONSIDER THE POSSIBILITY OF ATTENDING THE MEETING.
- 3. THE NEWSPAPERS THEMSELVES ARE MUCH LESS RESTRAINED. A FRONT PAGE ARTICLE BY THE IRISH TIMES' POLITICAL CORRESPONDENT HEADED QUOTE INITIATIVE ON NORTHERN IRELAND TALKS WELCOMED IN DUBLIN UNQUOTE, STATES THAT GOVERNOR CAREY'S INITIATIVE WAS RECEIVED IN DUBLIN WITH QUIET SATISFACTION AND SUGGESTS THAT THE GOVERNMENT HAS BEEN TRYING FOR SOME TIME TO GAIN ACCEPTANCE FOR THE VIEW THAT A BRITISH INITIATIVE WAS ESSENTIAL. QUOTE HERE TOO DUBLIN APPEARS TO HAVE SUCCEEDED SLOWLY UNQUOTE. THE IRISH PRESS IN A LENGTHY EDITORIAL ALSO TAKES UP THE THEORY ZIMBABWE RHODESIA AND SUGGESTS THAT A WEEK OF TALKS ON NORTHERN IRELAND MIGHT CHANGE MRS THATCHER'S VIEW ON THAT PROBLEM AS DRAMATICALLY AS A WEEK OF TALKS IN LUSAKA HAD CHANGED HER VIEWS ON ZIMBABWE RHODESIA. QUOTE IT IS NOW CLEAR THAT AFTER THE STALEMATE OF THE MASON YEARS THE NORTHERN LOGJAM IS AT LAST BEGINNING TO MOVE AND MOVE AT A FAIRLY SHARPISH PACE. IT WAS A TORY GOVERNMENT THAT LAST OFFERED THIS ISLAND THE PROSPECT OF A NEW START WITH SUNNINGDALE, AN EXPERIMENT THAT FAILED LARGELY THROUGH THE POLITICAL COWARDICE OF MR WILSON'S LABOUR CABINET. THE INITIATIVES BEING LAUNCHED FROM AMERICA NOW OFFER ANOTHER TORY ADMINISTRATION THE OPPORTUNITY TO STAUNCH THE YEARS OF BLOODSHED AND ATTEMPT A POLITICAL SETTLEMENT UNQUOTE.

NORTHERN IRELAND: GOVERNOR CAREY'S STATEMENT BEGIN

- 1. WE HAVE TELEGRAPHED TO YOU SEPARATELY THE TEXT OF A STATEMENT WHICH THE SECRETARY OF STATE FOR NORTHERN IRELAND ISSUED THIS AFTERNOON TO MAKE PLAIN HIS OWN POSITION FOLLOWING YESTERDAY'S ANNOUNCEMENT BY GOVERNOR CAREY OF A POSSIBLE MEETING IN NEW YORK. YOU MAY DRAW ON THIS FREELY.
- 2. WHEN THE GOVERNOR RAISED THE QUESTION OF A VISIT TO NEW YORK AT HIS MEETING WITH MR ATKINS ON 2 AUGUST, IT WAS REPRESENTED AS A PRIVATE OCCASION WHICH WOULD GIVE THE SECRETARY OF STATE THE OPPORTUNITY OF EXPLAINING TO OTHER AMERICAN POLITICIANS WHAT HE WAS TRYING TO DO IN NORTHERN IRELAND. MR CAREY IN A SUBSEQUENT TELEPHONE CONVERSATION PARTICULARLY URGED MR ATKINS TO EXPLAIN TO HIS US COLLEAGUES, AS HE HAD DONE TO MR CAREY HIM-SELF, THE THREAT TO PEACE POSED BY THE PIRA AND THE URGENT NEED TO DEAL WITH THE TERRORISTS. ON THIS BASIS MY ATKINS INDICATED THAT HE WOULD CERTAINLY CONSIDER SUCH A POSSIBILITY, BUT THAT IT WOULD NEED TO BE CONSIDERED IN THE CONTEXT OF THE OTHER TALKS IN WHICH HE WAS ALREADY ENGAGED AND HE WOULD OF COURSE NEED TO CONSULT HIS COLLEAGUES. GOVERNOR CAREY RAISED THE IDEA OF MR O'KENNEDY ALSO ATTENDING, AND MR ATKINS SAID THAT THE TWO OF THEM HAD OF COURSE ALREADY HAD DISCUSSIONS, BUT HE SAW NO OBJECTION TO THEIR MEETING AGAIN. THE GOVERNOR TELEPHONED MR ATKINS THE FOLLOWING DAY (APPARENTLY AFTER CONSULTING MR O'KENNEDY OR HIS OFFICE) AND IT WAS LEFT THAT THE GOVERNOR WOULD WRITE QUOTE WITHIN A FEW DAYS UNQUOTE. HIS LETTER IS STILL AWAITED.

- ABOVE ACCOUNT OF THE EVENTS WHICH HAVE LED TO THE PRESENT

 SITUATION. GOVERNOR CAREY DID NOT GIVE LONDON ANY ADVANCE WARNING
 OF HIS ANNOUNCEMENT YESTERDAY, WHICH WAS NO DOUBT DESIGNED TO SERVE
 HIS OWN POLITICAL ENDS. CLEARLY IT CALLS IN QUESTION HIS FOLLOWING
 TWO WORDS UNDERLINED BONA FIDES. AND WILL MEAN THAT WHEN THE FORMAL
 INVITATION ARRIVES IT WILL BE CONSIDERED VERY CAREFULLY BEFORE
 ANY REPLY IS SENT. THE SECRETARY OF STATE WILL CERTAINLY
 FIRST WISH TO DISCUSS IT WITH THE FOREIGN SECRETARY, WHICH MEANS
 A REPLY IS UNLIKELY TO GO BEFORE THE END OF THE MONTH, AND THEN
 CONSULT THE PRIME MINISTER WHO IS BEING KEPT FULLY INFORMED.
- 4. FOR YOUR OWN INFORMATION YOU SHOULD KNOW THAT MR ATKINS HAS BEEN AND STILL IS CONTEMPLATING A POSSIBLE VISIT TO THE US QUITE APART FROM GOVERNOR CAREY'S INITIATIVE. THE PURPOSE OF THIS WOULD BE TO CARRY SERIOUS IRISH/AMERICAN OPINION WITH HIM IN HIS SEARCH FOR AN ACCEPTABLE FORM OF GOVERNMENT FOR NORTHERN IRELAND: AND ALTHOUGH THE TIMING OF IT IS STILL WIDE OPEN IT SEEMS UNLIKELY THAT SUCH A TRIP WOULD BE APPROPRIATE UNTIL HIS TALKS WITH NI POLITICIANS HAD REACHED A POINT AT WHICH HE HAD GONE PUBLIC ON SOME SPECIFIC PROPOSALS FOR CONSTITUTIONAL ADVANCE, WHICH CAN HARDLY BE BEFORE OCTOBER.

THE TEXT IS AS FOLLOWS:QUOTE DEAR MR ATKINS:

THANK YOU FOR THE TIME AND CONSIDERATION YOU EXTENDED TO ME DURING MY RECENT TRIP TO LONDON. NOW, PURSUANT TO OUR DISCUSSIONS, I OFFICIALLY EXTEND TO YOU MY INVITATION TO VISIT NEW YORK IN THE VERY NEAR FUTURE, AND MEET WITH MR. MICHAEL O'KENNEDY, MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF IRELAND.

NEW YORK, THE HOME OF THE UNITED NATIONS AND THE SITE OF INNUMERABLE INTERNATIONAL CONFERENCES, IS SUPERBLY SUITED TO HOST THIS MEETING AND, AS GOVERNOR, I WILL MAKE CERTAIN OF ARRANGEMENTS TO ENSURE AN ATMOSPHERE OF COMFORT, SECURITY AND PRIVACY, I WILL CONSULT WITH YOU BY PHONE CONCERNING THESE PLANS AND ANY SUGGESTIONS YOU MIGHT CARE TO MAKE.

QUESTIONS OF AGENDA AND ISSUES FOR DISCUSSION WILL BE DETERMINED, OF COURSE, BY YOURSELF AND MR. O'KENNEDY. HOWEVER, THE VERY FACT OF YOUR MEETING WILL BE A LONG AWAITED SIGN OF ENCOURAGE-MENT TO THOSE WHO HAVE SOUGHT AN EQUITABLE SOLUTION THAT RESPECTS THE RIGHTS OF ALL THE PEOPLE OF NORTHERN IRELAND.

I REALIZE YOU ARE CURRENTLY ON VACATION, AND YOUR ACCEPTANCE OF THIS INVITATION DEPENDS ON THE APPROVAL OF THE PRIME MINISTER AND CABINET, BUT THE EXEGENCIES OF PREPARING FOR SUCH A MEETING REQUIRE THAT I ASK YOU TO RESPOND AT YOUR EARLIEST POSSIBLE CONVENIENCE.

I HAVE INSTRUCTED MR PETER QUINN, ONE OF MY SPECIAL ASSISTANNTS WITH A BACKGROUND IN THIS AREA, TO WORK WITH YOUR OFFICE AND WITH MR. O'KENNEDY'S IN ORDER TO ARRIVE AT ARRANGEMENTS SUITABLE TO ALL CONCERNED. I LOOK FORWARD TO RETURNING YOUR HOSPITALITY. SINCERELY, HUGH L CAREY UNQUOTE. I HAVE SINCE LEARNED THAT NIMETZ, STATE DEPARTMENT COUNSELLOR, WHOSE POLITICS AND LEGAL PRACTICE HAVE BEEN IN NEW YORK, HAS BEEN IN CLOSE TOUCH WITH CAREY RECENTLY, AND MAY HAVE BEEN PRIVY TO CAREY'S INTENTIONS IN SUGGESTING THIS MEETING. (I REPORTED IN MY LETTER OF 26 JUNE TO CUBBON NIMETZ'S SUGGESTION THAT THE SECRETARY OF STATE FOR NORTHERN IRELAND MIGHT WISH TO VISIT THE US FOR A QUIET MEETING WITH SOME OF THOSE PRINCIPALLY INTERESTED IN THE IRISH QUESTION IN US POLITICS.)
- 2. I DO NOT BELIEVE THIS NEED INFLUENCE OUR ATTITUDE TO CAREY'S INITIATIVE, PARTICULARLY SINCE CAREY'S PUBLICATION OF HIS INITIATIVE AND THE FACT THAT HE APPARENTLY DID NOT ACT IN CONCERT WITH O'NEILL AND KENNEDY. INDEED GOVERNOR CAREY MAY BE THE LEAST IMPORTANT OF THE FOUR, THE MOST IMPORTANT BEING O'NEILL AND KENNEDY. IF MR ATKINS WERE TO DECIDE TO VISIT THE US FOR THE SORT OF EXCHANGES WHICH NIMETZ ORIGINALLY HAD IN MIND I THINK HE SHOULD AIM TO MEET O'NEILL AND KENNEDY IN THE FIRST PLACE. THIS IS NOT TO SAY THAT CAREY'S INITIATIVE MIGHT NOT BE ADAPTED FOR THIS PURPOSE, DEPENDING ON MR ATKINS' SUBSEQUENT TELEPHONE CONVERSATION WITH CAREY AND KENNEDY'S OWN REACTION TO CAREY'S INITIATIVE.

- Q CAN YOU COMMENT ON REPORTS THAT GOV CAREY OF NY HAS INVITED IRISH FOREIGN MINISTER O'KENNEDY AND BRITISH SECRETARY OF STATE FOR NORTHERN IRELAND HUMPHREY ATKINS?

 GOV CAREY HAS INFORMED THE DEPARTMENT THAT HE HAS EXTENDED SUCH INVITATION FOLLOWING HIS RECENT CONVERSATIONS WITH SECRETARY ATKINS AND FOREIGN MINISTER O'KENNEDY.
- Q DOES THE DEPARTMENT HAVE ANY VIEW ON THE APPROPRIATENESS OF SUCH A MEETING?

1. THE FOLLOWING IS TEXT OF LETTER FROM THE RT. HON. HUMPHREY ATKINS MP, SECRETARY OF STATE FOR NORTHERN IRELAND, TO THE HONOURABLE MICHAEL O'KENNEDY TD, MINISTER OF FOREIGN AFFAIRS, DATED 30 JULY BEGINS:

WE HAD A WORD ON THE TELEPHONE EARLIER TODAY, AND I EXPLAINED TO YOU MY GROWING CONCERN THAT, AS A RESULT OF A SERIES OF INCIDENTS, THE GOOD RELATIONS WHICH I BELIEVE WE ESTABLISHED WHEN I MET YOU AND GERRY COLLINS IN DUBLIN LAST MONTH APPEAR NOW TO BE CALLED IN QUESTION.

IT IS NOT MY PURPOSE IN THIS NOTE TO SAY ANYTHING ABOUT THE LATEST INCIDENTS WHICH YOU RAISED WITH ROBIN HAYDON ON THURSDAY-THE TRUTH OF WHICH I SHALL, OF COURSE, GET OFFICIALS TO INVEST-IGATE - OR TO ARGUE WHAT I KNOW IS TRUE - THAT THERE IS CERTAINLY NO MALICE OR ILL-WILL ON THE PART OF HM GOVERNMENT BEHIND THEM. ALL I WANT TO DO IS TO SAY THAT I THINK IT WOULD BE HELPFUL IF WE COULD HAVE A FAIRLY EARLY MEETING SO THAT WE MAY, IN THE WORDS OF YOUR LETTER OF 18 JULY, QUOTE THRASH THESE PROBLEMS OUT UNQUOTE -BECAUSE I KNOW WE CAN APPROACH THE DIFFICULTIES IN A SPIRIT OF GOODWILL. I HAD THE IMPRESSION FROM OUR TELEPHONE CONVERSATION THAT YOU WOULD ALSO FIND IT HELPFUL TO HAVE AN EARLY MEETING. I SUGGESTED THAT WE MEET QUITE PRIVATELY, WITHOUT OUR MEETING BECOMING PUBLIC, AND YOU AGREED THAT THE MORE THAT COULD BE DONE TO DAMP DOWN MEDIA SPECULATION, THE BETTER. I GO ON HOLIDAY FOR A FORTNIGHT AT THE END OF THIS WEEK. SUBJECT TO THAT, I SHALL DO MY BEST TO FIT IN WITH YOUR OWN MORE DEMANDING PROGRAMME. NO DOUBT THE DETAILS CAN BE FIXED THROUGH THE DUBLIN EMBASSY.

M 1 F T CONTAINS TEXT OF LETTER DATED 30 JULY FROM MR ATKINS TO MR O'KENNEDY. PLEASE ARRANGE FOR ITS EARLY DELIVERY TO MR O'KENNEDY, EXPLAINING THAT SIGNED ORIGINAL WILL FOLLOW VERY SOON. 3. WHEN DELIVERING ADVANCE TEXT PLEASE SEEK D F A'S VIEWS ON TIMING AND ARRANGEMENT FOR A FURTHER MEETING BETWEEN MR ATKINS AND AR O'KENNEDY. SECRETARY OF STATE FOR MORTHERN IRELAND WOULD LIKE THIS TO TAKE PLACE AS SOON AS POSSIBLE AFTER HIS HOLIDAY, THAT IS TO SAY ON OR AFTER TUESDAY, 28 AUGUST.




