Dear Clive,

We discussed over the weekend my Secretary of State's suggestion that the Prime Minister should make a statement at about the time of the Pope's departure for the United States later today.

This statement would be intended formally (and after due consideration of what the Pope has said in Ireland) to put on record the British Government's response. You will be aware that my Secretary of State deliberately refrained from any comments over the weekend until we could be sure of what the Pope had said.

I attach a draft text of the statement. I have discussed it in general terms with the Foreign Office but they have not so far seen the actual text. My Secretary of State is content with it as it stands and obviously I should like to hear from the Foreign Office if they have any comments on it. If they confirm that they have none, the way is clear for you to make whatever use of it you wish.

One final point: the Prime Minister may want to consider whether this message should take the form of a statement by her on behalf of Her Majesty's Government (which is now it is now drafted) or whether it should take the form of an open message to the Pope, in which case it could begin "Your Holiness's clear and profound message".

- 1. MR GERRY FITT, MP FOR W BELFAST, SDLP CALLED UPON THE LPS YESTERDAY, 26 SEPTEMBER.
- 2. MR FITT EXPRESSED HIS CONCERN AT RECENT REPORTS IN THE PRESS SUGGESTING THAT THE POPE MIGHT REFER TO 'H' BLOCKS DURING HIS FORTHCOMING VISIT TO IRELAND. HE SAID THAT IF THERE WERE ANY TRUTH IN THESE REPORTS, ANY SUCH REFERENCES COULD DO IRREPARABLE HARM IN THE DELICATE NORTHERN IRELAND SITUATION. HE THOUGHT THAT CARDINAL O'FIAIGH WHO CAME FROM CROSSMAGLEN IN THE BORDER AREA, DID NOT REALLY UNDERSTAND THE SITUATION IN BELFAST, AND EARLIER REMARKS MADE BY THE CARDINAL HAD BEEN MOST UNFORTUNATE.
- 3. MR FITT SAID HE THOUGHT IT WOULD BE HELPFUL IF HE WERE TO SEND A PRIVAT AND PERSONAL MESSAGE TO THE VATICAN THROUGH FCO CHANNELS. THE LPS AGREED THAT SUCH A MESSAGE SHOULD BE RELAYED THROUGH THE FCO AND THAT THE SENDING OF THE MESSAGE SHOULD REMAIN CONFIDENTIAL.
- 4. PLEASE ARRANGE FOR MESSAGE IN MIFT TO BE CONVEYED TO VATICAN
 IMMEDIATELY AT APPROPRIATE LEVEL. IN HANDING OVER MESSAGE YOU
 SHOULD MAKE CLEAR THAT MESSAGE IS BEING SENT ENTIRELY AT MR FITT'S
 INITIATIVE AND THAT HE IS WELL PLACED TO COMMENT ON THIS ISSUE.

1. TICKELL (MR JENKINS' CHEF DE CABINET) HAS GIVEN AN ACCOUNT OF MR JENKINS' CONVERSATION WITH THE POPE, AT WHICH NO ONE ELSE WAS PRESENT.

2. THE CONVERSATION WAS NOT WHOLLY SATISFACTORY IN THAT IT WAS CONDUCTED IN A MIXTURE OF ENGLISH AND FRENCH, MR JENKINS NOTED THAT THE POPE WAS NOT ENTIRELY AT EASE IN EITHER LANGUAGE. MOREOVER THE POPE APPEARED NOT YET TO HAVE STUDIED THE NORTHERN IRELAND PROBLEM IN DETAIL AND WAS DISMAYED THAT EVENTS PREVENTED HIS VISITING ARMAGH. HE WAS CLEARLY DISAPPOINTED THAT THIS WOULD MAKE IT IMPOSSIBLE TO ACHIEVE HIS OBJECTIVE OF PROMOTING A SPIRIT OF RECONCILIATION.

3. THE POPE SAID THAT THERE WERE UNDOUBTEDLY QUOTE PEOPLE BEHIND UNQUOTE SUCH TERRORIST ORGANISATIONS AS THE IRA. HE EXPRESSED UNQUALIFIED CONDEMNATION OF THE ACTIVITIES AND METHODS OF TERRORISTS. HE AGREED THAT MR JENKNIS' ASSESSMENT THAT IN THE REPUBLIC THE GREAT MAJORITY WERE AGAINST VIOLENCE BUT THAT THERE WAS A MINORITY WHICH GAVE PASSIVE SUPPORT TO IT.

4. THE POPE AGREED WITH MR JENKINS THAT THE FACT THAT BOTH PARTS OF IRELAND BELONGED TO THE COMMUNITY GAVE GROUNDS FOR HOPE.



Thank you for your letter of 28 August looking forward to the Pope's visit to Ireland and suggesting that the time had come for church leaders to join in a condemnation of violence and to lead the people of Northern Ireland in prayers for peace and reconciliation.

When you wrote there was still speculation that the Pope might visit Northern Ireland; but you will know that this has now been ruled out by the Vatican because of what they described as the recent "dreadful murders". Although the Papal visit is, as I understand it, intended to be a purely pastoral one, I think that it is in practice most unlikely that His Holiness will wish to stay silent about the problem of 'political violence' in Ireland. Indeed in statements issued by the Vatican, or which have appeared in the Vatican newspaper, he has already condemned the violence and spoken of his desire to see reconciliation and peace. Other Church leaders from all the main Christian traditions (and including the Archbishop of Canterbury who you specifically mentioned in your letter) have spoken on similar lines.

But, as you suggest, the Pope's visit to Ireland at the end of this month will provide a unique opportunity for Christian leaders, wherever they are, to speak out against hatred and

/violence.

violence. To use the words of the Irish Hierarchy's pastoral letter issued on 2 September there will be an opportunity then for them "to speak to the hearts and consciences of all those engaged in campaigns of violence and bring them back to awareness of the horrible evil of murder and to the sense of the absolute sacredness of human life". I believe that it would be wholly in character for the Pope to use this opportunity and, like you, I hope very much that he will do so.

MR ROY JENKINS'S AUDIENCE WITH THE POPE: TUESDAY 11 SEPTEMBER

1. I UNDERSTAND THAT MR JENKINS HAS ENQUIRED INFORMALLY WHETHER
THERE ARE ANY POINTS WHICH IT WOULD BE HELPFUL FOR HIM TO MAKE
TO THE POPE.

- 2. MR JENKINS HIMSELF WILL OF COURSE BE CONCERNED NOT TO CONVEY THE IMPRESSION THAT ANYTHING HE SAYS ABOUT NORTHERN IRELAND IS, ON BEHALF OF HMG. ON THE OTHER HAND, I AM SURE THAT THE POPE WOULD ATTACH WEIGHT TO ANYTHING MR JENKINS MAY SAY IN A PERSONAL CAPACITY, GIVEN HIS LONG EXPERIENCE IN GOVERNMENT, AND I AM GRATEFUL TO HIM FOR GIVING US A CHANCE TO LET HIM HAVE SOME THOUGHTS.
- 3. MR JENKINS MAY LIKE TO KNOW, FOR HIS BACKGROUND INFORMATION, THAT SHORTLY AFTER THE ANNOUNCEMENT OF THE POPE'S FORTHCOMING VISIT TO IRELAND WE TOLD THE VATICAN THAT SHOULD HE WISH TO VISIT THE UNITED KINGDOM (REPEAT UNITED KINGDOM) HE WOULD BE MADE VERY WELCOME: BUT THAT IF THERE WERE ANY QUESTION OF HIS WISHING TO CROSS THE BORDER INTO NORTHERN IRELAND, WE WOULD NATURALLY EXPECT TO BE FULLY CONSULTED. AT THE TIME THE VATICAN WERE QUITE CLEAR, AND SAID SO PUBLICLY, THAT NORTHERN IRELAND WAS NOT INCLUDED IN THE POPE'S ITINERARY. SUBSEQUENTLY HOWEVER THERE WAS PRESSURE ON THE VATICAN BOTH FROM THE IRISH CATHOLIC HIERARCHY, AND INDEED FROM THE CHURCH OF IRELAND, TO REVERSE THIS DECISION. BUT THE MATTER WAS SETTLED BY THE TRAGIC EVENTS OF 27 AUGUST. MR JENKINS MIGHT SAY THAT HE IS SURE THAT IN PRESENT CIRCUMSTANCES THE POPE'S DECISION NOT TO VISIT THE NORTH WAS A WISE ONE.
- 4. THE POPE WILL UNDOUBTEDLY BE AWARE THAT ANYTHING HE SAYS PUBLICLY ABOUT THE IRISH QUESTION DURING HIS FORTHCOMING VISIT TO IRELAND WILL ATTRACT ENORMOUS INTEREST IN BOTH PARTS OF IRELAND, IN BRITAIN AND IN THE UNITED STATES. WHILE NO-ONE DISPUTES THE RIGHT OF PEOPLE IN THE REPUBLIC OR IN NORTHERN IRELAND TO SUPPORT THE ASPIRATION TO IRISH UNITY, IF THE POPE WERE TO SAY ANYTHING PUBLICLY WHICH COULD BE INTERPRETED AS SUPPORT FOR IRISH UNITY, THE PROTESTANT COMMUNITY IN NORTHERN IRELAND WOULD UNDOUBTEDLY FEEL THAT THEY WERE BEING UNFAIRLY

/THREATENED

THREATENED. AND AT THIS TIME OF HEIGHTENED INTERCOMMUNAL TENSION, THERE WOULD BE A DINGER OF PROTESTANT EXTREMISTS USING THE POPE'S WORDS AS A PRETEXT FOR ANTI-CATHOLIC VIOLENCE. WE WOULD HOPE THEREFORE THAT THE POPE WILL USE HIS VISIT TO CALL FOR RECONCILIATION BETWEEN THE TWO COMMUNITIES.

5. AS MR JENKINS WILL KNOW, THE POPE HAS BEEN FORTHRIGHT IN CONDEMNING THE MURDER OF LORD MOUNTBATTEN AND OF THE SOLDIERS AT WARRENPOINT. IT WOULD HAVE A PROFOUND EFFECT, NOT ONLY IN IRELAND BUT ALSO IN THE UNITED STATES, IF HE WERE ABLE TO SPEAK OUT NOT ONLY AGAINST TERRORISTS BUT ALSO AGAINST THOSE WHO HELP, ASSIST, COMFORT AND SUPPORT THEM, WHETHER ACTIVELY OR PASSIVELY. BETTER STILL, THOUGH IT MAY BE TOO MUCH TO HOPE FOR THAT THE POPE WOULD BE READY TO GO SO FAR, WOULD BE A CONDEMNATION OF TERRORIST ORGANISATIONS BY NAME, BOTH QUOTE REPUBLICAN UNQUOTE AND QUOTE LOYALIST UNQUOTE. SUCH CONDEMNATION WOULD I AM SURE BE WELCOMED BY THE IRISH GOVERNMENT, BY THE SDLP AND BY THE MORE MODERATE LEADERS OF THE IRISH AMERICAN COMMUNITY.

MR. ROY JENKINS' MEETING WITH THE POPE: 12 SEPTEMBER 1979

You wrote to me on 7 September enclosing the text of a draft telegram to Sir Donald Maitland about the audience which the President of the European Commission is to have on Wednesday with the Pope.

The Prime Minister has seen the text and is content that the telegram should be despatched. However, she has commented that she thinks it is expecting a great deal of the Pope to ask him to condemn terrorist organisations - both Republican and Loyalist - by name.



Mr Jenkins may like to know, for his background information, that shortly after the announcement of the Pope's forthcoming visit to Ireland we told the Vatican that should he wish to visit the United Kingdom (repeat United Kingdom) he would be made very welcome; but that if there were any question of his wishing to cross the border into Northern Ireland, we would naturally expect to be fully consulted. At the time the Vatican were quite clear, and said so publicly, that Northern Ireland was not included in the Pope's itinerary. Subsequently however there was pressure on the Vatican both from the Irish Catholic hierarchy, and indeed from the Church of Ireland, to reverse this decision. But the matter was settled by the tragic events of 27 August. Mr Jenkins might say that he is sure that in present circumstances the Pope's decision not to visit the North was a wise one.
- 4. The Pope will undoubtedly be aware that anything he says publicly about the Irish question during his forthcoming visit to Ireland will attract enormous interest in both parts of Ireland, in Britain and in the United States.

While no-one disputes the right of people in the Republic or in Northern Ireland to support the aspiration to Irish unity, if the Pope were to say anything publicly which could be interpreted as support for Irish unity, the Protestant community in Northern Ireland would undoubtedly feel that they were being unfairly threatened. And at this time of heightened intercommunal tension, there would be a danger of Protestant extremists using the Pope's words as a pretext for anti-Catholic violence. We would hope therefore that the Pope will use his visit to call for reconciliation between the two communities.

forthright in condemning the murder of Lord Mountbatten and of the soldiers at Warrenpoint. It would have a profound effect, not only in Ireland but also in the United States, if he were able to speak out not only against terrorists but also against those who help, assist, comfort and support them, whether actively or passively. Better still, if the Pope felt able to go so far, would be a condemnation of terrorist organisations by name, both "Republican" and "Loyalist". Such condemnation would I am sure be welcomed by the Irish Government, by the SDLP and by the more moderate leaders of the Irish American community.

The FCO have just learnt from Rome that the Vatican will be announcing at 5.00 p.m. this afternoon, local time, that the Pope will not be visiting Northern Ireland in the course of his forthcoming visit to the Irish Republic.

The announcement will, I understand, take the following line. Initially a visit to Northern Ireland had not been envisaged by the Pope. However, in response to requests from both Catholic and Protestant groups, a decision in principle was taken to incorporate Armagh in the Pope's itinerary. However, the Pope has now decided, with deep regret, that due to the dreadful murders of recent days, it would not be right to include a venue in Northern Ireland in his itinerary.

THE POPE'S VISIT TO IRELAND

The Foreign and Commonwealth Office have informed us that our Minister (Mr Crossley) at the Vatican has reported (Holy See Telegram No 23) that strong pressures seemed to be building up for the Pope to visit the North and that in the light of the pressures Cardinal O'Fiaich had been invited to Rome on Monday 27 August to discuss them. The Vatican Foreign Minister had indicated that they might thereafter contact the British Government with a specific proposal about a visit to Northern Ireland.

After consultation with the FCO and with the approval of my Secretary of State, Mr Crossley has been instructed first to repeat to the Vatican the line (already approved by the Prime Minister) to the effect that HM Government wishes the Pope to understand that if he wishes to make a visit to the UK he would be warmly welcomed and that the Government would do all in its power to make such a visit a success; but that if the Pope did envisage crossing the border HM Government would welcome the opportunity of considering a request to do so informally, so that they could consider and advise the Pope about all aspects of such a visit in terms of its effect upon the two communities in Northern Ireland and their security. He will go on to say that it would not be possible to indicate in advance what HM Government's reaction might be to a specific proposal for a visit by the Pope to Northern Ireland. This would require consideration at the highest level in the light of the specific terms of a Vatican request. He will indicate that our problems would not be confined simply to ensuring protection for the Pope. It would also be necessary to consider the protection of individual citizens. Depending

on what exactly was proposed, a visit could easily spark off inter-communal violence in Northern Ireland in which innocent individuals could suffer tragically. There would be plenty of time between now and the visit for plans to be laid to disrupt it. The consequence could be damage to the very aims which the Pope had in mind in thinking about making the visit. He will urge that the Vatican should, therefore, consult HM Government fully, and at the earliest opportunity, and in any case before any public statement (however unofficial) is made.

We have been concerned about possible leaks on all this over the holiday week-end. In any case, the visit of Cardinal O'Fiaich to Rome may of itself produce press enquiries about the possibility of a visit by the Pope to Northern Ireland, irrespective of the conclusion which the Vatican itself reaches. Press Offices in London and Belfast have, therefore, been instructed to respond by repeating the substance of the statement made earlier by Prime Minister to Mr Fitt, but in the terms in which Mr Crossley has already spoken to the Vatican (see above). They would go on to say that no approach has yet been made and that if and when it is made Ministers will carefully consider it in all its aspects. They are instructed not to be drawn beyond this.

We cannot take this further at present, but you will wish to know that we have reported to my Secretary of State some preliminary views about our response should an approach from the Vatican be received. We would then know more clearly what is envisaged. At one extreme, if all that the Vatican had in mind was a symbolic gesture, e.g. a quick inand-out helicopter visit to pray at the grave of Cardinal Conway for peace and reconciliation (an idea that has recently been floated in more than one quarter), then there might be, comparatively, few problems. The present and provisional view of the security forces is that such a visit might provoke a disturbance somewhere (not necessarily in Armagh) but that it would present no insurmountable security problems, although they would obviously want to consider the specific proposal very carefully. If on the other hand the Pope was contemplating an open visit, allowing himself to be seen by (and to bless) thousands of people - perhaps from the steps of Armagh Cathedral - that would present security problems so severe that it might be necessary for us to tell the Vatican that a visit in these terms could not be contemplated at all. The risks if a spectacular visit of this type were contemplated would certainly go much wider than the Pope's own safety.

Intercommunal violence would be a much stronger possibility and one tragic incident could have an incalculable effect on hopes for both peace and political progress. The fact that an "open" visit could have such serious implications in both security and political terms underlines the need for the earliest possible indication of the Vatican's intentions and this is what the Minister in Rome will be trying urgently to obtain.

1. THIS IS TO CONFIRM TELEPHONIC INSTRUCTIONS TO MAKE FURTHER CONTACT WITH MGR SILVESTRINI. YOU SHOULD REPEAT THE GENERAL WELCOME FOR A VISIT BY THE POPE TO THE UNITED KINGDOM ON THE LINES OF THE LAST TWO PARAGRAPHS OF THE AIDE MEMOIRE ENCLOSED WITH YOUR LETTER OF 27 JULY TO NEW INGTON. YOU SHOULD GO ON TO SAY THAT IT IS NOT POSSIBLE FOR YOU TO GIVE ANY INDICATION IN ADVANCE OF HMG'S LIK-ELY REACTION TO A SUGGESTION OF A VISIT TO NORTHERN IRELAND. WHICH, AS THE VATICAN WOULD WELL UNDERSTAND, WILL REQUIRE VERY CAREFUL CONSIDERATION AT THE HIGHEST LEVELS IN LONDON IN THE LIGHT OF THE SPECIFIC TERMS OF THE VATICAN'S CONSULTATION WITH US. IN THAT CONTEXT, YOU ARE SURE THAT YOU NEED NOT SPELL OUT THE POTENTIAL MEPACT ON THE TWO COMMUNITIES IN NORTHERN IRELAND. IN ADDITION TO THE QUESTION OF INTERCOMMUNAL RELATIONS, THERE IS THE PROBLEM OF PROTECTION, WHICH IS NOT JUST THAT OF PROTECTING THE PERSON OF THE POPE BUT OF PROTECTING INDIVIDUAL CITIZENS IF THE POPE'S VISIT WERE TO GIVE RISE TO INTERCOMMUNAL VIOLENCE ANYWHERE IN THE WORTH. (FOR INSTANCE, - FOR USE AT YOUR DISCRETION - IT WOULD NOT BE HARD TO CONCEIVE OF A TERRORIST INCIDENT INVOLVING COACHLOADS OF CHILDREN TRAVELLING TO WITNESS THE POPE'S VISIT). THE PROBLEM IS COMPOUNDED BY THE PERIOD OF TIME BETWEEN NOW AND THE POPE'S VISIT, IN WHICH ANYONE WHO WANTED TO EXPLOIT THE SITUATION FOR MALIGN PURPOSES COULD CARRY OUT DETAILED PLANNING. IT IS ONLY HMG THAT HAS THE COMPETENCE TO ASSESS AND MAKE A JUDGEMENT ABOUT ALL THESE KIND OF ISSUES. FURTHERMORE, IF A SERIOUS INCIDENT WERE TO OCCUR, IT WOULD DE MOST DAMAGING TO THE VERY AIMS WHICH THE POPE'S VISIT WAS) INTENDED TO SECURE.

THE POPE'S VISIT TO IRELAND

The Foreign and Commonwealth Office have informed us that cur Minister (Mr Crossley) at the Vatican has reported (Holy See Telegram No 23) that strong pressures seemed to be building up for the Pope to visit the North and that in the light of the pressures Cardinal O'Fiaich had been invited to Rome on Monday 27 August to discuss them. The Vatican Foreign Minister had indicated that they might thereafter contact the British Government with a specific proposal about a visit to Northern Ireland.

After consultation with the FCO and with the approval of my Secretary of State, Mr Crossley has been instructed first to repeat to the Vatican the line (already approved by the Prime Minister) to the effect that HM Government wishes the Pope to understand that if he wishes to make a visit to the UK he would be warmly welcomed and that the Government would do all in its power to make such a visit a success; but that if the Pope did envisage crossing the border HM Government would welcome the opportunity of considering a request to do so informally, so that they could consider and advise the Pope about all aspects of such a visit in terms of its effect upon the two communities in Northern Ireland and their security. He will go on to say that it would not be possible to indicate in advance what HM Government's reaction might be to a specific proposal for a visit by the Pope to Northern Ireland. This would require consideration at the highest level in the light of the specific terms of a Vatican request. He will indicate that our problems would not be confined simply to ensuring protection for the Pope. It would also be necessary to consider the protection of individual citizens. Depending

on what exactly was proposed, a visit could easily spark off inter-communal violence in Northern Ireland in which innocent individuals could suffer tragically. There would be plenty of time between now and the visit for plans to be laid to disrupt it. The consequence could be damage to the very aims which the Pope had in mind in thinking about making the visit. He will urge that the Vatican should, therefore, consult HM Government fully, and at the earliest opportunity, and in any case before any public statement (however unofficial) is made.

We have been concerned about possible leaks on all this over the holiday week-end. In any case, the visit of Cardinal O'Fiaich to Rome may of itself produce press enquiries about the possibility of a visit by the Pope to Northern Ireland, irrespective of the conclusion which the Vatican itself reaches. Press Offices in London and Belfast have, therefore, been instructed to respond by repeating the substance of the statement made earlier by Frime Minister to Mr Fitt, but in the terms in which Mr Crossley has already spoken to the Vatican (see above). They would go on to say that no approach has yet been made and that if and when it is made Ministers will carefully consider it in all its aspects. They are instructed not to be drawn beyond this.

We cannot take this further at present, but you will wish to know that we have reported to my Secretary of State some preliminary views about our response should an approach from the Vatican be received. We would then know more clearly what is envisaged. At one extreme, if all that the Vatican had in mind was a symbolic gesture, e.g. a quick inand-out helicopter visit to pray at the grave of Cardinal Conway for peace and reconciliation (an idea that has recently been floated in more than one quarter), then there might be, comparatively, few problems. The present and provisional view of the security forces is that such a visit might provoke a disturbance somewhere (not necessarily in Armagh) but that it would present no insurmountable security problems, although they would obviously want to consider the specific proposal very carefully. If on the other hand the Pope was contemplating an open visit, allowing himself to be seen by (and to bless) thousands of people - perhaps from the steps of Armagh Cathedral - that would present security problems so severe that it might be necessary for us to tell the Vatican that a visit in these terms could not be contemplated at all. The risks if a spectacular visit of this type were contemplated would certainly go much wider than the Pope's own safety.

CONFIDERITIAE

Intercommunal violence would be a much stronger possibility and one tragic incident could have an incalculable effect on hopes for both peace and political progress. The fact that an "open" visit could have such serious implications in both security and political terms underlines the need for the earliest possible indication of the Vatican's intentions and this is what the Minister in Rome will be trying urgently to obtain.



There seems to have been such a welter of confusing messages and conversations yesterday about the possibility of the Pope visiting the United Kingdom that I thought it might be useful to set the record straight in a short letter.

The Prime Minister made clear yesterday that the Pope would be welcome to visit the United Kingdom but that at that stage she had had no approach from the Vatican. By own position was quite clear: if the question of the Pope visiting Northern Ireland arose. THE POPE AND NORTHERN IRELAND

I was in touch with you and other members of your Department on the telephone yesterday evening about the repercussions of the call which Mr. Gerry Fitt, MP, made on the Prime Minister at her room in the House of Commons at 1530. This letter records the sequence of events.

Mr. Fitt had, as you know, intended to catch the Speaker's eye during Prime Minister's Questions in order to ask the Prime Minister about a possible visit to Ulster by the Pope. did not, in fact, attempt to put his Question but came to see the Prime Minister immediately after Questions instead. Mr. Fitt said that he had already discussed the question of a visit by the Pope with your Secretary of State and he was in full agreement with Mr. Atkins' approach to the issue. It nevertheless had to be recognised that this would be a unique opportunity for the Roman Catholic population of Northern Ireland to see the head of their Church. If a visit by the Pope did not take place, it would be widely felt in Northern Ireland that this was the fault of Mr. Paisley. The Prime Minister told Mr. Fitt that the British Government had received no approach from the Vatican about a visit If a request were to be received for the Pope to visit the United Kingdom, he would be welcome. It would have to be borne in mind that he would come to the United Kingdom as a Head of State; and this would have certain implications. If the Government were to receive any indication that the Pope wished to pay us a visit, we would of course be happy to discuss all the arrangements for the visit with the Vatican in the usual way.

Mr. Fitt again asked the Prime Minister to confirm that the Government had received no representations from the Vatican about a visit. The Prime Minister repeated that we had not: if such representations were received, they would be considered favourably. Mr. Fitt asked whether he could say this to his friends. The Prime Minister said that, so far as she was concerned, Mr. Fitt could say that the British Government had received no

indication from the Vatican that the Pope wished to pay us a visit; that if the Pope were to wish to visit the United Kingdom, he would be welcome; and that if he wished to come, we would be happy to discuss the arrangements for a visit to the United Kingdom with the Vatican in the usual way. At the Prime Minister's request, Ian Gow and I put this formulation in writing for Mr Fitt before he left the Prime Minister's office, and he took it with him.

As you know, the following item appeared on the PA tapes at 1745:

"Pope 'welcome' in Ulster. The Pope would be very welcome if he wished to visit Ulster, Prime Minister Margaret Thatcher told Irish Catholic MP Mr. Gerry Fitt today. In a private meeting at Westminster with Mr. Fitt, leader of the mainly Catholic Social Democratic and Labour Party, Mrs. Thatcher said that all necessary security arrangements would be made. 'She said she had had no word from the Vatican yet, but that if the Pope wanted to visit the UK he would be a very welcome guest' Mr. Fitt said."

At 1815, I received a telephone call from Mr. Ian Paisley, MP. Mr. Paisley said that he was deeply concerned by reports that the Prime Minister had issued a statement to the effect that the Pope would be welcome in Northern Ireland. This, he said, seemed to be at complete variance with the assurance which he claimed to have been given by Mr. Atkins on the previous day to the effect that, if there were to be any question of a visit by the Pope to Ulster, the elected representatives of the people of Northern Ireland would be heard before decisions were taken. Mr. Paisley that the Prime Minister had made no statement about a possible visit by the Pope. Any statements emerging from the No. 10 Press Office at that time were designed to correct misleading reports which had appeared on the tapes concerning a conversation between the Prime Minister and Mr. Fitt earlier in the day. I read over to Mr. Paisley the terms of the No. 10 correction, which were identical to those in the formulation agreed with Mr. Fitt.

Mr. Paisley then spoke at some length to the effect that these statements had created an extremely serious situation in Northern Ireland and that the Government were sitting on a powder keg. He repeated that the statements being made by No. 10 were in conflict with the assurance which he claimed to have been given by Mr. Atkins. He asked that this assurance should be repeated from No. 10 and said that he would like to call on the Prime Minister himself. Mr. Paisley said that if the elected representatives of the people of Northern Ireland could not be heard, he could not be held responsible for the consequences. If an opportunity for a hearing were denied, he saw no further use in politics nor in the ballot box. I told Mr. Paisley that I would wish to

discuss what he had said to me with Mr. Atkins' office and undertook to telephone him again when I had done so.

You subsequently told me that Mr. Atkins had not, in fact, given Mr. Paisley an assurance in the terms attributed to him. You suggested that, in speaking again to Mr. Paisley, I should repeat to him, making it clear that I was doing so on the Prime Minister's authority, the corrected statement put out by No. 10 earlier in the evening, emphasising the reference to "the United Kingdom". I should go on to say that if a proposal for a visit by the Pope to the United Kingdom were to be received, the detailed arrangements for such a visit would be discussed in the usual way, in consultation with those concerned in the United Kingdom. I should add that the Government, and of course Mr. Atkins himself, would welcome Mr. Paisley's views as part of this process.

The Prime Minister agreed that I should speak to Mr. Paisley in the terms which you suggested and I did so at 1930. I made it clear at the outset that I was not prepared to discuss with him the substance of his conversation with Mr Atkins on the previous day, at which I had not been present; and that it would be best for any differences of view as to what had passed on that occasion to be pursued by him direct with Mr. Atkins or his office. Mr Paisley carefully noted down the sentences which we had agreed between us and at first seemed mollified by the reference to "consultations". He then asked, however, whether he was to conclude from my opening remarks that Mr. Atkins was not prepared to stand by the assurance which he had given. I repeated that I thought it would be better if he were to pursue this point with Mr. Atkins direct.

Mr. Paisley then launched into a long diatribe, to the general effect that if Mr. Atkins was not prepared to stand by his word there was clearly no point in pursuing the current talks with him. Mr. Paisley said that he therefore proposed to inform the press very shortly that he was breaking off his talks with the Secretary I told Mr. Paisley that I thought it would be regrettable if he were to take this step without making further contact with Mr. Atkins or his office in order to clarify matters. Mr. Paisley replied that he did not propose to take any initiative in speaking to Mr. Atkins again but if Mr. Atkins wished to telephone him before he spoke to the press, he would of course listen to what Mr. Atkins had to say. Mr. Paisley ended the conversation by saying that he would like to make his views known to the Prime I told him that I would convey this request Minister direct. to the Prime Minister.

I should be grateful for advice on how the Prime Minister should respond to Mr. Paisley's request to see her.

I am making arrangements to inform Sir Philip Moore, in Lusaka, of this background to reports which he may see on the tapes or in the press about a possible visit by the Pope to Northern Ireland, some of which continue to be cast in misleading terms.

I am sending copies of this letter to Paul Lever (Foreign and Commonwealth Office) and Martin Vile (Cabinet Office).

I telephoned Mr. Paisley at 1930 this evening. I made it clear at the outset that I was not prepared to discuss with him the substance of his conversation with Mr. Atkins yesterday 1, since I had not been present; and that it would be best for any differences of view as to what had passed on that occasion to be pursued by him direct with Mr. Atkins or his office. I then spoke to Mr. Paisley in the terms which you had approved, making it clear that I was doing so on your authority. Mr. Paisley took down what I said and at first seemed mollified. He then asked whether he was to conclude from my opening remarks that Mr. Atkins was not prepared to stand by the assurance he had given him yesterday. I repeated that I thought it much better if Mr. Paisley pursued this point direct with Mr. Atkins. Mr. Paisley then went off into one of his usual fulminations,_ to the effect that if Mr. Atkins was not prepared to stand by his word there was clearly no point in pursuing talks with him. Mr. Paisley said that he therefore proposed to inform the Press very shortly that he was breaking off his talks with the Secretary of State. I told Mr. Paisley that I thought it would be very regrettable if he were to take this step without making further contact with Mr. Atkins or his office. Mr. Paisley said that he did not propose to take any initiative in speaking to Mr. Atkins again but that if Mr. Atkins wished to telephone him before he spoke to the Press he would of course listen. In conclusion, Mr. Paisley

/said

said that he would like to make his views known to you directly. I said that I would pass this request on to you.

I relayed the above to Mr. Atkins' office. Mr. Atkins now proposes to speak to Mr. Paisley on the telephone this evening.

Would you be prepared to agree to a brief call on you by Mr. Paisley, to balance Mr. Fitt's call? Or would you rather leave Mr. Atkins to cope?

VISIT BY MINISTER AT HOLY SEE TO THE VATICAN AT 1730 ON 26 JULY

The Mirister has asked whether we would agree that in conveying his message as instructed he could go so far as to say that <u>if</u> the Pope were to decide that he wished to visit Northern Ireland he would be welcome.

His instructions (at Annex) were deliberately drafted in terms which convey pretty plainly that our first choice would be that the Pope did not go. Accepting the Minister's advice that something less cool might get a more helpful response, one still would not want to express a welcome to a visit by the Pope to Ulster in those terms.

The right tone, which we would need to convey by telephone to the Minister this afternoon, would be as follows:

- 1. If a visit by the Pope to the Province is not contemplated it would be helpful if this could be made known as soon as possible so that extremist statements of a kind being made by Dr Paisley could be seen to be irrelevant and thus reduce the risk of stirring up inter-communal discord.
- 2. Her Majesty's Government trusts that the Pope understands that if he wished to make a vicit to the United Kingdom then he would be warmly welcomed and the Government would do all in its power to make his visit a success.

 If the Pope wishes, during the course of his pastoral visit to the church in Ireland to travel from the

Republic of Eire into the Province of Ulster, HM Government would welcome the opportunity of considering a request to do so informally so that they could consider and advise the Pope about all aspects to such a visit in terms of its effect upon the two communities of Northern Ireland and their security.

MESSAGE TO MINISTER AT HOLY SEE ∠Give him press guidance7.

Go in and say HMG would appreciate an early indication whether or not the Pope is contemplating making a request to visit Northern Ireland during his visit to the Republic. You should explain the line we have taken publicly and say that, if a visit to the North is not contemplated it would be helpful if this could be made clear without further delay, in order to damp down speculation. You should of course draw attention to extreme public statements by Dr Paisley and the risk that these will stir up inter-communal discord. You should of course make it clear that we do not regard Dr Paisley as the sole spokesman for Northern Ireland Protestants: the Church of Ireland clearly takes a different view.

If asked what HMG's attitude would be to such a request, you should say that you would need to seek instructions. However, you should express the hope that, if such a request is contemplated, an informal indication would be given to HMG, so that we would be in a position to indicate our likely response before a formal request is made and before anything is said publicly.

You should indicate that HMG have not considered what their view would be of their reaction to such a request. Security considerations - on which Ministers would need expert advice - would of course be a very important factor.

- 1. IN RESPONSE TO PRESS INQUIRIES WE ARE TAKING THE LINE THAT

NORTHERN IRELAND

Mr. Gerry Fitt, MP, called on the Prime Minister at his own request in the House of Commons at 1535 this afternoon to discuss reports of a possible visit by the Pope to Northern Ireland.

Mr. Fitt said that he had already discussed the matter with the Secretary of State for Northern Ireland and was in total agreement with Mr. Atkins' approach. But it had to be recognised that this would be a unique chance for the Roman Catholics in Northern Ireland to see the head of their Church; and that it would be widely felt that if a visit did not take place it would be the fault of Mr. Ian Paisley.

The Prime Minister told Mr. Fitt that the British Government had received no request from the Vatican for a visit by the Pope. If a request were to be received for the Pope to visit the United Kingdom, he would be welcome. It would have to be borne in mind that he would come to the United Kingdom as a Head of State; and this would have certain implications. If we received any indication that he wished to come, we would of course be happy to discuss all the arrangements for his visit with the Vatican in the usual way.

Mr. Fitt again asked whether the Government had received any representations from the Vatican about a visit. The Prime Minister repeated that we had not. If we did receive such representations, they would be considered favourably. Mr. Fitt asked if he could say this to his friends. The Prime Minister said that, so far as she was concerned, Mr. Fitt could say that the British Government had received no indication from the Vatican that the Pope wished to pay us a visit; that he would be a welcome visitor to the United Kingdom; and that if he wished to come we would be happy to discuss the arrangements with the Vatican in the usual way.

Thank you for your letter of 22 June. I am sorry if you found my note unhelpful.

I understand that, since you sent your letter, you have had another chance to discuss the security situation at some length with the Secretary of State for Northern Ireland and there has also been the Renewal Debate, in which he fully set out the Government's assessment and the policy being followed.

For the moment it seems unlikely that we would have anything to gain from a meeting on security. But you should be in no doubt that the continuing violence in Northern Ireland is a matter of close personal concern to me.
