TEXT OF STATEMENT FROM THE PRIME MINISTER OF AUSTRALIA, THE RT. HON. MALCOLM FRASER, TO PARLIAMENT ON 18 SEPTEMBER 1980.

I informed the House on 19 February 1980, when I outlined the Government's response to the Soviet invasion of Afghanistan, that we intended discussing with our regional friends the further development of our defence relations with them. One of the specific measures that I mentioned then was combined exercises between the Australian Defence Force and forces of our South East Asian neighbours. The resilience of independent regional countries is an important element in contributing to regional stability, and the abiding security interests we have in common with our neighbours call for continuing consultation and cooperation in the defence field. The Government regards such cooperation as a long-term measure of major importance.

I am pleased to be able to inform Honourable Members that I took the opportunity during the recent Commonwealth Heads of Government Regional Meeting in New Delhi to hold further consultations on defence matters with the Prime Minister of Malaysia, Datuk Hussein Onn, and with the Prime Minister of Singapore, Mr Lee Kuan Yew. We all agreed that all three countries would gain much from the conduct of our respective defence forces of multinational exercises. It was agreed that we should initially look to conducting these under the auspices of the Five Power Arrangements.

Since returning from New Delhi, I have consulted with my British and New Zealand colleagues. They have indicated that they endorse what is proposed. There is therefore now agreement in principle between all partners of the Five Power Arrangements.

Honourable Members may be aware that the last major exercise involving all participants in the Five Power Arrangements, including both ground and air forces, took place in 1970. More limited air defence exercises are regularly held in the Malaysia and Singapore area and there are frequent bilateral exercises involving ground forces of the various participants. For example, today there are Singapore soldiers in Townsville preparing to take part in an exercise with Australian troops. An infantry company of the Malaysian Army took part in a similar exercise in Australia in May-June last year.

Now that we are all agreed that exercises having a more distinctive multinational character should be reinstituted, we shall be taking early action towards this end. I have given instructions that Australia should move with full vigour to help put the agreement into practical effect.

Singapore recently requested that the Singapore Armed Forces be permitted to carry out their own training exercises in agreed training areas in Australia. A small country, Singapore faces exceptional difficulties in finding adequate training space for its armed forces on its own territory.

The Singapore request is for facilities to enable them to exercise their Commanders and Units of their ground forces. Some naval training and air crew training is also envisaged. Included in the last-named is a request to deploy and maintain at Nowra Naval Air Station a small number of Skyhawk aircraft to facilitate advanced pilot training.

We have been pleased to agree to Singapore forces conducting training exercises in Australia and have also agreed to their specific request to deploy Skyhawk aircraft to Nowra.

All this has been discussed with Malaysia as a member of the Five Power Arrangements.

I have already emphasised Australia's abiding interest in the security of the area to our north.

The Government is prepared to give sympathetic consideration to meeting the special needs of other regional countries. Indeed, I made this clear during my discussions in New Delhi.

We are exploring with the Malaysian and Singapore Governments arrangements for high-level talks on a broad range of matters in the defence field including those I have already referred to. I have indicated to Prime Minister Hussein Onn and to Prime Minister Lee our readiness to have the Secretaries of the Departments of Defence and Foreign Affairs and the Chief of the Defence Force Staff visit Kuala Lumpur and Singapore for such discussions at an early date.

Dy dear Prine Minister.

Thank you for your message of 11 September describing your discussions with the Prime Ministers of Malaysia and Singapore about possible multi-national exercises under the auspices of the Five Power Defence Arrangements (FPDA).

You will remember that after our talk on the FPDA in London earlier this year, we stressed the importance which we attached to the support from regional members for any initiative to revitalise the FPDA. I was therefore particularly pleased to hear that Hussein Onn and Lee Kuan Yew had welcomed the idea of joint exercises.

Subject to our available resources, and as you know they are very stretched, the United Kingdom would certainly wish to play its part in breathing life into the FPDA.

Because we no longer maintain substantial forces in the area, we can not commit ourselves to participating in any exercises until their form and timing are clearer; but we are, of course, entirely willing to take part in official talks to consider possible exercises.

We certainly have no objection to your proposal to make an announcement in the Australian Parliament.

Brian Norbury passed to me Michael Alexander's letter of 11th September asking for advice on Mr Fraser's letter to the Prime Minister in which he seeks agreement to announce the planned holding of joint exercises under the Five Power Defence Arrangements.

Officials of our two Departments had earlier discussed a number of possible measures to breathe life into the Arrangements, including the holding of exercises. Now that both Malaysia and Singapore appear to favour joint exercises, we are certainly ready to engage in discussions with our partners to see what might be arranged. Our resources are, of course, limited and largely committed elsewhere, so United Kingdom participation in any such exercises is likely to depend heavily on the resources available in the area at the time.

As I have already mentioned on the telephone, Lord Strathcona has seen, and is content with, the draft reply to Mr Fraser.

### Five Power Defence Agreements

You wrote on 11 September to Stephen Gomersall enclosing a copy of the message to the Prime Minister from the Australian Prime Minister proposing the holding of joint exercises under the auspices of the Five Power Defence Arrangements (FPDA).

You will remember that Mr Fraser raised the topic of "breathing life" into the FPDA when he met the Prime Minister in February this year. Following those talks we told the Australians that:

- a) we should be pleased to play our part within the limits of available resources;
- b) in our view any initiative should come from the regional members.

It is not clear from Mr Fraser's letter whether he proposes to announce a decision to hold exercises, talks about exercises, or both. Whatever the intention, the Australians have told our High Commission in Kuala Lumpur that Hussein Onn has agreed to the announcement. The New Zealanders have informed our High Commission in Singapore that the Singaporeans have endorsed the proposal and are likely to agree to Fraser's proposed statement. We do not know the New Zealand reaction but they are unlikely to object.

Politically we consider we should welcome any measures to "breathe life" into the FPDA. But we no longer maintain substantial forces permanently in the area, and we could not commit ourselves to participating in exercises until we know the form and timing of them. We suggest therefore that in her answer to Mr Fraser the Prime Minister should express our willingness to discuss with our FPDA partners any proposals for holding joint exercises.

My Dear Prime Minister,

During the course of the Commonwealth Heads of Government Regional Meeting in New Delhi, both Prime Ministers Hussein Onn and Lee Kuan Yew discussed with me a range of subjects concerning defence cooperation in the One suggestion was that we should have joint multinational exercises under the auspices of the Five Power Defence Arrangements. Both Hussein Onn and Lee Kuan Yew were clearly attracted to this. Indeed, Hussein commented that he did not understand why such exercises had not been held in recent years.

For our part, we are anxious to develop such exercises and we have told the Malaysian and Singapore Prime Ministers that we would like to have official talks with them about this.

We very much hope that you will wish to have your own national forces participate in whatever combined exercises might be agreed upon, but that is a matter that can be taken up later. In the meantime, I would like to inform the Australian Parliament next Thursday that it is proposed to hold these exercises under the auspices of the Five Power Arrangements.

It would help me to know that you see no problem about a statement of this kind.
