In paragraph 2 of my letter of 9 March to John Coles, I referred to the 'final sum due' to be met by the Prime Minister in respect of the rescue of her son.

A month after that letter was sent, two more bills were received by our Embassy in Algiers. They were for landing charges incurred by the aircraft bringing Mr Denis Thatcher from the United Kingdom and amount to a sterling equivalent of £15.16. The delay in submitting them to you was caused by the Embassy accountant charging them to a suspense account which has only now been audited.

Thank you for your letter to Francis Richards of 15 February in which you asked, since the Prime Minister had decided that she did not wish any charge to be made to public funds, for a bill for £1,190.95 to be sent to you. You also said that the Prime Minister would meet bills for a total of £583.14, referred to in your letter of 8 February, when they were presented, the total for the two bills being £1,774.09.

Further calculations here show that the sum due, as you will see from the enclosed statement, is in fact £1,784.80. As previously agreed, the Prime Minister is being asked to pay Consular fee 37 (£412.50) instead of the actual costs of air fares and subsistence (items 1 - 3 of the enclosure with my letter of 3 February) plus the cost of accommodating the Swiss Rally team. Although the Prime Minister asked that the bill for this (item 4) should be sent direct to No 10, it was, in fact, presented to and paid by the Embassy Accountant in Dakar and is, therefore, repayable to the FCO. In the event, the final sum due amounts to £129.42.

The remainder of the amount to be met by the Prime Minister is previously agreed telegram and telephone costs (items 5-8).



MARK: COSTS OF RESCUE OPERATION, ETC.

The attached FCO letter contains advice on how the costs should be apportioned and the public line which should be taken where necessary.

All the hotel expenses in Tamanrasset have been met by the Algerian Government. The attached telegram describes the background.

One or two bills may emerge later which are not taken account of in the attached letter. But I am sure they will not be large. The letter does not take account of telephone calls made from Downing Street. These were numerous but I think they are a proper charge to public funds either because:

- (a) they were required for reasons of courtesy towards a foreign government, or
- (b) they were connected with an operation to locate a UK citizen in distress and it is not normal practice to make a charge for such calls.

In advising how to apportion the costs the FCO based themselves, with my agreement, on two principles:

- (a) As regards what may broadly be called the Consular aspect (the various activities carried out by British officials in support of the search and rescue operation), public funds should bear only such costs as they would have done if Mark had been an ordinary UK citizen.
- (b) As regards other costs a distinction should be made between those which were incurred for reasons of diplomacy (e.g. messages to the Presidents of Algeria and France), which are a proper charge to public funds, and other costs which cannot properly be so charged.

If you agree with the advice, the total cost to be met by you or your family personally would be, subject to any unforeseeable bills coming in later, a maximum of £583.14. You asked for advice on (a) the costs of the search and rescue operation; and (b) (your letter of 3 February) the line to be used in responding to inquiries on this subject.

It appears to us that the costs which we should seek to recover in this case are those listed in items 1-4 of the attached statement, totalling £531.21. For reasons explained below, however, the actual charge to be levied should be the rather higher figure of £583.14. These costs are primarily those we should normally consider 'consular'; we do not think it right to seek recovery of those costs incurred for primarily 'diplomatic' reasons.

Perhaps it would help if I explained in rather more detail the criteria we have adopted. The normal rules have given us some guidance, but in such a case as this there are inevitably considerable grey areas where we have had to rely on judgement. In order to make sure that the outcome is readily defensible in the kind of terms you have in mind, we have in cases of doubt opted for the higher charge to the Prime Minister. We have divided the cost into three categories:

- (a) Normal 'consular' costs;
- Normal 'diplomacy' costs;
- Others (ie 'possibly recoverable').

Items 1-3 in the attached statement are unusual. If it is necessary for a consular official to attend at a place other than consular premises, it is normal to charge fee 37 in the Consular Fees Table. In this case, the total fee would be £412.50, and though this is higher than the actual cost of £360.57 shown in the table, we believe that it would be right for this higher sum to be recovered.

The bulk (over 75 per cent) of the remaining costs (items 5-9 in the attached statement) relate to telegrams and telephone calls. These can properly be attributed to normal consular costs, or in the case of messages of thanks (including translations) from the Prime Minister, Mr Denis Thatcher and Mr Mark Thatcher to Heads of States or Governments, Government officials and so on, to 'diplomacy'. We regard these as a proper charge to the FCO. The cost of messages of thanks is not listed separately in the statement. We do not believe that it would be either reasonable or practical to treat those messages sent by other members of the Prime Minister's family as different from those which she sent herself. These have not been included because, apart from the fact that it would be almost impossible to arrive at any sort of accurate figure, it is not normal consular practice to charge such costs over and above statutory fees or actual expenses.

As regards the line to take in answer to inquiries, the line you suggested in your letter of 3 February seems to us appropriate, but we would suggest that it be modified so as to limit it to the cost of the search and rescue operation, and to exclude the diplomatic costs of the various messages of thanks. It would then read as follows:







MR. MARK THATCHER

When the question of costs for the search and rescue operation has been settled we shall need to adopt a line to be used in response to public and possible Parliamentary enquiries, a number of which have been received here. I should like to be able to use wording on the lines of that in paragraph 2 below but I should be grateful if you could arrange for this to be looked at and amended as necessary. It is important that it should be entirely accurate and defensible.

I propose that in dealing with such enquiries we should draw on the following:-

"No charges have been made to official funds other than those which would be so charged in the case of assistance for any UK citizen in distress. All other bills which have been raised have been met by Mrs. Thatcher personally.

"The total cost to the UK taxpayer, which consists exclusively of those expenses which the Government would meet in the case of assistance for any UK citizen in distress, amounts to (a figure will have to be inserted later).


"The major part of the expenses of the search and rescue operation was met by the Algerian Government. Mrs. Thatcher has expressed her gratitude for their generosity. The Governments of France and Mali also contributed to the operation at their own expense and similar thanks have been expressed.

"No charge has been made to official funds in regard to the hotel expenses in Tamanrasset of Mr. Denis Thatcher, Mr. Mark Thatcher or the accompanying British officials."



MARK THATCHER - COST OF OPERATION

Because of the generosity of others - especially the Government of Algeria - the British role was minimal. HMG have not been asked to pay any costs.

The cost of the British contribution will be small but has not yet been fully worked out.

There is no question of any costs being improperly charged to the taxpayer. I shall make sure they are not.

Appropriate Consular assistance is given to <u>any</u> distressed UK citizen. The extent of assistance provided by other governments is entirely a matter for them.

When a friendly Government is devoting so much effort to finding a UK citizen, it is right that the British Ambassador should be on hand as well. Anything less would be downright discourteous.

Were RAF Aircraft Used?

No. But as a precautionary measure an RAF Hercules already in the area on a routine flight to Dakar called at Gibraltar to collect rescue equipment for use in case the Algerians asked for UK assistance. The aircraft continued its planned movement to Dakar but was in the event not required to help in the search.

Cost?

The change in the aircraft's flight plan was made as a precautionary and life-saving measure for which no charge is customarily made.

The Prime Minister invited the Ambassador of Algeria to call this afternoon. Mr. Denis Thatcher and I were present. Mr. Young provided interpretation.

The conversation was mostly of a general nature and related entirely to the operation mounted last week by the Algerian Government to find Mr. Mark Thatcher in the desert. The Prime Minister told the Ambassador that she had particularly wanted to express to him her thanks and those of her husband for everything which the Government of Algeria had done. She told the Ambassador that she had of course already written to the President, Prime Minister and Foreign Minister of Algeria. But she and her husband had been so impressed by the speed and effectiveness of the efforts made by the Algerian Authorities that she had wished to leave the Ambassador in no doubt of her gratitude.

The Ambassador said that his Government was extremely satisfied at the outcome. The Algerian Authorities had regarded the operation as a matter of duty; it was the tradition of Algeria that such assistance should be given in circumstances of this kind. The Ambassador also said that his Embassy had been deluged by telephone calls from journalists. He had the impression that they were mounting an "insidious" campaign against the Prime Minister. He wished to make it clear that the Government of Algeria did not wish to be associated with this in any way.

It was not clear precisely what the Ambassador was referring to, but I suppose that some journalists may have attempted to obtain sensational details about the episode, and might have tried to elicit information about the cost.



Please accept this assurance of my warmest gratitude to you and to the French men and women who, as a result of your initiative, contributed to the search operation and to its happy outcome.

MARK AND PRESS

We need to think ahead how we play the next 24 hours.

As of now, we are feeding out blow by blow and awaiting confirmation. This is not now an elegant posture but it is perfectly tenable. But for the 4.00 pm Lobby I need a line, over and above the detailed diary of events and colour material. I propose it should be as follows:

"The Prime Minister heard Mr Thatcher on the ITN news bulletin reporting that he was 90% certain Mark, his crew and car had been located. We now await confirmation and this may not be forthcoming for several hours. You must keep in touch. In the meantime the Prime Minister is carrying out her programme and intends to go to Manchester tomorrow."

After Confirmation

Once Mark's rescue has been confirmed, we should put out a statement from the Prime Minister and I attach a draft at Annex A.

The Prime Minister has agreed not to give press, radio or TV interviews. But they will seek every way telephonically into No.10 and, given that Carol has given interviews, will try to get at the Prime Minister through her.

It would be a help if Carol could keep us posted on approaches and let us know what she is saying so that we sing in tune.

So far as press, radio and tv is concerned today, I shall say there will be no Prime Ministerial interviews; they will have to be satisfied with the on-the-record statement from the Prime Minister. But I suspect that radio programmes, especially from abroad, may well try to break through the shield as they did in Melbourne. You may therefore consider concentrating press calls on to Press Office by giving instructions to switchboard.

Tomorrow

Mr Gaffin will be doing a separate note on arrangements. All I wish to say is that we need to introduce the maximum control, and we need to avoid the Prime Minister giving her reaction time after time. We need to find a location where this can be done most effectively: that is not in Downing Street. If she said anything in London she would still be dogged in Manchester, Consequently, Mr Gaffin is trying to find a way of coping in Manchester which minimises the amount of trouble for the PM.

In Africa

We need to consider what advice we should give to Mr Thatcher and Mark in Algeria. This is difficult since we do not know any details or circumstances. But what is clear is that there is only one way to deal with the issue - for Mark and Mr Thatcher to hold a press conference, filmed without separate BBC, ITN, IRN interviews, at which one story comes out.

Second, it is absolutely crucial in view of the expense run up in the search that Mark resists every blandishment on the part of any individual newspaper to buy up his story. He must show no partiality, but deal even handedly with all in open press conference, so that no one can level charges against him.

Third, it is essential that any telephone calls as between Mark and Prime Minister are conducted in absolute privacy.

Back in London

Whatever the access in Africa, the British media will give saturation coverage to the return home of Mark and Mr Thatcher. Again there is much to be said for killing that interest with a press conference at the airport on arrival, which we could organise.

We shall need to give thought to the Prime Minister's welcome. The press would give their right arms for a reunion picture. They should be denied it and the reunion should be behind closed doors either here or at Chequers?

Could we discuss?

- 1. I attach a minute recording action taken by the FCO in support of the search for Mr M Thatcher up to noon today. It was written before the unconfirmed reports that Mr Thatcher has been spotted. But since these may take some time to confirm, I see merit in issuing the report as it stands, to be supplemented later if necessary.
- 2. It is clearly right for NENAD to have been placed in charge of this operation, and that this should continue for its duration. I do not believe that any more elaborate structure to deal with the situation is necessary, beyond the measures referred to in paragraph 10 of the report. It is quite clear to me that Mr Howarth has done a very professional job in coordinating operations in the last two days.

- 1. This minute records action taken by the FCO (and the MOD) in support of the efforts to find Mr M Thatcher. It represents the situation at noon today, 14 January. There have since been further developments, reported to those concerned separately.
- 2. The last confirmed sighting of Mr M Thatcher was by Swiss rally driver Michel Bosi on Friday, 8 January at approximately 70 kms North East of Timeiaouine. Mr Thatcher's car had reportedly broken down (reports of the cause and of whether or not there is a mechanic in addition to Mr Thatcher's co-driver are conflicting). According to the rally search supervisor, Mr Sabine, four search vehicles reached the point where Mr Bosi had left Mr Thatcher on Tuesday, 12 January, but the car was no longer there. There have been no confirmed sightings since.
- 3. Unconfirmed reports include:
 - (a) Two 'missing' persons had been recovered (AFP, 13 January'
 - (b) Mr Thatcher's car and co-driver located, but Mr Thatcher himself missing (Times Correspondent Paris, 13 January).
 - (c) eVehicle sought and persons answering to description of Mr Thatcher and companions crossed into Mali on 12 January via Irharen en route towards Gao. ('Inspecified officials at the Algerian/Mali frontier, 13 January).

 (d) There is no evidence (see press speculation) that the Polisario or the Libyans are involved in Mr Thatcher's disappearance.
- 4. Mr Denis Thatcher, accompanied by HM Ambassador Algiers, our Vice-Consul, and an Algerian Genarmarie liaison officer are in Tamanrasset where the Algerian search and rescue operation is based. The Algerians have undertaken to set up a telex link from Tamanrasset to the Ministry of Foreign Affairs in Algiers to which Mr D Thatcher and HMA would have access.

/5.

- 5. The Algerians, French and Malian authorities are all cooperating fully.
 - (a) The Algerians have committed four aircraft (one equipped for aerial survey) and one helicopter with medical equipment and supplies on board, in addition to land forces.
 - (b) The French have three aircraft based in Gao searching the area between Bamako and Gao and between Gao and the Algerian frontier. The French are in touch with the Algerian authorities in order to allow French aircraft to conduct searches in Algeria.
 - (c) The French Charge d'Affaires in Bamako has conveyed HMG's concern to the Malian Foreign Minister, who has promised to take early action. It has since been confirmed that the Governor of Gao and his authorities have been alerted and are joining in the search.
 - (d) The rally organisers are themselves searching.
- 6. Our other personnel in the area (apart from our posts in Dakar and Algiers) are as follows: Miss Coombe, Second Secretary, Chancery, Dakar, is with one of the French aircraft at Gao, and Mr Richard White, also of the Embassy in Dakar, should now be in Bamako in order to keep in close touch with the Malian and French authorities there.
- 7. The MOD have already diverted an RAF Hercules en route from UK to Dakar (on routine business), to Gibraltar where it picked up rescue packs. The MOD are now sending the aircraft on to Dakar where it will stand by in case of need. The MOD are also consulting No 10 on the possibility of using a Canberra aircraft for aerial reconnaissance over the area. The MOD also considered, but for operational reasons, rejected the use of a Nimrod. But no decision has been taken by No 10 on whether the Hercules or the Canberra should be used. The MOD have pointed out that if either of the aircraft are used in response to an Algerian or Malian request for assistance, no costs will have to be charged.
- 8. We consulted HM Embassies in Algiers and Dakar on 13 January on likely Algerian and Malian reactions to a UK offer to help. Algiers reported that it would be best to await the scale and effectiveness of Algerian operations before making an offer. Dakar thought it best to leave efforts to the French for 24 hours and only consider UK assistance if it became clear that Mr Thatcher was not in the area now being searched.
- 9. For the present it is not clear what further can be done except to await the results of today's search and decide in the light of developments whether to make an offer of assistance to Algeria and Mali.

/10.

- 10. A group of interested FCO Departments (NENAD, WAD, Consular, News and Defence Departments) met under Lord N Gordon Lennox (AUSS) this morning to discuss this report, which has been drafted by Mr Howarth (NENAD). They agreed that NENAD would remain operationally in charge of this matter within the FCO, reporting regularly to Lord N Gordon Lennox who would convent further interdepartmental meetings as necessary. No more elaborate structure seems at present needed. The meeting also discussed and approved guidance for News Department. They agreed that HM Ambassador in Dakar, at present in Banjul, should be asked to return to Dakar as soon as possible.
- 11. Since the above was drafted, there have been unconfirmed reports that Mr M Thatcher has been found.

Madame Verney asked whether he had sent any news. I said he had been impressed by the search operation which had been remounted this morning.

The Algerian Foreign Minister telephoned this office at 1300 today. I explained that Lord Carrington was on his way to Brussels.

M. Benyahia said that an Algerian military aircraft had just located Mr Mark Thatcher and his two companions. The aircraft had made a low pass over their car, which was 400 kilometres south of Tamanrasset. The party had erected a tent. I enquired about their condition. M. Benyahia said that they had all signalled to the aircraft.

M. Benyahia said that the Algerians were now sending a helicopter carrying a landrover in order to recover the party. The helicopter would have to fly 300 kilometres to land the landrover, which would then have to make a further 100 kilometre journey. I asked how long this would take. He thought two to three hours, but this may have been a guess off the top of his head. He said that the party would be taken back to Tamanrasset by the same route.

I promised to inform No 10 immediately of this news, and I have of course done so. I said that the Prime Minister and the Foreign Secretary had of course personally followed with close attention the search operation mounted by the Algerian Government, and were extremely grateful for everything the Algerians had done. I also thanked the Foreign Minister warmly for taking the trouble to telephone the news himself and assured him that it would be received with the greatest of pleasure.

You have received a similar story from our Embassy in Algiers, who in turn have heard from HM Ambassador at Tamanrasset. The Ambassador has rightly pointed out that until the identities of the people who waved to the search aircraft are confirmed, we should exercise some caution: but that on the whole the signs are good.

M. Grenier of the French Embassy telephoned Sir Len Allinson at about the same time to pass on the same story. It has now been carried by the news media, including the BBC radio news at 1335.

As soon as the identities of the party are confirmed, we should send appropriate messages of thanks. I shall naturally consult No 10 about this: but in addition to those sent by the Prime Minister, I am sure that Lord Carrington will wish to send a personal message to M. Benyahia. We must also not forget the other Governments which have assisted, including the French, Malian and possibly Senegalese.

I hope it would not be premature to add a word of thanks to you for your considerable efforts in this matter over the past two days.

An Algerian rescue team today found Mark Thatcher who has been missing for 6 days in the Sahara. The official Algerian News Agency APS reported. Thatcher, 28, was found safe and sound at the settlement of Tindert about 400 kilometers (250 miles) from the town of Tamanrasset.

In its official despatch monitored in Paris APS gave no word about the fate of co-driver Verney and the mechanic. APS said a helicopter had left Tamanrasset airfield to collect Mr. Thatcher. Mr. Thatcher's father flew to the oasis town yesterday to join the search.


