BUT HE AND HIS STAFF ARE NOW BEING MUCH GLOOMIER WITH THE AUSTRALI-ANS WHO HAVE A SIMILAR PROBLEM. SO THE CHEQUE MAY YET BOUNCE. IF IT DOES WE SHALL HAVE THE FOLLOWING OPTIONS: (A) ACCEPT THE INDIAN POSITION (LIMITING ACCOMPANYING STAFF TO ONE, PRESUMABLY A DETECTIVE), AND USE COMMERCIAL FLIGHTS FOR OTHER SUPPORT STAFF. (B) AS ABOVE, BUT ATTEMPTING TO BADGER THE INDIANS INTO TRANS-PORTING ONE PRIVATE SECRETARY AS WLL (FALL-BACK POSITION RELUCTANTLY CONFIRMED IN TURY. (C) CHARTER AN AIRCRAFT OURSELVES. (POSSIBLY IN CONJUNCTION WITH THE AUSTRALIANS). (D) USE VC10 (OR ALTERNATIVELY THE AUSTRALIAN 707). (E) IN THE LAST RESORT, THREATEN THE PRIME MINISTER'S WITHDRAWAL FROM THE RETREAT IF ADEQUATE ARRANGEMENTS FOR HER SUPPORT STAFF CANNOT BE MADE. 2. MY COMMENTS ON THESE OPTIONS ARE RESPECTIVELY AS FOLLOWS: (A) THE INDIANS HAVE CONFIRMED THAT COMMERCIAL FLIGHTS WILL OPERATE ON BOTH 25 NOVEMBER (OUTWARD) AND 27 NOVEMBER (RETURN: BUT SEE BELOW). TIMINGS:

25 NOVEMBERS LEAVE DELHI 0900, ARIVE GOA 1255. (BUT TO BE CERTAIN OF CATCHING THE BOMBAY CONNECTION IT MAY BE SAFEST TO TAKE THE EARLIER DELHI-BOMBAY FLIGHT LEAVING DELHI AT 0710 INSTEAD.) 27 NOVEMBER: LEAVE GOA 1345, ARRIVE DELHI 1905. THERE REMAINS A DANGER THAT THIS FLIGHT WILL BE CANCELLED, IN WHICH CASE SUPPORT STAFF WOULD NOT (NOT) BE ABLE TO GET BACK TO DELHI UNTIL MONDAY MORNING. AS YOU KNOW, WE HAVE MADE BOOKINGS ON THESE FLIGHTS FOR ALL FIVE SUPPORT STAFF. (B) NATWAR HAD PREVIOUSLY DUG IN HIS HEELS AT PROVIDING FOR BOTH A DETECTIVE AND A PRIVATE SECRETARY FOR THE FOREIGN MINISTERS RETREAT (MY TELNO 858). WE SHALL HAVE TO PERSUADE HIM THAT THE PRIME MINISTER'S NEEDS ARE QUALITATIVELY DIFFERENT. HOWEVER

- STRONG OUR CASE, HE MAY FEEL IT POLITICALLY UNWISE TO DISCRIMINATE ANY FIRTHER IN OUR FAVOUR.
- (C) THE ONLY SUITABLE AND AVAILABLE AIRCRAFT WOULD BE AN HS748. FLYING-TIME WOULD BE APPORXIMATELY 4 1/2 HOURS, PLUS 45 MINUTES REFUELING. COST WOULD BE AROUND £8.000 EACH WAY. WE HAVE NOT ENGUIRED WHETHER THE INDIAN NAVY (WHO ARE RESPONSIBLE FOR AIR MOVEMENTS IN GOA DURING THE RETREAT PERIOD) WOULD GIVE FLIGHT CLEARANCE (THERE ARE VARIOUS SOVIET-SUPPLIED MILITARY AIRCRAFT THERE ABOUT WHICH THEY MAY BE SENSITIVE). THEY MIGHT INSIST THAT THE PLANE REMOVES TO ANOTHER AIRFIELD (E.G. BOMBAY) RATHER THAN REMAINING AT GOA OVER THE WEEKEND: THIS WOULD INCREASE THE COST IF WE WERE THINKING OF CHARTERING THE PLANE FOR JOURNEYS IN BOTH DIRECTIONS.
- (D) WE ARE STILL NOT CERTAIN WHETHER IT IS TECHNICALLY FEASIBLE TO USE THE VC10. GOA AIRPORT HAS LCN60. WHICH PUTS IT JUST WITHIN THE ACCEPTABLE RANGE FOR A LIGHTLY-LOADED VC10. BUT WE ARE NOT SURE ABOUT OFF-RUNWAY PAVEMENT STRENGTHS. SECURITY OBJECTIONS MIGHT LOOM EVEN LARGER IN INDIAN EYES FOR AN RAF AIRCRAFT AND CREW THAN FOR AN LOCALLY CHARTERED PLANE. THEY MAY ALSO CLAIM NOT TO HAVE HANDLING FACILITIES FOR A VC10: AND/OR TO BE UNABLE TO HANDLE/ACCOMODATE THE CREW OVER THE WEEKEND. IF WE ARE TO INVESTIGAT THIS POSSIBILITY WE NEED TO START QUICKLY.

As you will see, the High Commission agree that given the constraints of the CHOGM programme it would be very difficult to include a worthwhile visit to Calcutta.

We understand that it is not proposed that Mr Thatcher should be involved in the lunches for Heads of Delegation on the three days of the proposed business visits. 

- 1. YOUR PARA 2, LAST SENTENCE. THE QUEEN'S RECEPTION FOR THE BRITISH COMMUNITY WILL TAKE PLACE IN THE HIGH COMMISSION COMPOUND JUST BEFORE HER DINNER WHICH THE PRIME MINISTER AND YOU ARE ATTENDING AT MY HOUSE. THERE WILL BE ABOUT 400 PEOPLE PRESENT, FROM ALL OVER INDIA. BUCKINGHAM PALACE HAVE MADE CLEAR (YOUR TELNO 598) THAT THE PRIME MINISTER WOULD BE MOST WELCOME SEMICOLON AND THIS WOULD DEVIOUSLY APPLY ALSO TO YOURSELF. ATTENDANCE BY HER AND YOU AND YOUR SPOUSES WOULD CERTAINLY BE MUCH APPRECIATED BY THE COMMUNITY AND WOULD BE LOGISTICALLY SIMPLE TO ARRANGE AS A STOP ON YOUR WAY TO DINNER. BUT IT IS SOMETHING WHICH EITHER OR BOTH OF YOU COULD EASILY DUCK IF YOU PREFERRED. MY RECOMMENDATION THEREFORE IS THAT ALL FOUR OF YOU SHOULD COME IF YOU WOULD LIKE TO SEMICOLON BUT THAT YOU SHOULD FEEL UNDER NO OBLIGATION TO DO SO.
- 2. IF THE PRIME MINISTER COMES, MR BUTLER (WHO IS ALSO ATTENDING THE SUBSEQUENT DINNER) MAY LIKE TO ACCOMPANY HER SEMI-COLON AND OTHER SENIOR MEMBERS OF THE DELEGATION WOULD OF COURSE BE WELCOME. IT WOULD BE BEST TO ARRIVE AT 1845, FIVE MINUTES BEFORE THE QUEEN SEMICOLON AND TO LEAVE JUST BEFORE HER (AS I SHALL BE DOING), SO THAT SHE IS THE LAST TO ARRIVE AT DINNER.

AS SEEN FROM HERE THE BEST TIME MIGHT BE EITHER BEFORE LUNCH OR AT TEATIME OF 22 NOVEMBER (WHICHEVER IS LEAST AFFECTED BY WHATEVER TIME MRS GANDHI SUGGESTS FOR HER BILATERAL WITH THE PRIME MINISTER). A CONVENIET MEETING PLACE, GIVEN OTHER PREOCCUPATIONS AT MY RESIDENCE, WOULD BE THE GARDEN OF THE MINISTER'S HOUSE IN THE HIGH COMMISSION COMPOUND.







C. 11 Health CHGM: You asked us to enquire about the drug you used during your tour of India with the Prince of Wales, which was effective at keeping at bay stomach ailments. The drug is called Streptatriad. We have also asked the CSMA if he would recommend the Delegation to take these tablets while they are in India, or if it is something which should not be prescribed without reference to the GPs of the individual concerned. 



- 1. I WELL UNDERSTAND THE PROBLEM AS YOU DESCRIBE IT. AS REPORTED IN PARA 6 OF MY TELNO 858, I HAD A FURTHER GO AT HATWAR ON THIS YESTERDAY AND HE ACCEPTS THAT THE BALL IS IN HIS COURT. I MADE CLEAR THAT THERE WERE FOUR MINIMUM STAFF (IN ADDITION TO THE ONE FOR WHOM INDIAN ARRANGEMENTS ALREADY CATER) WHO WOULD BE NEEDED BY THE PRIME MINISTER URGENTLY AT BOTH ENDS OF HER JOURNEYS TO AND FROM GOA AND WHO SHOULD THEREFORE TRAVEL AS NEAR AS POSSIBLE SIMULTANEOUSLY WITH HER. - b) The opening ceremony for the 1983 CHGM will take place in the auditorium on the ground floor of the Vigyan Bhavan Conference Centre.


#### 2. PROGRAMMES

- The latest programme, as known at the time of publication, is shown at Appendix I.
- Programmes for Mr Thatcher and Lady Howe will be b) circulated separatly.

#### RETREAT WEEKENDS 3.

- The traditional CHGM Retreat Weekend for Heads of Delegation will take place at the Fort Aguada Beach Hotel in Goa, from Friday 25 November to Sunday 27 November. Heads of Government, accompanied by their spouses, and one aide will fly to and from Dabolim Airport, Goa in a special aircraft provided by the Indian Government. The flying time from Delhi to Goa is about 2 hours 30 minutes.
- Other members of the UK Delegation required in Goa during the weekend will also travel by special aircraft. Details to be confirmed. This party will stay at the Cidade de Goa Hotel which is located some 30 minutes by car from the Fort Aguada Hotel. Mr Peter Morris, 2nd Secretary DHC, Bombay will travel to Goa to assist the No 10 Party staying at this hotel.
- c) A Retreat weekend is also planned for Foreign Ministers in either Jodhpur or Udaipur.

#### 4. COMPOSITION OF THE UK DELEGATION

- a) A list of the United Kingdom Ministers, officials and support staff who will be in New Delhi for the Meeting, together with details of their living accommodation is given at Appendix II.
- b) A list of British High Commission staff based in New Delhi and accredited to the UK Delegation is also shown.

#### 5. AIR TRAVEL (OUTWARD)

- a) The Prime Minister, Foreign and Commonwealth Secretary and their immediate parties will travel to India by RAF VC10 (Task Ascot 1166) arriving in New Delhi on Tuesday 22 November. A press party will, subject to confirmation, also be carried and a refuelling stop will be made in Bahrain.
- b) All other UK based members of the party will travel to India by scheduled air services.
- c) Flight details, including for the VC10 are given at Appendix III. Details for the return from India, in so far as they are known, are also given at this Appendix.

#### 6. PASSPORTS ENTRY VISAS

- a) All members of the party should carry valid passports.
- b) No visas are required by British passport holders for entry to India.

#### 7. HEALTH

a) As far as the Indian Authorities are concerned there are currently no vaccination certificates required for entry to India, except for persons travelling from, or transiting through, yellow fever endemic zones. A transit through a yellow fever zone,

RESTRICTED however brief, will require a vaccination certificate. The Civil Service Medical Adviser has advised that b) immunisation against typhoid, cholera, polio and tetanus should be obtained by all those travelling in advance of their arrival in India. c) The party should also take protection against malaria and for this purpose a course of Paludrin tablets is recommended; one taken daily starting 2 days before arrival in India and continuing for 6 weeks after leaving the country. Tablets are enclosed for those who have not already received them from other sources. Detailed guidance on health and hygiene whilst in d) India will be issued with the local administrative arrangements disributed to the party on their arrival in Delhi, although at all the accommodation being used standards of hygiene should be good. In case of emergency or need, the British High Commission is equipped with its own hospital and has a full time doctor on its staff (Dr E R H Tennant in New Delhi).

#### 8. BAGGAGE

- a) Those travelling on the VC10 are requested to confine their hold loaded baggage to one reasonable sized suitcase
- b) Coloured labels for those travelling in the VC10 are enclosed on the following coding:-

9. INSURANCE

A note covering baggage and insurance regulations during official travel is attached at Appendix V.

#### 10. CLIMATE

- a) In New Delhi November marks the beginning of winter. The weather is likely to be warm during the day but temperatures drop markedly at night. Maximum recorded temperatures at this time of year are in the region of 80°F (27° Centigrade) and minimum temperatures around 50°F (10° Centigrade). The mean temperature is therefore about 65°F.
- b) In Goa, which is located some 1200 miles south of Delhi, the temperatures will be higher, fluctuating between 70°F and 90°F.
- c) In both Delhi and Goa short thunderstorms can be expected.

#### 11. DRESS

- a) In Delhi appropriate day time dress would be as for a good British summer. Although rain is unlikely, folding umbrellas could be a wise precaution against a freak thunderstorm. Account should be taken of the drop in temperature in the evening and woollens/sweaters should be taken. Heavy coats are not needed but the Prime Minister and Lady Howe might wish to bring light coats for evening wear. Formal clothes (dinner jacket, decorations, tiara) are needed by those attending the CHGM Banquet on 23 November but not otherwise. Dress for other social engagements will usually be lounge suit or casual. Casual dress (swimming, tennis etc) should be brought for off-duty wear.
- b) The temperatures in India at this time of year will not be high enough to qualify the UK party for warm climate clothing allowances.

#### 12. ELECTRICITY SUPPLY

The voltage in New Delhi is 220 AC/50 cycles.

#### 13. LIVING ACCOMMODATION





#### CHOGM: Mr. Thatcher

Joy's note about Mr. Thatcher's programme for the morning of 21 November is attached.

It seems perfectly practicable to me for Mr. Thatcher to attend his meeting at Attwoods, but I think a few minor changes to Joy's plans would help things to run even more smoothly.

I would suggest a GCS car is made available to transport Mr. Thatcher to and from his meeting. This avoids his car being left at Attwoods and ensures his arrival at Southside at the correct time. I would hope Bob Rumble (an ex-No.10 driver) would be able to cover this for us. He knows Mr. Thatcher and, more importantly, knows the layout of Heathrow Airport.

I am told Attwoods is actually in Stockley Road (not Stockleigh) and that it should only take 20 minutes to get to Southside. Mike Hall has said that the Prime Minister and Mr. Thatcher would board the plane together some 5 or 10 minutes before take-off (which is at 1400). If Mr. Thatcher leaves Attwoods at 1300, or just after, he should arrive at Southside at 1320 or so. He could then wait in the lounge where coffee is served until the Prime Minister's party arrive.

Alternatively he could delay his departure from Attwoods until 1330 (at the latest) and still be in time for a 1400 hours take-off.

The only other thing I shall have to bear in mind is the luggage, but I would expect that this will all be dealt with on the Monday morning, and in any event will not affect Mr. Thatcher.



#### CHOGM: PROGRAMME FOR MR. THATCHER

You will have seen New Delhi telegram No. 706 but may not have seen Mike Hall's letter of 21 October to me. I think it would be tidier if Mr. Thatcher's programme was dealt with through your office.

I should be grateful if the following points could be conveyed to the High Commission in Delhi:-

- a) Mr. Thatcher would prefer in general that his separate programme should be carried out under High Commission rather than Indian Government auspices. He also hopes that a member of the staff will be able to accompany him on his visits.
- b) of the companies listed in Delhi tel. No. 706 he would be most interested in the MODI Group, Usha Telehoist and Somany Pilkingtons (he has visited Escorts before).
- c) he does not think he can reconcile a visit to Calcutta with the likely requirements of the CHOGM programme. This should be dropped.
- d) if it would be helpful he would be happy to visit the British Council.
- e) Mr. Thatcher will not wish to play golf during the visit.
- f) he would be interested in the visit to the trade fair (para. 5 of New Delhi tel. No. 728).
- g) he does not in the least mind early starts in order to avoid a less rushed programme than would otherwise be possible.

John Holmes to obtain advice on what the Prime Miniser should and should not eat during her visit to India for this years' CHGM. We have now received a reply from our High Commission in New Delhi and if I may will set this out verbatim:-

'It is impossible in India to guarantee avoidance of illness. Usually these are only mild attacks of stomach upset but occasionally something more serious. Bringing bottled water would be a rather extreme precaution since bottled water is available locally, and in any case one cannot guarantee that the glasses, crockery, etc will be germ-free. Water in the major hotels, and of course the Residence, will be safe (filtered or boiled or both). Food and general hygiene in these places will also be good. There are no particular foods or drinks which should be avoided, except that in general spicey food is best avoided (at Indian meals there is invariably a wide choice of dishes)

I am afraid the Doctor will take a dim view of people 'crying-off' at the last minute, so if you have decided not to go through with it please let me know as soon as possible. CHGM: MR THATCHER'S PROGRAMME

- 1. I enclose a copy of New Delhi telegram 728 of 18 October which was sent in response to my telegram on programmes of 13 October (FCO tel 558). A copy of this is also enclosed. I included the paragraph about a programme for Mr Thatcher because I was unaware that you had already sent a personal telegram to the High Commissioner on the same subject.
- 2. I am a little concerned that the High Commission, by informing the Indians of Mr Thatcher's interests (para 4 of the Delhi telegram) might have given them the impression that the GOI will be primarily responsible for Mr Thatcher's programme, could result in a programme which is both onerous and wide of the mark. For example, the Indians might include visits which will demonstrate Indian industrial achievement rather than British activity on the Indian industrial scene, although a little of the former may be of interest to Mr Thatcher. Therefore, if you agree, I propose to ask the High Commission to ensure that they, rather than the GOI, remain in control of Mr Thatcher's programme outside the official CHGM programme.
- 3. Turning to specific programme suggestions in Delhi telegrams 706 and 728 (the former being in answer to your telegram to the High Commissioner), my personal view is that a day visit on 28 November to Calcutta would be very tiring for Mr Thatcher. He will have spent the weekend in Goa (which one hopes would be reasonably restful) but the journey from Goa to Bombay, thence to Calcutta and from there back to Delhi, all in one day, would be very taxing. One also has to bear in mind that Mr Thatcher will

/have



have an overnight flight back to the UK on 29 November. Regarding the visits to industrial firms proposed in Delhi telegram 706, the geographical department's recommendation would be the first two ie the Modi Group and Escorts, the former having the advantage of possibly being able to provide helicopter transport.

Now that both the lunches are to take place after The Queen's departure from India, there is no need for adjustment to take account of any entertainment she may be offering. A simple alphabetical division of delegations produces a good regional balance. I assume that, as in Melbourne and Lusaka, Heads of Delegation unable to accept an invitation on the appropriate day may be offered, if space permits, an invitation for the other day. The result of this juggling may produce a slightly different mix, but is unlikely to disturb the overall balance. We have added also some senior representatives from the Commonwealth Secretariat. Additionally, the Prime Minister might rike Mr Alison and four or five senior officials to be included for each lunch (the Foreign Secretary will of course already have Meft). The officials might include Sir Robert Armstrong, Sir Antony Acland and Sir John Leahy, plus of course Sir Robert Wade-Gery and at least one Private Secretary. This would produce a total of about 32 people for each lunch. Numbers could of course be made up if necessary from the other members of our delegation. If the Prime Minister agrees these proposals, we shall ask our High Commissioners to issue invitations to Heads of Delegations concerned, and will ourselves issue them to those concerned in the Commonwealth Secretariat. You will presumably as usual follow up later with confirmatory invitation cards. 

CHOGM: Prime Minister's Accommodation

Following my letter of 10 October, you told me that the Prime Minister would like Sir Robert Wade-Gery to ask Natwar Singh whether the Indians would have any objection if she and her party were to stay at the Residence during CHOGM.

Sir Robert has now spoken to Natwar Singh (New Delhi telno 713 - enclosed). Briefly, Natwar Singh said firmly that the Indians would have no objection to the Prime Minister staying at the Residence if she preferred to do so. The Residence was conveniently situated, so that there would be little additional security burden. Natwar concluded that staying at Residences was not something he would want every Head of Government to do; but that in our case there seemed little objection. He spoke confidently, and showed no disposition to consult Mrs Gandhi. Sir Robert comments that, so far as the Indian Government is concerned, we can take this as the green light we wanted.

We cannot, of course, rule out the possibility that some Commonwealth Heads of Government might be disappointed at the Prime Minister's absence from the "collegiate" atmosphere of the hotel complex; but, as I noted in my letter of 10 October, the Foreign and Commonwealth Secretary does not regard this as an over-riding consideration.

Should we now plan on the basis that the Prime Minister and her party will stay at the Residence? Sir Robert would like to tell the Indians as soon as a decision has been reached.

THE ONLY POSSIBLE DAY FOR A VISIT TO CALCUTTA SEEMED TO BE 28 NOVEMBER, ESPECIALLY SINCE HE WAS NOT EXPECTED AT THE YUNUS DINNER THAT EVENING. LAMBAH SUGGESTED THAT HE CONSIDER FLYING DIRECT FROM BOMBAY TO CALCUTTA AFTER THE GOA RETREAT, RATHER THAN RETURNING TO DELHI. 5. LAMBAH SAID THAT THE SECRETARY GENERAL'S RECEPTION FOLLOWING THE OPENING ON 23 NOVEMBER WOULD PROBABLY NOT INCLUDE SPOUSES.

THE VISIT TO THE TRADE FAIR AND LUNCH BY THE VICE PRESIDENT ON 24 NOVEMBER WAS NOT INTENDED FOR WIVES, FOR WHOM MRS HIDAYATULLAH WOULD BE ARRANGING A SEPARATE PROGRAMME AND LUNCH. MR THATCHER WOULD PROBABLY BE MORE INTERESTED IN THE TRADE FAIR. WILLIAMS AGREED. GRATEFUL FOR ADVICE ON WHETHER MR THATCHER WOULD LIKE TO BE INCLUDED IN THIS.

#### SECRETARY OF STATE'S PROGRAMME

- 6. WILLIAMS CONFIRMED THAT THE SECRETARY OF STATE WOULD LIKE TO HOST A LUNCH ON 25 NOVEMBER, FOR SOME BUT NOT ALL OF HIS COLLEAGUES. LAMBAH SAID THIS WOULD NOT BE PUT INTO THE OFFICIAL PROGRAMME.
- 7. THE INDIAN FOREIGN MINISTER WOULD PROBABLY BE OFFERING DINNER ON 23 NOVEMBER TO VISITING FOREIGN MINISTERS AND WIVES. THE PLACE FOR THE MINISTERIAL RETREAT WAS STILL NOT DEFINITELY FIXED. IT MIGHT BE JODHPUR (FOR A VISIT ONLY) THEN ON TO STAY OVERNIGHT AT UDAIPUR. UDAIPUR MIGHT NOT BE INCLUDED. THERE MIGHT BE NO OVERNIGHT STAY. THE HOST WOULD BE THE INDIAN FOREIGN MINISTER. PROBABLY ALL VISITING MINISTERS WOULD BE INVITED, NOT JUST FOREIGN MINISTERS (SEMICOLON) BUT NO AIDES AT ALL.
- AGREED THAT THE SECRETARY OF STATE SHOULD PLAN ON TRAVELLING TO EUROPE FROM DELHI ON THE EVENING OF 27 NOVEMBER, AT LEAST UNTIL THE DETAILS OF THE MINSTERIAL RETREAT WERE FIXED.

IN ADDITION TO HIS OTHER ENGAGEMENTS, I RECOMMEND THAT THE SECRETARY OF STATE SHOULD VISIT THE BRITISH COUNCIL IN DELHI (INDIA, AS YOU WILL KNOW, IS THEIR LARGEST OVERSEAS OPERATION, AND THEY ARE ORGANISATIONALLY A DIVISION OF THE HIGH COMMISSION) (SEMICOLON) AND THAT HE SHOULD ALSO HAVE A MEETING WITH DIPLOMATIC SERVICE MEMBERS OF MY STAFF (INCLUDING SECONDEES).

LADY HOWE'S PROGRANME

10, WILLIAMS PASSED ON THE INFORMATION IN YOUR TELNO 588 ABOUT LADY HOWE'S PROFESSIONAL INTERESTS. LAMBAH SAID IT HAD NOT YET BEEN DECIDED WHETHER WIVES OF MINISTERS WOULD BE INCLUDED IN THE PROGRAMME FOR WIVES OF HEADS OF DELEGATION. IT DEPENDED IN PART ON HOW MANY OF THE FORMER ATTENDED. HE ACCEPTED THAT, IF GENERALLY INCLUDED, LADY HOWE MIGHT WISH TO ABSENT HERSELF FROM SOME ITEMS IN THE WIVES' PROGRAMME TO PURSUE PARTICULAR INTERESTS.

NOR HAD THEY YET DECIDED WHO WOULD BE LOOKING AFTER VISITING SPOUSES, EXCEPT FOR MRS HIDAYATULLAH'S LUNCH ON 24 NOVEMBER.

#### GOA RETREAT

15. LAMBAH DENIED A PRESS REPORT THAT TRANSPORT FROM GOA TO THE FORT AGUADA WOULD NOW BE BY ROAD (SEMICOLON) THIS WAS MERELY AN OPTION IF ANY HEADS OF DELEGATION DID NOT WISH TO GO BY HELIC-OPTER. ON PRESENT PLANS ANY OFFICIALS TO STAY AT THE CIDADE DE GOA WOULD HAVE TO TRAVEL SEPARATELY, NOT IN THE SPECIAL AIRCRAFT FOR HEADS OF DELEGATION, AND ON A DIFFERENT DAY. - 1. WE NOTE FROM YOUR TEL 695 THAT THE INDIANS ARE STILL CONSIDERING NOT RETURNING THE HEADS OF DELEGATION TO DELHI FROM GOA UNTIL MONDAY 28 NOVEMBER. NO 10 DO NOT WISH TO MAKE AN ISSUE OF THIS, BUT FROM OUR POINT OF VIEW IT WOULD BE PREFERABLE IF THE PRIME MINISTER WERE NOT SEPARATED FROM SECURE TELEGRAPHIC COMMUNICATION FOR AS LONG AS THREE NIGHTS. GRATEFUL IF THIS COULD BE MENTIONED TO THE INDIANS. IT MAY TIP THE DECISION BACK TO A RETURN ON SUNDAY 27 NOVEMBER.
- 2. THE PRIME MINISTER HAS AGREED THAT IT WOULD BE BEST IF SHE GAVE TWO LUNCHES FOR FELLOW HEADS ON 28 AND 29 NOVEMBER. PLEASE NOTIFY THOSE CONCERNED WITH THE CHGM PROGRAMME.
- 3. WE AWAIT DETAILS OF THE OFFICIAL SPOUSES PROGRAMME BUT WE ASSUME A GOOD DEAL OF IT WOULD NOT BE APPROPRIATE FOR MR THATCHER. #### CHOGM Delegation

You wrote on 25 July to say that the Prime Minister had approved the provisional list of the British delegation which we sent you on 15 July.

We would now like to add one Counsellor to the FCO list. The present Head of Commonwealth Co-ordination department, Alick Goldsmith, is leaving the Department immediately after CHOGM on posting to Hong Kong. His successor, Arthur Watson, who was High Commissioner in Brunei until earlier this year, will therefore be responsible for co-ordinating and implementing whatever action may be required as a result of CHOGM; and Sir Antony Acland believes that he could do this more effectively if he had first-hand experience of the Meeting. It would be very useful for him to get at first hand the feel of a Head of Government Conference and see some of the personalities and the members of the Commonwealth Secretariat in action.

Watson would travel on the Prime Minister's plane, and the only extra expense would therefore be for his hotel accommodation. Perhaps you would let me know if you see any problem about this.

CHOGM As requested in your letter of 5 October, we have asked our High Commissioner for his advice as to how the Indians would react if the Prime Minister and her party were to stay at the Residence. The High Commissioner's response is contained in New Delhi telegram No 683 (copy attached). Briefly, the High Commissioner would personally like the Prime Minister and her party to stay with him. the other hand, he believes that most, if not all, the other Heads of Delegation will stay in the Ashok/Samrat hotel complex, and that for security reasons the Indians would prefer to keep all Heads of Delegation together. He suggests that we should either conclude now that the safest course would be for the Prime Minister to stay in the hotel complex, or that he should seek advice from Natwar Singh, who would in turn almost certainly consult Mrs Gandhi. Quite apart from the Indians, some Heads of Commonwealth delegations might well regret it if the Prime Minister were to stay outside the main complex; but the Secretary of State feels that this need not be an over-riding consideration. Another point to bear in mind is that the space and facilities available for the Private Office would be a great deal less satisfactory at the Residence than they would be in the hotel complex. On balance, the Foreign Secretary is inclined to think that it would be politically safer to opt for the hotel, but it would be perfectly possible to sound out the Indians if the Prime Minister continues to prefer the Residence. CHOGM: Entertainment

In your letter of 13 September you recorded the Prime Minister's agreement to her offering two lunches for Heads of Delegation, on 24 November and 28 November. Unfortunately the Indians have now decided that their Vice-President will offer lunch to all Heads of Delegation on 24 November.

It appears that the only lunchtime or dinner slots not pre-empted by The Queen, the Indians, the Commonwealth Secretary-General or by the visit to Goa are lunchtime on 28 November (which we have secured) and lunchtime on 29 November.

29 November is of course the final day of the Conference, and is thus not ideal. But it is in our view the only practicable proposal. The only real alternative would be a single lunch for all Heads of Delegation on 28 November. But this could be very cramped. The absolute limit for a lunch at the High Commissioner's residence is 46, and even this would involve six guests being squeezed into an alcove. With 43 possible guests - not including Mr Ramphal and his deputies this would leave very little leeway. Another venue would be difficult to arrange and likely to be very expensive.

Accordingly, if the Prime Minister agrees, we would now propose to tell the Indians that the Prime Minister would like to give her lunches on 28 and 29 November.

CHGM 1983, NEW DELHI: ADMINISTRATIVE ARRANGEMENTS

1. I am writing to follow up a number of points which were raised during our meeting yesterday.

# 2. Arrival and Departure in Delhi

Subject to the Prime Minister's approval, we are now planning on Mrs Thatcher arriving in Delhi at 0800 hours local time on Tuesday 22 November which will mean a departure from London at 1400 hours on Monday 21 November. For the return, we agreed that it might be preferable for the VC 10 to arrive at LHR at 0700 hours on Wedesnday 30 November (to avoid commuter traffic, etc) which would mean a departure from Delhi at 2230 hours local time on Tuesday 29 November. For the record the total journey time outward, including a refuelling stop of one hour at Bahrain is 12 1/2 hours. Because of prevailing winds the return journey, also including a stop in Bahrain is 14 hours. The UK will be on GMT and New Delhi on GMT + 5 1/2 hrs

## 3. Accommodation

Commonwealth Coordination Department are seeking the advice of the High Commission in New Delhi on possible Indian reactions to the Prime Minister electing to stay at the Residence, rather than the hotel accommodation, designated for Heads of Government. At the same time we are looking into the practical implications of Mrs Thatcher staying at the Residence, such as whether there is sufficient accommodation for the fairly large No 10 Private Office that is usually needed during these Commonwealth meetings. I should also mention the problem of the RMP having to guard 2 separate locations overnight - a No 10 Private Office at the Residence and an FCO Private Office at the hotel -although this could be overcome by our increasing the RMP team or by our requesting the FCO Private Office to return its papers overnight to the High Commission.



## 4. Goa Retreat

In accordance with the tradition of these Retreat weekends, only the Prime Minister, Mr Thatcher and one other (almost invariably a detective) will be staying at the Fort Aguada Hotel. We have, however, requested 6 rooms at the hotel where the Indians propose to accommodate any support teams which need to be in Goa at the same time. This hotel is the Cidade de Goa and is some 25 minutes by road from the Fort Aguada. We propose that a member of the Deputy High Commission in Bombay is on hand at this hotel in order to assist the party coming down from Delhi.

I would therefore be grateful to know who the 5 members of this party are likely to be. At the last CHGM in Australia in 1981 the following were accommodated at a nearby hotel during the Retreat weekend at the Lakeside Hotel in Canberra:—

On this occasion the party will have to be more restricted (a) because of the limited number of rooms available to us in the Cidade de Goa and (b) because of the limited number of seats we are likely to be allocated on any special flight the Indians might be providing to take support officials from Delhi to Goa.

## 5. Prime Minister's lunches

I mentioned that Thursday 24 November was no longer available for the Prime Minister's first lunch for fellow Heads of Government and we agreed that it was more likely that the Prime Minister would wish to move this lunch to Tuesday 29 November rather than attempt to entertain all Heads at one lunch on Monday 28 November. The latter option carries the risk that if all Heads accepted the Prime Minister's invitation the conditions for the lunch could be somewhat cramped and it would not be possible to provide matching china and cutlery. You asked whether Wednesday 23 November might be a possible date for one of these 2 lunches. The problem here is that the Commonwealth Secretary General is holding a Reception at noon for all Heads of Government on that day and that as this will be the first major social occasion of the Meeting it will, in all likelihood, run on for some time.



# 6. Medical

At your suggestion I am enquiring about the tablets which proved to be such an excellent protection against stomach ailments during the tour of India by the Prince of Wales. We shall shortly be issuing guidance on all in oculation and related requirements.

A transit through a yellow fever zone, however brief, will require a vaccination certificate. 3. 

COMMONWEALTH HEADS OF GOVERNMENT MEETING (CHOGM)

As you know The Queen will be paying a State Visit to India from 17 to 22 November and will also be in Delhi during 23 to 26 November during the first four days of the Commonwealth Heads of Government Meeting. We are already well under way with the planning for the Royal Visit, and it has been agreed that The Queen and the Duke of Edinburgh should dine privately at my house at 8 pm on 22 November. There would be not more than about 30 guests, at least half of whom would be distinguished Indians.

- 2. I have drawn the Palace's attention to the fact that the Prime Minister and Mr Thatcher may already be in Delhi by that time. They have responded that if so The Queen would be delighted if the Prime Minister and Mr Thatcher would like to attend the dinner; but equally that She would of course understand if they would not be free to do so on the evening before the CHOGM opens. I should be grateful if you would let me know whether the Prime Minister will indeed be in Delhi in time for dinner on 22 November; and if so whether she and Mr Thatcher would wish to accept an invitation to dine with The Queen that evening.
- 3. If the Prime Minister were to accept, we would need to consider who else from the CHOGM party (eg the Foreign Secretary and/or Robert Armstrong and/or Robin Butler or you) should also be included. Let me know if the Prime Minister has any views on that, or if you yourself have any advice to offer.
- 4. I should perhaps add that I am leaving it to those in London responsible for CHOGM arrangements to let me know in due course whether the Prime Minister and Mr Thatcher would

wish to stay in the Ashok/Samrat hotel complex (which is being set aside for Heads of Delegations and their closest advisers) or with me. I suspect that the advice may for understandable practical reasons favour the former; but I should of course be delighted personally if the answer turned out to be the latter. Either way, my house is about four minutes drive from the Ashok.

Thank you for your letter of 9 September asking for advice on the Indian proposal that the Prime Minister should present the Bhartiya Jnanpith Award, India's most prestigious literary prize, on the afternoon of 28 November during the Commonwealth Heads of Government meeting in New Delhi.

This is an attractive proposal. Presentation of the Award by the Prime Minister would provide an excellent means of underlining the close relationship between Britain and India. The occasion, which would almost certainly also be attended by Mrs Gandhi, will be a considerable media event attracting extensive press, radio and television coverage, at a time when the Indian media will otherwise be preoccupied with Commonwealth rather than specifically Indo-British affairs. We can confirm Mr Johari's description of the Award and this year's recipient and we recommend that the Prime Minister accept the invitation.

It has been proposed that, on the afternoon of 28 November, the Prime Minister should give a lunch for a number of Commonwealth Heads of Government and thereafter attend the afternoon session of the Commonwealth meeting. We assume, therefore, that the Indians would arrange for the presentation to take place in the late afternoon. At present, no other engagements are envisaged for the Prime Minister at that time.

Dear Mr. Coles,

With reference to our telephone conversation this morning I am giving below some details about the Bhartiya Jnanpith Award, the presentation ceremony of which is to take place in New Delhi on the afternoon of 28th November, 1983.

- The Award is the country's highest and most prestigious in the field of literature and was instituted in 1965. The Award is made annually with the twin objectives of shouldering the cardinal national responsibilities of rediscovering the neglected treasures of Indian phylosophy and of encouraging original creative writing in 15 Indian languages. The Award carries a cash prize of Rs.150,000/- (approximately £10,000/-). This year's recipient is Mrs. Mahadevi Verma who is a very distinguished and eminent poetess in the Hindi language. She is now 76 years old and is the last surviving member of the Romantic School of Hindi poetry. She has been chosen for this honour for her distinguished work "Yama", a collection of outstanding poems which was first published in 1939 and the Fifth Edition of which was brought out in the late 70s. A special feature of the collection is the beautiful illustrations painted by Mrs. Mahadevi Verma herself.
- 3. As I had mentioned on the phone it is customary for either our President or Prime Minister to give the Award. However, since this year the ceremony is happily coinciding with the Commonwealth Heads of Governments meeting in New Delhi, my Government has made the suggestion which I mentioned on the phone.

Commonwealth Heads of Government Meeting (CHOGM) 1983:

## Entertainment

I should be grateful for your advice on what hospitality the Prime Minister will wish to offer her fellow Heads of Government/delegation at the CHOGM later this year (23 - 29 November) in New Delhi. We shall not be able to consider what bilateral meetings should be arranged for the Prime Minister (and what informal hospitality might thereby be entailed) until we have information about which Heads of Government and Foreign Ministers will be attending. However, we need to take a decision in principle now on the general form and extent of any formal group entertainment the Prime Minister might offer in order to reserve appropriate slots in the schedule of entertainment which the Indian organisers are already compiling.

There are three broad options. The first is that the Prime Minister should offer no hospitality whatsoever. But the absence of British hospitality would constitute a sharp break with precedent and might be interpreted as indicating a diminution of enthusiasm for the Commonwealth. Past practice has been that the Prime Minister has offered a formal meal to all colleagues, even when not acting as host to the meeting.

The second option is that the Prime Minister should entertain selectively. This would be more flexible and need not be pre-arranged. The main disadvantage is the difficulty of being selective without causing gratuitous resentment.

The third option is that the Prime Minister should entertain all her colleagues. This is what she did in both Lusaka and Melbourne. The obvious disadvantage of this course is the expense but this should not be as great as in Melbourné.

The third option is the one we recommend: that is, two separate lunches taking in all Heads of Delegations, whether Heads of Government or not, without spouses. If the Prime Minister agrees with this recommendation, we suggest that we aim for Thursday, 24 November and Monday, 28
November. We could invite half the Heads of Delegations, split alphabetically, to each lunch, together with a number of senior Commonwealth Secretariat officials and a small British element in support. Both lunches would be given in the High Commissioner's house.

Sir Geoffrey Howe would also, in accordance with precedent, undertake some (selective) entertainment of his colleagues, in particular those with whom he will not have a substantive bilateral meeting.



Commonwealth Heads of Government Meeting (CHOGM): New Delhi 1983

It is time to consider the composition of the British Delegation to the Commonwealth Heads of Government Meeting (CHOGM) in New Delhi from 23 to 30 November. We have drawn up the enclosed provisional list which also takes into account the findings of the recent reconnaissance visit to India by a team from the FCO Protocol and Conference Department and by Leslie Wright of the Cabinet Office. As it stands, the delegation numbers 58 as compared with 67 for Melbourne in 1981.

As far as senior officials are concerned, the composition of the team has to take account of the likely shape of the agenda which the Commonwealth Secretariat expect to issue in draft in late Septebmer. But I think we can be certain that developmental issues and Southern Africa (in particular Namibia and sporting contacts) will feature prominently. I am sure that it would also be helpful, as in 1981, to have someone from the Overseas Development Administration. We have also followed the 1981 precedent by including the Chief Political Correspondent from the COI.

The numbers of communications and security staff will be smaller than those for our delegation to Melbourne, since we will be able to use staff from the High Commission in New Delhi - a much larger post than the Consulate-General in Melbourne. On the other hand, the High Commission will not be able to provide as much clerical and secretarial support as was provided at Melbourne by the Canberra High Commission. So the extra staff will have to be flown out from Britain.

Since both the Prime Minister and the Foreign and Commonwealth Secretary will need to maintain close contact with London, the three communications officers shown will be needed to reinforce the existing team in the High Commission. The Royal Military Police detachment will provide safe-hand services and guard the delegation offices during the night: we are planning to take four fewer than in 1981, since High Commission staff will be able to take on some of these duties.

? Unless your or No 10 see objection, we shall work on this basis for the time being.

Foreign Ministers will not be assigned liaison or security officers, their cars will not be radio controlled and as matters stand they will receive little preferential treatment on arrival or deparature at Delhi Airport. All this is in keeping with what occurred during the NAM which was perhaps understandable given the limited resources of the Indians and the fact that there were well over 100 countries participating, but it is less appropriate in an organisation with only 40 or so member countries. However steps are being taken to warn the Commonwealth Secretariat about this potential problem and we hope generally that they will put the Indian organisers on to the right lines regarding the requirements and character of a CHGM.

# CONFERENCE SITE

- 3. The Conference sessions will take place in the Vigyan Bhavan, the GOI Government Conference Centre. This is a somewhat undistinguished building with gloomy interiors and here again one detected a wide gulf between the arrangments for the Heads of Government and those for the remainder of each Delegation. Extensive areas will be reserved for the Heads while comparatively little accommodation will be accessible to others. However the rooms designated for working groups at official level are large and well equipped. The opening ceremony of the CHGM will also take place in a large auditorium within the Vigyan Bhavan complex. One possible problem identified was that the Indians appeared to have made little or no provision for communication between Senior Advisers and Heads/Ministers during meeting sessions and an attempt was made to persuade them to introduce more flexibility in this regard.
- 4. Each Delegation is being allocated one very small office measuring no more than 15' x 15' which at certain times could present our Delegation with a severe problem of congestion. The allocation of one room per Delegation is however within the CHGM tradition and practice. Only communal photocopiers will be available 3 per floor.

#### LIVING ACCOMMODATION

5. The Indians are proposing to accommodate all Heads of Government and Ministers in a pair of inter-connecting hotels owned by the Government of India. These 2 hotels are the Ashok and the Samrat and are located very close to the

British High Commission. Each Delegation will be allocated one large suite, one smaller suite and 12 ordinary rooms, (one designated as an office). Both these hotels have disadvantages for which our Delegation should be prepared. The Ashok was built some 20 years ago and is showing distinct signs of age while the Samrat is not yet complete and therefore teething troubles can be expected. We do understand however that efforts are being made to give the Ashok a face lift and to ensure that all systems such as telephones, plumbing etc are in good working order by November.

6. Five hotels in the vicinity of the British High Commission and the Ashok/Samrat were visited with a view to finding accommodation for the balance of the UK party, and it was decided to book the bulk into the Maurya Hotel, which is part of the Sheraton Group. Ten rooms were booked at the Claridges Hotel for the RMP team and 15 rooms at the Taj Palace Hotel for the RAF aircrew. The Maurya has established a good reputation for efficient service, comfortable rooms and a broad range of cuisine and all this was borne out by our inspection visit.

#### WORKING ACCOMMODATION

7. The Private Offices of the Prime Minister and Foreign Secretary will in the usual way have to be set up in the Ashok/Samrat. However after careful consideration it was decided that the best location for the offices of the Delegation Secretariat, the Senior Advisers and the Administrative support would be in a suite of offices in the British High Commission (which is just over the road). There were three major reasons for arriving at this conclusion. First, the rooms in the Ashok are arranged in an unusual way: all suites are grouped together: as are all single and double rooms. Thus the more offices we have in this huge hotel the more likely they are to be scattered throughout it. Second, the more offices we put into the Ashok the fewer senior advisers and other key support staff will be able to stay there. Third, in siting our offices within the High Commission they would be close to the essential services it can provide, such as communications, transport etc. There would be sufficient accommodation for the Cabinet Secretary to hold his daily morning meetings in the High Commission building. Also given the inadequacy of the office accommodation at the Conference Centre, it is anticipated that much greater use than usual will be made of these offices. Overall they are far more likely to funtion well in one of our Diplomatic posts than in an hotel.

CONFIDENTIAL

#### PRESS ARRANGEMENTS

8. Mr Bruce Cleghorn, First Secretary (Information) in the High Commission, who accompanied us on all visits and calls, has reported in some detail about the proposed press media arrangements for the meeting (see his letter of 15 June to Mr Kydd of the No 10 Press Office) but a summary of the relevant principal locations may be useful. The main facilities for the press will be located in a Media Centre in an annex to the Vigyan Bhavan. The main briefing hall seats about 200 but it would not be possible to exclude non British journalists from briefings held here. A more suitable venue, if British only briefings were required, might be the Recreation Hall at the British High Commission. Two hotels have been designated for the press accommodation the Kanishka and the Janpath. A suite, which will double as a briefing room and an office, has been reserved at the Kanishka for Mr Kydd. It is envisaged that Mr Ingham will have a room at the Ashok Hotel but that he will use Mr Kydd's suite at the Kanishka for informal briefings of the British press. As a fallback position, a suite has also been booked at the Maurya Hotel in case the rooms allocated to the UK at the Ashok are not as anticipated.

# 9. SECURITY

Colonel Durrant of PCD has written a separate detailed report on the Indian security arrangements for both Delhi and the retreat weekend in Goa. Indian thinking in this area is still strongly influenced by their arangements for the NAM which tended to be on a large and restrictive scale. Again this was understandable given the number of delegations taking part and the many cases of mutual suspicion and antipathy between delegations. It is to be hoped that the arrangements for CHGM will be scaled down to an appropriate level. Sources of concern at present are possible restrictions on access to the Ashok/Samrat complex by those delegates not staying there and an overrigid separation between Heads of Government and their advisers at the Vigyan Bhavan. These concerns are however being conveyed to the Indian Government via the Commonwealth Secretariat and there is optimism that in the event a reasonable compromise will be reached. As Colonel Durrant has recorded, only the Prime Minister will be assigned an armed Indian protection officer but the Indians did say they would be prepared to assign one to the Secretary of State also, should a threat of any significance be brought to their attention.

#### COMMUNICATIONS

10. Here again a detailed separate report is being submitted; in this case by Mr Wright, Head of communications at the Cabinet Office. He has identified the points in Delhi where both direct lines and private wires to London will be located, as well as the positions of base stations for a radio network, the latter to be used primarily for administrative purposes, although the Special Branch officers accompanying our Ministers will have access to it. The main communications problem arises over the Retreat weekend in Goa where a combination of distances between hotels linked by winding roads and an inadequate existing telephone system could cause difficulties. On present planning a secure link telephone will terminate in the room of the aide accompanying the Prime Minister to Goa.

11. For its telegraphic traffic with London and elsewhere, the Delegation will be using the Communications Centre of the British High Commission, whose staff will be reinforced to provide the necessary 24 hour cover while our Ministers are in India.

# ARRANGEMENTS AT DELHI AIRPORT

12. Here again the proposed arrangements bear the imprint of the NAM precedent. The Indians propose that only the Heads of Government will be met by limousines at the end of the aircraft steps while all other delegates, including Foreign Ministers, will proceed by airport bus to a VIP lounge in a new terminal building whence they will then walk through the building to embark in a motorcade. Between now and November, efforts will be made to negotiate a somewhat more dignified reception for Foreign Ministers. We shall also try to ensure that it will not be necessary for each member of our party to personally present their passports and personally identify and remove their baggage.

#### TRANSPORT

13. The Indian Government will provide each Delegation with one Mercedes for the Head of Government, a second Mercedes for the spouse of the Head of Governmenet, one chauffeur driven Ambassador car (an Indian vehicle, based on the 1953 Morris Oxford) for Foreign Ministers and one other chauffeur driven Ambassador car for the use of one or two other senior members of the Delegation. For the rest of the UK party's transport needs a combination of British High Commission

allocation of cars will shortly be sent to the British High Commission.

# ENTERTAINMENT

14. If the pattern of previous CHGM'S is followed, the Prime Minister is likely to give 2 lunches for her fellow Heads of Government and/or possibly spouses and Foreign Ministers and again if past practice is followed, it is likely that the Residence of the British High Commissioner will be used for the purpose. The Residence was visited by the recce team and while the dining room would appear to be too small for these functions, a set of tables set out on the horseshoe-shaped veranda appeared to be an attractive solution.

#### FINANCE

15. The High Commission did not see the need for any extra funds to be drafted to their account to meet the expenditure arising out of CHGM, estimated at £50,000 to £60,000. They have nominated Mr Ian McDonald to act as accountant to the Delegation and detailed charging instructions for all items such as car hire, subsistence, accommodation etc will be forwarded to Mr Reed, Head of Adminstration in the BHC.

## RETREAT WEEKEND IN GOA

- 16. The London recce party accompanied by staff from the British High Commission, New Delhi and Deputy High Commission, Bombay called on the Lt Governor, the Chief Secretary, and the Inspector General of Police in Goa in order to discuss arrangements for the Retreat. They also visited the principal sites involved in the Retreat.
- 17. The Head of Government, their spouses and aides will be accommodated in the Fort Aguada Beach Hotel which occupies an impressive position overlooking an old Portuguese Fort and a long wide beach. New chalets are being constructed on the hill above the Hotel and some Heads may be located there. In the adjacent Taj village complex, about a 5 to 10 minute walk away, members of the Commonwealth Secretariat and GOI support staff will be accommodated. The whole of this area will be sealed off by the security authorities. The Heads will transfer from Dabolim Airport to the Fort Aguada by helicopter, a journey which by car takes a good hour along narrow winding roads. The Indians have also made block bookings at the Cidade de Goa Hotel for Advisers and other delegates who may be needed to be in Goa, and at the

block bookings at the Cidade de Goa Hotel for Advisers and other delegates who may be needed to be in Goa, and at the Hotel Fidalgo for any press who may be covering the retreat. These hotels are approximately 25 and 30 minutes drive respectively from the Fort Aguada. No alternative suitable accommodation is to be found any nearer than this to the Fort Aguada, and if we have a number of senior advisers in the Cidade de Goa round the clock transport will need to be on hand.

- 18. It was recognised that given the infrequency of flights between Bombay and Goa, and the unreliability of the telephone system, there was little role for the DHC in Bombay during the Retreat. It might however be valuable for Mr Morris of DHC Bombay to be present in Goa to assist those staying at the Cidade de Goa.
- 19. One difficulty will be the travel to and from Goa of any British support staff. The journey by scheduled services involved changing aircraft in Bombay and from door to door takes the best part of the day, a period of time which Private Secretaries and security officials in particular will not be able to afford. A request is therefore being made to the Indians for the provision of a second special aircraft to fly direct from Delhi to Goa, possibly also taking press representatives.
- 20. Press coverage of the Retreat is likely to be confined to a photo call carried out by a pool of press/cameramen.
- 21. As to the programme of the retreat, the Indians intend to organise an excursion for the Heads by river launch to see what remains of old Goa, the former capital of the territory. There will also be recreational facilities such as swimming, clock golf, etc. For the last day there is a proposal that the Heads lunch at the Residence of the Lt Governor. It is very much hoped that this is arranged since the Lt Governor himself is a delightful personality with a keen interest in the environment and conservation and his Residence is a beautiful old Portuguese colonial mansion commanding superb views of the coast. The grounds are equipped with a helipad.
- 22. The Indians indicated that they were also arranging Retreat weekend excursions for Foreign Ministers to Udaipur and for senior officials to Jaipur or Agra. Confirmation of these plans is awaited.

# 23. MEDICAL

It has to be recognised that a good proportion of all new arrivals in India will succumb to some form of stomach complaint within the first few days. This happened in varying degrees to all members of the recce party. It is therefore indeed fortunate that the British High Commission has its own hospital on compound, staffed by a British doctor and a team of nurses. Given that the total British party going to India for CHGM could number about 70 including the RAF aircrew, the medical team have been alerted that the demand on their services in the early stages of CHGM at least could be high.

# 24. OFFICE EQUIPMENT AND SUPPLIES

The High Commission will be able to meet many of the Delegations requirements for stationery, office furniture, duty-free liquor etc. Where they are unable to do this the supplementary supplies will be sent from London. The main problem arises over photocopiers, 4 of which were innitially requested for various parts of the Delegation. However, with the cost of hiring a photocopier in India running at £200 per day we may need to consider reducing this number to 2: one Rank Xerox 3107 machine to be shared by the 2 Private Offices in the Ashok Hotel and one to be located in the Delegation Secretariat in the High Commission building. This will still mean a bill of about £5,000 for a 10 day period including the cost of paper and a round the clock service cover. The cost of purchasing one of these machines in India is about £7,000. Bringing photocopiers out in the VC10 will also be considered but experience has shown this to be an unsatisfactory solution since these machines do not travel well.

#### COMPOSITION OF THE UK DELEGATION

25. The Indian Government have requested the names and numbers in each delegation, together with 2 photographs of each delegate, measuring 35 mm  $\times$  45 mm, to be submitted to them by 31 August. As many UK names as possible will be forwarded by this date.


I am sorry to trouble you with a trivial matter, but it would be helpful to settle a particular question finally. At the end of last year the British High Commission in New Delhi wrote to us to ask whether the High Commissioner's Rolls Royce Silver Wraith, due for replacement this year by a Rolls Royce Silver Spirit, should be kept on for use during the CHGM, although doing so would result in the probable loss of some £3600 in the selling price.

We replied that the Wraith should not be kepton, particularly if doing so would result in such a substantial drop in the selling price. We also said that the provision of transport for Heads of Government at CHGM Meetings was a host Government responsibility and that if the British Prime Minister were to be the only Head using a Rolls Royce it could invite unfavourable comment. We would therefore recommend that other things being equal she should be seen to be using the same facilities as her fellow Heads of Government. At Lusaka in 1979 and at Melbourne in 1981 the Prime Minister used cars provided by the Zambians and the Australians. A further argument put forward by the High Commission was that the Wraith is bullet-proofed, but again it was pointed out that the provision of any specially secure vehicles on these occasions is still the responsibility of the host Government.

Although the High Commission appeared to accept this verdict, a recent visitor to Delhi has reported that they are still anxious on this point. Could you therefore confirm that the Prime Minister will not wish to have different transport arrangements from the rest of her fellow Heads of Government?



CHOGM 1983: Weekend Retreat in Goa

You have asked for advice about the possibility of the Prime Minister spending the weekend of the CHOGM retreat visiting a part of India which she does not know. I gather that the Prime Minister has expressed some doubts about whether it would be right for her to attend the retreat, which will be in Goa, because it might appear to condone the Indian use of force in seizing Goa from the Portuguese in We have discussed this with the High Commission in New Delhi, but have not of course spoken to the Indians.

Our High Commission could undoubtedly arrange a useful and interesting programme for the Prime Minister in a part of India which she does not know. Sir John Thomson - whom we were able to consult on his return to London - believes that, if the Prime Minister were to carry out such a programme instead of attending the retreat in Goa, the Government of India would be likely to take serious offence and there would be widespread criticism in the Indian press. A decision by the Prime Minister not to attend the retreat would also of course disappoint the Prime Minister's Commonwealth colleagues (some of whom would no doubt express their disappointment publicly). To ask the Indians now to change their plans about Goa or to warn them now that the Prime Minister might at the time feel unable to go there, would be bound to arouse Indian resentment, without achieving any positive result.

In practice, there are very real differences between Goa and the Falkland Islands. In particular:

Geographical and historical a.

> Goa is part of the Indian mainland. Its population was predominantly of Indian ethnic origin and prior to its acquisition by Portugal (1510) it had been governed by Indian rulers.

b. Legal

> By a treaty with India of 31 December 1974, Portugal has formally recognised Indian sovereignty over Goa and over the other four former Portuguese enclaves in India. The Portuguese Foreign Minister went to Goa during a

visit to India in November 1981, and this was seen as marking the end of any residual ill-feeling about Goa between the two countries. We extended de jure recognition in 1975, when our Deputy High Commissioner in Bombay paid an official visit to Goa. Since then a number of British officials, including successive High Commissioners, have been there.

In the light of these considerations, Mr Pym considers that the Prime Minister should attend the weekend retreat in Goa. To do otherwise could impose serious strains on the atmosphere of the Meeting; would certainly cause offence to the Indians, and might well affect the atmosphere for the bilateral State Visit by The Queen which will precede the opening of the Heads of Government Meeting.

Commonwealth Heads of Government Meeting (CHGM): New Delhi

I enclose a circular letter from the Commonwealth Secretary-General conveying to Commonwealth Heads of Government a proposal from the Government of India that the next CHGM should take place in New Delhi from 23 - 30 November 1983.

Unfortunately the Greeks, who will be occupying the Presidency at the time, have just proposed a meeting of the European Council for 28 and 29 November 1983. However, in view of the number of governments involved in CHGM (43) and of the fact that Mr Ramphal put his proposal in first, Mr Pym hopes that the Prime Minister will agree to accept the dates now proposed for CHGM. We would then tell the Greeks that the dates they have proposed for the European Council would not be possible for us. (Our Embassy in Athens have already indicated to them that this is likely to be the case.)

It was widely felt after Melbourne that a full wekk for CHGM was too long. We have it in mind to use the forthcoming meeting of Commonwealth Senior Officials (Tanzania, early December) to press for shorter, more businesslike and more productive CHGMs, and shall be hoping to enlist Mr Ramphal's support. There would be no harm in the Prime Minister indicating this to Mr Ramphal, who told Sir Michael Palliser and Sir Antony Acland earlier this year that he would favour a shorter meeting in 1983.

The Palace are aware of the dates proposed and have indicated that they are happy with them. They are of course subject to agreement by Commonwealth Heads of Government before becoming firm.



# Next Commonwealth Conference

We discussed the problem of the weekend retreat in Goa.
May I pursue this a little further.

If we are to attempt to change Indian plans to hold the weekend retreat in Goa, it would be better to do so now rather than have a row nearer the time. But my own feeling is that we should not make an issue of it. The Indian occupation of Goa was thoroughly objectionable but it is now well in the past. I doubt if other Commonwealth countries, even Guyana or Belize, will make an issue of attending the weekend retreat if it is held in Goa.

The Commonwealth Secretary General is already aware of your views (and I have no doubt that he will let others know them as well). But I understand that he feels that Indian plans are too far advanced to be challenged now. You may like to have a word with him during your lunch for Mr. Seaga on Monday. It would be helpful to have guidance thereafter as to whether you want any action to be taken with the Indians.


