



SUMMARY

1. GENSCHER (PRESIDENCY) AND DELORS (COMMISSION) EXPLAINED THEIR THINKING ON FAMILIAR LINES. GENERAL AGREEMENT THAT INTERNAL MARKET (REVIEW AND PRIORITIES), THE SOCIAL DIMENSION AND MONETARY DEVELOPMENTS WOULD BE THE MAIN COMMUNITY SUBJECTS. COMMISSION TO REPORT ON ECONOMIC AND SOCIAL SITUATION AND BLACK ECONOMY. DELORS MENTIONS CRIME CONTROL AND DELINQUENCY, CITIZENS EUROPE AND ENVIRONMENTAL POLICY AS OTHER POSSIBLE SUBJECTS.

DETAIL

- 2. GENSCHER SAID THAT HANOVER SHOULD LOOK AT THE PROSPECTS FOR EUROPEAN INTEGRATION IT SHOULD SET PRIORITIES FOR THE MEDIUM TERM FOR THE INTERNAL MARKET, FOR THE SOCIAL DIMENSION, WHICH WOULD FIGURE UNDER THE GREEK AND SPANISH PRESIDENCIES, AND FOR MONETARY MATTERS: ON THIS LATTER AREA THE PRESIDENCY WOULD INFORM MEMBER STATES IN GOOD TIME OF THE INITIATIVES THE PROPOSED. ON THE ECONOMIC AND SOCIAL SITUATION, THEY EXPECTED THE COMMISSION TO GIVE AN ORAL PRESENTATION. THE CHANCELLOR WOULD REPORT ON THE ECONOMIC SUMMIT. POLITICAL COOPERATION WOULD BE DONE BY FOREIGN MINISTERS OVER DINNER AND TAKEN UP BY THE EUROPEAN COUNCIL THE NEXT MORNING. THE CHANCELLOR WOULD SEND A LETTER TO HIS COLLEAGUES ON 23 JUNE SETTING OUT HIS VIEWS ON SUBJECTS FOR DISCUSSION.
- 3. DELORS (COMMISSION) SAID IT WAS IMPORTANT FOR THE COUNCIL TO RESOLVE THE REMAINING PROBLEMS ON FUTURE FINANCING IN THE COURSE OF TOMORROW. ON THE INTERNAL MARKET PROGRESS UNDER THE GERMAN PRESIDENCY ON 3 KEY DIRECTIVES MUTUAL RECOGNITION OF DIPLOMAS, LIBERALIZATION OF CAPITAL MOVEMENTS AND ROAD TRANSPORT PLUS A PACKAGE AT THE INTERNAL MARKET COUNCIL WOULD BE A VERY POSITIVE SIGN. HE SUPPORTED THE IDEA OF PREPARING A TIMETABLE OF INTERNAL

PAGE 1 RESTRICTED MARKET PRIORITIES UP TO THE END OF 1992 IF THE GREEK, SPANISH AND FRENCH PRESIDENCIES AGREED. THIS SHOULD PICK OUT STRATEGIC PRIORITIES. IT WAS ALSO NECESSARY TO SEND A POLITICAL SIGNAL TO WORKERS AND EMPLOYERS THAT WHAT WAS BEING DONE TO IMPLEMENT THE SINGLE EUROPEAN ACT WOULD NOT INCREASE UNEMPLOYMENT. THERE WAS PROVISION FOR TAKING UP THESE MATTERS UNDER ARTICLES 117, 118A AND 118B. BUT IT WAS NOT NECESSARY FOR THE HEADS OF STATE TO DISCUSS THIS IN DETAIL. ON MONETARY DEVELOPMENTS THE COMMISSION HAD STUDIED THE VARIOUS IDEAS WHICH HAD BEEN FLOATED BY INDIVIDUALS AND GOVERNMENTS. THE ULTIMATE GOAL OF ECONOMIC AND MONETARY UNION AND THE COMMON CURRENCY WOULD TAKE TIME. EXPERTS NEEDED TO DISCUSS DETAILED QUESTIONS INCLUDING THE ROLE OF THE ECU AND HOW TO MANAGE A COMMON CURRENCY.

- 4. THESE 3 ISSUES (INTERNAL MARKET, SOCIAL MATTERS AND MONETARY DEVELOPMENTS) SHOULD BE DISCUSSED ON THE FIRST AFTERNOON. THERE WOULD BE A DOCUMENT ON THE ECONOMIC AND SOCIAL SITUATION BUT HE WOULD ALSO MAKE AN ORAL PRESENTATION WHICH WOULD GO FURTHER. HE WOULD TALK ABOUT THE BLACK ECONOMY AND UNEMPLOYMENT STATISTICS. OTHER POSSIBLE SUBJECTS INCLUDED PEOPLE'S EUROPE AND QUESTIONS ARISING FROM DISCUSSION IN THE POMPIDOU AND TREVI GROUPS ABOUT CRIME CONTROL AND DELINQUENCY. SOME HAD ALSO SUGGESTED THAT THERE SHOULD BE A REPORT ON ENVIRONMENTAL POLICY.
- 5. SOLBES (SPAIN) SAID IT WOULD BE HELPFUL TO KNOW MORE PRECISELY WHAT THE PRESIDENCY HAD IN MIND FOR THEIR PRIORITIES FOR THE NEXT THREE PRESIDENCIES. EACH EUROPEAN COUNCIL SHOULD CONSIDER WHAT REMAINED TO BE DONE BY 1992. FRAU ADAM-SCHWAETZER SAID SHE ACCEPTED THAT SUCCESSIVE PRESIDENCIES MUST WORK TOGETHER.
- WHICH NEEDED TO BE DISTINGUISHED: MEASURES TO BE AGREED BY THE TIME OF HANOVER INCLUDING LIBERALIZATION OF CAPITAL MOVEMENTS, MUTUAL RECOGNITION OF DIPLOMAS AND ROAD TRANSPORT: THE AGENDA UP TO 1992: AND PRIORITIES FOR RESOLUTION IN THE NEXT 18 MONTHS. I EXPLAINED THE PRIORITIES THE PRIME MINISTER HAD SET OUT IN HER REPLY TO CHANCELLOR KOHL. ON MONETARY DEVELOPMENT I EMPHASIZED THE IMPORTANCE OF CARRYING FORWARD THE IMPORTANT PRACTICAL STEPS OF THE LAST YEAR. WE WOULD LIKE TO SEE: GREATER USE OF THE PRIVATE ECU, STRENGTHENING THE BALANCE OF THE SYSTEM BY SHIFTING THE WEIGHT OF INTERVENTION MORE TO COMMUNITY CURRENCIES AND LESS TO DOLLARS, AN INCREASE IN CROSSHOLDINGS OF CURRENCIES BY EC MEMBERS AND GREATER BALANCE IN INTERVENTION ARRANGEMENTS. WORK ON IDEAS FOR THE FUTURE SHOULD BE DONE BY THOSE WITH EXPERTISE. ON THE SOCIAL DIMENSION I AGREED WITH

PRIME MINISTER'S ATTENDANCE AT THE EUROPEAN COUNCIL MEETING, HANOVER 27-28 JUNE 1988

I am writing to confirm details of the Prime Minister's forthcoming visit to Hanover for the European Council.

The Party will arrive in Hanover on the morning of 27 June and will be accommodated in the Hotel Intercontinental, where a Private Office will be set up in Suite 745. The Private Office will be manned by a Duty Clerk, Mr D Kerr and a Garden Room Girl, Miss M Jelley. Both are Gamma briefed, cleared for access to Category III material and will act as COMSOs at all times for the duration of the visit.

There will be a 24 hour Communications Centre situated in the hotel. It will provide a fully secure telegram service, and secure facsimile equipment will be available, which can be used for material of any classification to allow texts to be exchanged directly with 10 Downing Street.

A second Private Office will be set up at the <u>Messegelande</u> with the Prime Minister's party alternating between the two, depending upon where the Prime Minister is at the time. BRAHMS secure speech equipment will be available at both.

As usual, conference related intelligence material will be selected by the Foreign and Commonwealth Office while threat related intelligence material should be sent to us for passing to 10 Downing Street, who will decide whether it should be forwarded to Hanover. Any Comint material which may be sent will be securely locked overnight in the Private Office at the hotel, which will be manned during the silent hours by the Royal Military Police. A safehand service will operate when necessary between the two Private Offices.

We would strongly advise keeping a DTI representative on the delegation. Although there may not be detailed discussion of current single market issues, securing the right list of future single market objectives will be a major concern and we believe that DTI expertise will be necessary. We accept that a MAFF representative will not be essential on this occasion. We also strongly recommend keeping the PA to the Head of News Department on the list. As you know, she does not go to the European Council simply to work as PA to the Head of News Department, but to help organise press briefings on behalf of both Bernard Ingham and Christopher Meyer. She has an important job, on behalf of both of them, in typing up material for the press briefings, doing transcripts etc. In between these activities she is also available to do work for other members of the delegation. We believe our press operation would be handicapped without her. David Hannay and Roger Lavelle agree with these recommendations. I enclose a revised delegation list. As you know, the Prime Minister believes that delegations should be kept as small as possible. In that context I note that EQS(88)5 paragraph 8 judges that detailed negotiation on the internal market package at Hanover is judged unlikely (although not impossible). 
