



PRIME MINISTER'S VISIT TO NEW YORK: 29 SEPTEMBER - 1 OCTOBER

Thank you for your letter of 20 September about the Prime Minister's programme during her visit to New York. I have now had an opportunity to discuss this with her and would be grateful if the following arrangements could be made.

Children's Summit

The Prime Minister has noted the proposed arrangements. She will attend the informal dinner on the Saturday evening, the morning session on the Monday and the concluding session. But she will probably not go to the lunch or the afternoon working session on the Sunday, to leave more time for bilaterals and other engagements.

President Bush's Speech

The Prime Minister will attend the President's speech to the General Assembly on the Monday morning.

Bilaterals with President Bush

The Prime Minister accepts with pleasure the President's invitation to a working dinner on the Sunday evening. But she would like the first half hour to be a very restricted meeting, attended only by the President, herself, General Scowcroft and I will reinforce it with Scowcroft when I get back to London.

I think the Prime Minister would be happy with the agenda proposed by the Americans, and I should be grateful if briefing could be prepared on this basis. But in practice I agree that they are unlikely to get much beyond the Gulf.

Other Bilaterals

The Prime Minister confirms that she definitely wishes bilaterals with President Ozal, the Amir of Kuwait, Prime Minister Mulroney, Prime Minister Kaifu, President Salinas, the United Nations Secretary General and Prince Bandar. These should be given priority, filling the available time in the Prime Minister's programme on the Sunday and Monday.

Any other bilaterals can only be fitted in if there is still time when other engagements have been arranged. Those whom the Prime Minister would agree to see in these circumstances are, in order of priority:

King Hussein (if present)
Miss Charles
Mrs Chamorro
President Collor
President Gaycom
President Aylwin
President Mugabe
President Zehlev

But the Prime Minister would hope to be able to chat to some of these briefly in the margins of the reception and dinner on the Saturday evening, rather than have full bilaterals.

The Prime Minister would, of course, be happy to have a talk with the Foreign Secretary on the Monday morning.

Other Engagements

The Prime Minister agrees that it is simply not feasible to address the Foreign Policy Association. Before deciding on the Hans J Morgenthau award from the National Committee on American Foreign Policy, she needs to know whether any sort of speech is required. If not, she would be happy to receive it on this occasion: but if a speech is needed, then she would prefer to postpone it until some other time. I should be grateful if you could establish this for me.

The Prime Minister would be content to use one hour on Monday for a discussion with the Wall Street Journal Editorial Board. This could be either during the day or at lunchtime. But she would not want it to be a proper lunch, just a session of no more than one hour around a table, with sandwiches if at lunch time.

The Prime Minister would be very happy to receive the special gift from the group of children organised by Albina de Boisrouvray at some appropriate point in the programme.

Prime Minister's visit to New York: 29 September - 1 October

Thank you for your letter of 16 September about the Prime Minister's visit to New York. I enclose the most recent list of those Heads of State or Government who have said they will attend. I also enclose the latest draft outline of the Prime Minister's programme.

The White House have proposed that President Bush's working dinner with the Prime Minister on 30 September should run from 1930-2100 hrs in the President's suite at the Waldorf. Participation will be "Principals plus one or so" and they expect our team again to include Sir Antony Acland. In addition to the Gulf in all its aspects (including Arab/Israel and Iran), the Americans suggest that the talks cover CFE/CSCE linkage; the Soviet Union; Cambodia; the non-circumvention issue in START; the Uruguay Round and US/EC relations in that connection; South Africa; Vietnamese boat people; and the environment. They see no grounds at this stage to include other Alliance issues or German unification. In practice, we expect most of the time to be devoted to the Gulf. On that basis, the suggested agenda seems right (although the order is odd).

We shall go ahead with the arrangements for the bilaterals with President Ozal, the Amir of Kuwait, Prince Bandar and Prime Ministers Kaifu and Mulroney. Presidents Mitterand and Mubarak and Dr Mahathir have pulled out of the Summit.

As for other bilaterals the Prime Minister will no doubt wish to concentrate on Gulf issues. We are checking seperately to see which other Heads of the Gulf / States will be in New York. Apart from that I enclose a list of other possiblities. Meetings with the Presidents of Chile and Brazil would be particularly useful.

Since the Prime Minister and the Foreign Secretary will both be having bilaterals in New York, the Foreign



Secretary thinks it would be useful if they could meet for a talk. The Foreign Secretary is due to arrive in New York on Monday 1 October in time to hear President Bush's address. Depending on timing, perhaps the Foreign Secretary could have a meeting with the Prime Minister either just before or just after President Bush's speech?

There are a number of other invitations for the Prime Minister on which I would welcome you guidance.

The National Committee on American Foreign Policy (NCAFP) wish to present the Prime Minister with the Hans J Morgenthau Award for "outstanding contributions to international peace and security". Previous recipients have all been Americans and include James Baker, George Shultz and Henry Kissinger. The Ambassador in Washington has recommended that the Prime Minister should accept this award which is particularly timely given Britain's role since the invasion of Kuwait. The ceremony can be fitted in on 1 October either during the lunch period or before the UNIFEM Award. You will wish to consider whether the Prime Minister would want to accept two awards in the same day.

The Foreign Policy Association (FPA) would like the Prime Minister to give a speech to a "high calibre audience" with the Press in attendence. (I believe the chairman of the Association, Mr Leonard Marks, has already written directly to the Prime Minister.) In view of the guidance you gave in your letter of 21 July against any further speaking engagements and the fact that the Prime Minister gave a major speech in Aspen in August should we turn this down?

Countess Albina de Boisrouvray, President of the Association Francois-Xavier Bagnoud (a charitable foundation with a broad range of activities), has asked if a small group of children could present the Prime Minister with a special gift commemorating the World Summit for Children. She estimates the presentation would only take a few minutes. The Association recently sponsored a round-the-world voyage of children to promote the United Nations Convention on the Rights of the Child. Since your letter of 19 February indicated that the Countess is personally well known to the Prime Minister, you may wish us to make room for this in the programme.



PRIME MINISTER'S VISIT TO NEW YORK

We now have arrangements for the Prime Minister to meet President Bush in New York on the evening of Sunday 30 September for a talk followed by dinner. We need to consider what other bilaterals with Heads of Government the Prime Minister should seek in New York. It would be helpful, while we are in Eastern Europe, to have a list of those likely to be attending the World Children's Summit, so that we know what the options are. This morning's Observer seems to have such a list, although I have no idea whether it is accurate.

The Prime Minister has already agreed to see President Ozal. I see from Jeddah tel. no. 152 that the Amir of Kuwait is likely to be in New York at about that time, in which case the Prime Minister ought to see him (and it would be more convenient there than in London). I have had a request from Prince Bandar to see the Prime Minister, on the basis that King Fahd will not be coming to New York. If President Mubarak will be there, I think the Prime Minister should certainly see him. Others on the Observer list whom she should meet are President Mitterrand, Mr. Kaifu and Mr. Mulroney. If Dr. Mahathir is there I think she would also want to see him. But perhaps you could let me know in more detail what the possibilities are so that we can get on with constructing a programme.

I am sorry there has been confusion about the classification of the Prime Minister's visit to New York at the end of September. Your original letter of 26 July was marked 'Confidential' (and Personal) which we thought was the correct classification for the visit. MISC 136 discussed the visit at their meeting on 31 July and we included it on the Royal and Ministerial Visits schedule for August, of which we prepared only three copies: two for use in Protocol Department here and one for the Secretary of MISC 136 in the Cabinet Office. We considered this very limited distribution consistent with the request in your letter of 20 August to keep the Prime Minister's intention to use Concorde to New York secret. We saw no reason to exclude the visit from the August schedule, particularly as the minutes of the MISC 136 meeting on 31 July required us to include it and we knew the information would be restricted to MISC 136 (or those in the Cabinet Office entitled to see MISC papers), who had a duty to consider the security implications. The Cabinet Office produce a further limited number of copies of our schedule for the members of the MISC 136 group and you must have seen one of these. The Chairman of MISC 136 stresses at all their meetings the importance of keeping all proposed visits on a strict need-to-know basis, and the Prime Minister's visit to New York was no exception. I note that the Chairman of the JIC has now advised the Prime Minister to go to New York by RAF VC10 rather than Concorde. 
I suspect the Prime Minister will want a lot of bilaterals on 1 October if as many Heads of State and Government are present in New York as predicted. We had better delay a firm commitment to the Editorial Board of the Wall Street Journal until we know exactly what her other commitments will be (although I know the Prime Minister is keen to see the Wall Street Journal).

I am sending copies of this letter to Paul Ahearn (Department of Health), Peter Storr (Home Office), and Eamoinn Taylor (Overseas Development Administration).

I cannot begin to tell you how much it meant to all of us at The Noël Foundation and UNIFEM when we received the news of your attending A Celebration of International Leadership in your honor on October first at the United Nations.

You are an inspiration to the many international business and government leaders who will be attending and your acceptance of the award personally from the Secretary-General will be the highlight and most important part of the event.

We have just received news that President Reagan will be unable to attend due to a schedule conflict. We are working closely with the White House inviting President and Mrs. Bush to participate in your honour.

We are pleased the former President Oscar Arias of Costa Rica has changed his plans to be at this event honouring you. Our corporate chairman is Mr. David Rockefeller and corporate co-chair is Mr. Sid Bass, both of whom were thrilled to participate in an event honouring you and at the same time helping global economic development through the UNIFEM projects which we are sponsoring in your name and the names of the other honorees. Our event co-chairs are Mrs. Georgette Mosbacher and Mrs. Pamela Harriman.

We are also pleased that Mrs. Brundtland has confirmed her attendance with the Norway U.N. Mission and that Barbara Walters is our mistress of ceremonies.

I have recently visited two UNIFEM projects which I would like to share with you. I was very impressed with the women and the work of UNIFEM.

In Golfito, a very depressed region of Costa Rica the women were first taught to read and write and workshops were created to teach them bookkeeping and organizational skills and small loans were give to them to open businesses such as a laundry and a fish business. In Tempoal, a poor rural region of Mexico, the women were asked what they needed to improve their lives and their community and they drew pictures of what their days were

like since they could not read and write and it was determined by the women themselves that with a corn grinder and a water pump their days of domestic work could be reduced from 16 hours a day to 2 hour, thereby leaving them 14 hours a day for income producing work and time to care for their health and education of their children. UNIFEM gave them a loan to buy a corn grinder for their community which is income producing and provided training for 10 of the women to learn how to make water pumps from a factory run by women in Colombia. On August 3rd, the women of Tempoal opened their own factory making the water pumps which will be distributed throughout Mexico. This will provide jobs for the women of Tempoal producing income and the profits will be used for expansion, distribution and training of women in Africa and Asia to open factories in their own regions so that this income producing business will have the same benefits in these areas. This is helping those most in need to help themselves which is the core principle of The Noël Foundation and the philosophy of UNIFEM.


I was particularly impressed to see the confidence and self esteem the women of Golfito and Tempoal now has as a result of these projects and the positive effect it had on the whole community. World Summit for Children

The format for the World Summit for Children, to be held in New York on 29/30 September, is now becoming clearer. It will begin with dinner on 29 September, before the opening of the Summit at 0930 hrs on 30 September. The UN Secretary General and the two co-chairmen (Mr Mulroney and, the plan had been, Mrs Bhutto) will make short speeches followed by an 8-minute video. Two of the remaining four "initiators" will then be asked to speak for two or three minutes each.

The Summit will adjourn to the ECOSOC Chamber, where each member of a selected group will present one of the main themes of the Summit. Presentations should be short (two or three minutes). Each presentation will be followed by a number of speakers, who will make short speeches on the theme. No speaker will be allowed to speak more than once. The media will be present throughout.

After lunch there is due to be an opportunity for informal discussion before a final session at which the Declaration and Plan of Action would be presented.

We suggest that the Prime Minister might like to introduce one of the main themes. A final list of themes is not yet available, but it is likely to include:

- health and nutrition
- education
- children in especially difficult circumstances
- the environment
- economic factors

The Prime Minister might wish to introduce the topic of "the family". It has domestic as well as international appeal. We have consulted other interested Departments at official level: they agree with this suggestion. I should be grateful for your views.

The Prime Minister is to travel to New York at the very end of September to attend the Children's Summit and the UNIFEM Award ceremony at which she will be a recipient. The two events take place on Sunday 30 September and Monday 1 October.

The Prime Minister is very anxious to minimise the time she is absent from London rather soon before her Party Conference speech. In the light of that I have made tentative bookings, under a pseudonym, for the Prime Minister and a small party to fly out to New York by Concorde on the evening of Saturday 29 September and return by the scheduled British Airways 747 overnight on Monday 1 October/Tuesday 2 October. The alternative would, of course, be to use a RAF VC10 in both directions: or for the return from New York only. This would be more secure, but it is also slower and considerably more expensive.

The security aspects obviously have to be taken particularly seriously, both in the light of the heightened IRA activity and the renewed threat from Middle East terrorists. Would you please advise, on security grounds, whether:

- the Prime Minister can travel in both directions by scheduled flights. The bookings would, of course, be under a pseudonym, but the return flight would be more predictable;
- the Prime Minister could travel out by Concorde but should return by VC10;
- the Prime Minister should travel by VC 10 in both directions.

I have had earlier correspondence about the Prime Minister's travel arrangements for her visit to New York at the end of September and the security considerations which would cover travel by scheduled airlines. I have now had a chance to consult the Chairman of the JIC. His judgement is that it would probably be all right for the Prime Minister to travel out to New York by Concorde provided (a) thorough arrangements were made to ensure that her intention to travel by this route remained secret, and (b) there was enhanced screening of passengers, freight and baggage. But he does not believe it would be safe for the Prime Minister to return from New York by scheduled airline. We would therefore need a VC10 for the return journey. I realise this might raise questions how the Prime Minister is getting out to New York. You will wish to discuss with the Ministry of Defence how such curiosity can be stifled.







The Opening Session of the World Summit is fixed for 0930-1100 on Sunday, 30 September. It will be the only opportunity for speeches by participating Heads of State or Government. These will be limited to 5-10 minutes The next session from 1145-1545, which will include a working lunch, has been set aside for private discussion only. Some participants will also be asked to introduce, at this session, a substantial theme of the Summit. At the closing session, due to end at 1730, the co-chairmen will sum up and present the declaration and plan of action to children. It is most unlikely that they would agree to the Prime Minister being allowed to make a speech then. The UNIFEM Award Ceremony the next day, 1 October, will take place from 1900-2015. The Noel Foundation have told us that the timing cannot now be changed. It will be followed by a reception and dinner: they would understand if the Prime Minister chose not to attend these. At the Ceremony she would be called upon to make an acceptance speech lasting about 5 minutes. The Prime Minister would have to aim to arrive in New York on the evening of 29 September (since the morning Concorde only arrives at 0920). World Summit for Children: UNIFEM Award

Thank you for your letter of 16 July about the Prime Minister's attendance at the World Summit for Children and the UNIFEM Award Ceremony.

The Prime Minister has agreed in principle to this but before we inform anyone we need to be sure it is a practical proposition. For that, I need to know:

- Exactly what speeches would be required. If the Prime Minister were to speak in the general debate at the World Summit for Children on the morning of 30 September, how long a speech would she be expected to make? Would she be expected to speak at the UNIFEM ceremony on 1 October? If so, for how long? These are important considerations, given that she will only just have returned from a week's visit to Eastern Europe and Switzerland, where she will have made at least one major speech; and will be working up to the Party Conference speech.
- We need to minimise the time which attendance at these two events will take out of the Prime Minister's diary. Do we know what time of day on 1 October the UNIFEM Award will take place? Could we arrange for it to be in the morning so that the Prime Minister could return to London by that evening? Could we arrange for her to speak at the World Summit for Children on the afternoon of 30 September rather than the morning? Would there be any point in attending the Children's Summit without making a speech?





WORLD SUMMIT FOR CHILDREN: UNIFEM AWARD

You will recall that some months ago you received a delegation of ladies from UNIFEM who urged you to travel to New York to accept the UNIFEM award at the United Nations, together with Miss Bhutto, Mrs. Aquino and Mrs. Brundtland. We have so far delayed a reply.

At the same time Brian Mulroney has been pressing you to make a brief appearance at the World Summit for Children at the United Nations in the early autumn. You told him at the NATO Summit that you would do your best.

The UNIFEM Award ceremony has now been definitively fixed for Monday 1 October (although we do not know what time of day). The World Children's Summit will begin on the evening of Saturday 29 September and continue until Sunday 30 September. It would in theory therefore be possible for you to fly over for the second day of the World Children's Summit and stay over for the UNIFEM Award, getting back to London early on 2 October.

That would certainly attract a certain amount of publicity and at a time when not a lot else is due to be happening. On the other hand it would take a Sunday and Monday out of your diary about a week before the Party Conference starts, and 12 days before your speech (although you could no doubt do some work on the aeroplane).

The Foreign Secretary is inclined to wonder whether this is really worth your time. Against that, you have undertaken to Brian Mulroney to do your best: and President Reagan is to present the UNIFEM Award. We would try to arrange travel by Concorde if the timings fitted.

Foreign and Commonwealth Office London SW1A 2AH 16 July 1990 World Summit for Children: UNIFEM Award Your letter of 2 July asked for a firm recommendation on whether the Prime Minister should attend the World Summit for Children in New York, and at the same time receive the UNIFEM award. The UK has been actively participating in the planning committee and working groups of the World Summit for Children. The initiating countries (Canada, Sweden, Mali, Pakistan, Mexico and Egypt) have been adamant in refusing to accept any change to the framework they originally devised, i.e. attendance only by Heads of State or Government. The Declaration and Programme of Action under consideration in the preparatory process will do little new for children. The majority of the suggestions are already in existing UNICEF and WHO programmes. The Foreign Secretary does not think the Summit deserves the Prime Minister's attendance on its own merits. But if, as Mr Mulroney suggested to her on 5 July, the Prime Minister were to make a brief appearance and was then permitted by the organisers to appoint a Special Representative for the rest of the time, there could be considerable presentational advantage. Mrs Thatcher's presence would almost certainly attract other major world leaders. We have considered whether it would be practicable for the Prime Minister to fly to New York, make a brief appearance at the Summit, accept the UNIFEM award, and undertake other appointments inside a day. A practical problem exists in that the other recipients of the UNIFEM are Mrs Bhutto, Mrs Aquino and Mrs Brundtland and the /date



date for the award ceremony has now been set for 1 October. The World Summit is due to begin on the evening of 29 September with a dinner and continue on 30 September with a General Debate in the morning and a period for private discussion. The two Co-Chairmen (Mr Mulroney and Mrs Bhutto) will then present the declaration and plan of action to the Secretary General on 1 October. This suggests that there are two options: the Prime Minister could arrive on the evening of the 29th and stay for the Summit and for the UNIFEM ceremony on 1 October, or she could fly in on the evening of 30th, make only a brief appearence at the Summit and stay on for the award ceremony the following day. If the Prime Minister so wished we could ask the Embassy in Washington to explore the possibility for a meeting with President Bush. She has also been offerred two other awards in New York: the Presidential Gold Medal from B'nai B'rith and an Honorary degree from Adelphi University in New York.

On balance the Foreign Secretary doubts whether this will be an advantageous use of the Prime Minister's time.

UNIFEM: WORLD CHILDREN'S SUMMIT

You will find there is correspondence on the file, ending with my letter of 27 February to Bob Peirce, about an award to the Prime Minister by UNIFEM. They have suggested that the Prime Minister might receive it in New York on 27 September or 1 October.

At the same time, we are awaiting a recommendation on whether the Prime Minister should attend the World Children's Summit in New York on 1 October.

Recent developments are:

- UNIFEM tried to put out a press release saying that the Prime Minister would accept the award at a ceremony in New York on 1 October. We stopped them (I think);
- President Reagan's office have been in touch to say that he has been invited to present the award. They wanted to know whether the Prime Minister would definitely attend. If so, they expected President Reagan to do it;
- the Canadian Prime Minister has urged the Prime Minister to attend the World Children's Summit.

The time is coming when we need to put a firm recommendation to the Prime Minister on attendance at these events. I suggest that we should aim to do so not later than 22 July. Much will depend on whether the Prime Minister can undertake both events on the same day, to avoid too long an absence. I should be grateful if the recommendation could cover this point.

The Prime Minister duly saw Mrs. Capeling-Alakija and Mrs. Irwin-Hentschel this afternoon. They handed over the invitation to the Prime Minister to accept an award from UNIFEM and attend a ceremony in September at the United Nations to receive it. They suggested that one option might be to combine it with the final day of the Childrens' Summit on 1 October. The Prime Minister did not rule this out, saying she would look again at the question of dates. It might be possible to do a quick in-and-out visit to New York. But an alternative, which she favoured, would be to have a ceremony here in London, with appropriate publicity. One possibility might be to link it to the meeting of the International Women's Forum which is taking place here in Windsor on 24-27 September. (I do not know whether this would be appropriate or not. I enclose a pamphlet about the organisation. The Prime Minister is looking in on one evening of the meeting.)

No conclusion was reached, but Mrs. Capeling-Alakija will have gone away with <u>some</u> hope that the Prime Minister may yet be persuaded to come to New York.

The Prime Minister decided last December to accept an award from UNIFEM. She will receive the formal invitation from the organisers, Mrs Capeling-Alakija (the Director of UNIFEM) and Mrs Irwin-Hentschel (Director of the Noel Foundation) at 1600 on Monday, 26 February.

The Prime Minister was first approached about this award in October 1989, following contacts at official level both here and in New York.

Mrs Irwin-Hentschel runs a charitable organisation, the Noel Foundation, which together with UNIFEM is planning an awards ceremony in September 1990 (during the UN General Assembly) to four women of high accomplishment. The other recipients will be Ms Brundtland, Mrs Bhutto and Mrs Aquino. As part of the ceremony, a statue will be unveiled at UN Headquarters and Mrs Irwin-Hertschel's foundation will announce a donation of \$1 million in the name of the four recipients to projects to help women in the third world.

The Prime Minister agreed to accept the award last December after we had established that it would be possible for her to do so without attending the proposed ceremony in New York. Mrs Brundtland and Mrs Bhutto have accepted and will attend the ceremony. Mrs Aquino will probably accept but not attend.

UNIFEM itself is a worthwhile part of the UN system. We have been contributing £50,000 annually but have pledged to double this to £100,000 in 1990. UNIFEM operates as an autonomous body under the auspices of the UN Development Programme. It serves to ensure the involvement of women in mainstream development programmes, including those of other UN agencies, and to support innovative and experimental activities benefitting women in line with national and regional priorities. I enclose further background.



Mrs Capeling-Alakija and Mrs Irwin-Hentschel asked to call at short notice in December to present the formal invitation to the Prime Minister. It was not possible to arrange this. It is clear from UKMis New York's contacts with them that they are still keen for the Prime Minister to accept the award in person in New York. Sir Crispin Tickell has made clear to them that they should plan on the Prime Minister not being able to come, as she indicated in her letter of 13 December 1989. There are no strong reasons for the Prime Minister to go to New York during this year's General Assembly, particularly after her visit last year. In that case, Mrs Capeling-Alakija and Mrs Irwin-Hentschel would want to arrange either to present the award to the Prime Minister in London later this year, or give it to someone on her behalf in New York. They would be keen to film any presentation in London, to show at the award ceremony itself.

Finally, Mrs Capeling-Alakija and Mrs Irwin-Hentschel also want to arrange a short documentary about each prize winner, emphasising the humanitarian aspects. We are in touch with the COI about possible material.

WHAT IS UNIFEM?

UNIFEM is a fund which supports the development initiatives of poor women in Latin America/Caribbean, Africa, Asia and the Pacific. Created in 1976 by the United Nations General Assembly, it was first called the Voluntary Fund for the UN Decade for Women. Renamed the UN Development Fund for Women (UNIFEM), in 1985, it works in autonomous association with the United Nations Development Programme (UNDP).

WHAT ARE ITS PRIORITIES?

UNIFEM has two primary objectives:


- to provide direct financial and technical support to women involved in cooperative activities, food production, fuel and water supply, health services, small businesses, management, and planning; innovative approaches are preferred;
- to ensure that the needs of both women and men receive consideration when large-scale assistance is given to developing countries through involvement in programming and project design, monitoring and evaluation.

WHERE ARE THESE PROJECTS?

- In 104 different countries.
- Special priority is given to projects in the least developed, landlocked and island countries among developing countries.
- The Fund works in partnership with the United Nations Development Programme (UNDP). UNDP provides administrative support to project appraisals and execution, especially through its 112 field offices. The United Nations specialized agencies (FAO, ILO, UNIDO, etc.) also assist United Nations specialized agencies technical assistance to financial some projects. UNIFEM provides technical assistance to financial institutions such as banks and development funds, to leverage large-scale resources for women.
- A Consultative Committee representing Member States of the 5 regions of the world advises on the use of the Fund's resources. The Administrator reports each year to the Governing Council on the Fund's activities and then to the General Assembly. Present members of the Consultative Committee are: Kenya (Chairperson/Rapporteur), Colombia, German Democratic Republic, India, and Norway.

WHY WAS THE FUND ESTABLISHED?

- The Fund's establishment recognizes that women are central figures in their national economies - in families, communities and countries, together with their need for access to resources such as training, technologies and credit to make their development work more fruitful.





- US\$1.8 million has been contributed by individuals and non-governmental organizations.
- US\$39 million has been contributed by Governments.

HOW IS THIS MONEY USED?

- The Fund has assisted more than 400 projects and other activities including 100 project development missions since becoming operational in 1978. Some 200 projects are ongoing.
- Project size ranges from US\$2,000 to US\$400,000; the average size is US\$100,000
- Of the projects approved in 1987-1988:







Thank you for your letter of 25 October and one which the Prime Minister has received from Mrs S Capeling-Alakija.

Normally this is the sort of invitation we advise the Prime Minister to decline. UNIFEM is a bona fide but not particularly prominent part of the UN system (I enclose a brief on what it does), and we know that most of the energy behind the proposed awards has in fact been that of a private individual - Mrs Noel Irwin Hentschel, who runs the Noel Foundation mentioned in the letter. Acceptance would require the Prime Minister to visit New York next autumn. There are no UN or general foreign policy reasons why she should do so. A visit for this sole purpose during the General Assembly would be very unusual.

There are on the other hand a number of special features to this case, including the \$1 million which the Noel Foundation is proposing to contribute to UNIFEM projects in developing countries in the name of the four proposed recipients of the awards. Those four proposed recipients (the Prime Minister, Mr Bhutto, Mrs Aquino and Mrs Brundtland) form an impressive list. Mrs Bruntland had already agreed to participate (before losing office). Mrs Irwin Hentschel is putting a great deal of work and determination into getting these awards off to the best possible start and is capable of making an impact.

The Foreign Secretary doubts if this is quite in the Prime Minister's league. If the Prime Minister were prepared to entertain the idea of accepting, we could check on the intentions of the other proposed recipients. Once we have her views, we can of course let you have a draft reply to Mrs Capeling-Alakija.

WHAT IS UNIFEM?

UNIFEM is a fund which supports the development initiatives of poor women in Latin America/Caribbean, Africa, Asia and the Pacific. Created in 1976 by the United Nations General Assembly, it was first called the Voluntary Fund for the UN Decade for Women. Renamed the UN Development Fund for Women (UNIFEM), in 1985, it works in autonomous association with the United Nations Development Programme (UNDP).

WHAT ARE ITS PRIORITIES?

UNIFEM has two primary objectives:

- to provide direct financial and technical support to women involved in cooperative activities, food production, fuel and water supply, health services, small businesses, management, and planning; innovative approaches are preferred;
- to ensure that the needs of both women and men receive consideration when large-scale assistance is given to developing countries through involvement in programming and project design, monitoring and evaluation.

WHERE ARE THESE PROJECTS?

- In 104 different countries.
- Special priority is given to projects in the least developed, landlocked and island countries among developing countries.
- The Fund works in partnership with the United Nations Development Programme (UNDP). UNDP provides administrative support to project appraisals and execution, especially through its 112 field offices. The United Nations specialized agencies (FAO, ILO, UNIDO, etc.) also assist some projects. UNIFEM provides technical assistance to financial institutions such as banks and development funds, to leverage large-scale resources for women.
- A Consultative Committee representing Member States of the 5 regions of the world advises on the use of the Fund's resources. The Administrator reports each year to the Governing Council on the Fund's activities and then to the General Assembly. Present members of the Consultative Committee are: Kenya (Chairperson/Rapporteur), Colombia, German Democratic Republic, India, and Norway.

UNIFEM ANNUAL REPORT

In the Caribbean, the programme of the Women and Development Unit (WAND), established in 1978 as part of the Extra-Mural Department of the University of the West Indies (UWI), was designed to serve as a catalyst in tesponding to the needs and priorities of Caribbean women. WAND has played a key role in raising the awareness of, and providing support to, Caribbean women in their social, economic and civic roles since its establishment. Approximately 300 low-income women and extension workers of the CARICOM countries have participated in the various activities of the project.

In Kenva, the World Bank and UNDP assisted in a pilot project for testing eight different water hand pumps in the Kwale district. In 1983, UNIFEM and UNDP's Promotion of the Role of Women in Water and Environmental Services (PROWWESS) programme, supported an NGO, the Kenvan Water for Realth Organization (KWAHO), to provide software (community participation and training) to complement the hardware. KWAHO had been created as a result of the special concerns of members of the National Council of Women. The project trained 24 female community water leaders and organized workshops with them on community participatory training methods in health/sanitation and maintenance/use/repair of water pumps. It formed 70 water Committees, and reached a population of 27,000 as at 1987. It proved catalytic in that its methodology was adopted by the Swedish International Development Agency in the surrounding areas.


In Togo, UNIPEM's mainstreaming work with the round table exercise and follow-up activities with the Directorate of Women's Condition, a technical department, is illustrative of the Fund's catalytic role within the larger system of technical cooperation. Among concrete results have been United Nations agencies' cooperation in support of women in Togo as evident in preparatory studies for establishment of a revolving loan fund, financed by UNIFEM and UNDP and executed by PAO; preparatory assistance financed by UNIFEM for the development of appropriate technologies for women's projects by UNIDO, and UNIFEM's assistance to a UNICEF situation analysis of women and children.

In Peru, in 1982 UNIFEM supported a non-governmental organization to carry out research on the situation of female workers in the electronics industry. As a result of the study the Centre offered to women workers in the industry, and in the textile, chemical and canning industries, information services and training programmes. Participating women have information services and training programmes. Participating women have become more active agents in the development process of their country, enabling actions geared at improving the quality of women workers' lives.

In India, the Centre for Women's Development Studies assessed structures and attitudes within public specialized agencies that impact on the translation of macro level policies about women into practices. The study was concerned with the sectors of production/distribution enterprises (for example khadi production); public credit/financial institutions; special rural development agencies; health; education; and
