#### Item 7

SW reported on the research commissioned to date and on the formation of the expert groups. WW would also circulate a list of companies that had agreed to help All Centre with its research work.

### Item 8

KJ spoke on his paper on public education. He mentioned he had approached Jock Bruce-Gardyne with a view to the latter assisting Centre part-time in training of disputants/debaters. Jock considering offer. It was agreed that we should proceed with disputations in universities and other institutions of further education by enlisting help of hand-picked sympathisers who would identify protagonists for our cause. PU and MW to begin searching for sympathisers.

PU reported that a trial disputation would take place in Centre in November with following proposition:

"that it is no part of the function of Government to bail out private industries in financial trouble:

- is the rule valid? a)
- is Ferranti an exception?"

David Howell and Sir Fred Catherwood had agreed to oppose the motion; it was hoped Jock Bruce-Gardyne and Barry Bracewell-Milnes would propose it. Basil de Ferranti had agreed to participate and had kindly provided information for a CPS staff AS brief for the debaters. Date was yet to be arranged; all present PU would be notified in due course.
