MY TELEGRAM NO 417 TO BONN: CAMBODIA: DE-RECOGNITION OF POL POT

1. PLEASE DELIVER THE FOLLOWING MESSAGE FROM THE PRIME MINISTER TO PREMIER HUA GUOFENG: BEG INS

DURING YOUR VISIT TO BRITAIN I GREATLY VALUED OUR EXCHANGE OF VIEWS ABOUT INDO-CHINA.

YOU WILL REMEMBER THAT WHEN YOU JOINED ME FOR DINNER AT NO 10 DOWNING STREET, I SAID THAT I HAD BEEN GLAD TO NOTE THAT YOU HAD CRITICISED SOME OF POL POT'S POLICIES: WE WERE ALSO STRONGLY OPPOSED TO THEM. I ALSO TOLD YOU THAT OUR CRITERIA FOR RECOGNITION REQUIRED THAT A GOVERNMENT SHOULD BE IN CONTROL OF THE COUNTRY CONCERNED AND THAT CLEARLY POL POT'S GOVERNMENT WAS NOT. I MADE IT PLAIN, HOWEVER, THAT WE HAD ABSOLUTELY NO INTENTION OF RECOGNISING THE REGIME OF HENG SAMRIN WHICH HAD BEEN INSTALLED BY THE VIETNAMESE AND DEPENDED ON THEM FOR ITS SURVIVAL.

I KNOW THAT YOUR GOVERNMENT CONTINUES TO RECOGNISE DEMOGRATIC KAMPUCHEA. HOWEVER THERE ARE OTHER IMPORTANT GOVERNMENTS WHO ARE FIRMLY OPPOSED TO VIETNAM'S INVASION OF CAMEODIA, WHO RECOGNISE NONE OF THE PARTIES THERE. WE HAVE NOW DECIDED THAT OUR CRITERIA REQUIRE US TO BE AMONG THOSE WHO RECOGNISE NEITHER DEMOCRATIC KAMPUCHEA NOR THE REGIME OF HENG SAMRIN, AND IN THE SPIRIT OF MUTUAL CONFIDENCE BETWEEN US I THOUGHT I SHOULD TELL YOU THAT OUR DECISION WILL BE MADE KNOWN IN THE HOUSE OF COMMONS DURING A DEBATE ITEM ABOUT CAMBODIA, ON 6 DECEMBER.

IN REACHING THIS DECISION I GAVE GREAT WEIGHT TO THE VIEWS YOU SO CLEARLY EXPRESSED TO ME. DUT THERE IS MUCH CONCERN IN THIS COUNTRY ABOUT THE INHUMANE POLICIES OF POL POT AND A DESIRE THAT THE BRITISH GOVERNMENT SHOULD NO LONGER RECOGNISE HIS GOVERNMENT NOW THAT IT DOES NOT CONTROL ANY MAJOR PART OF CAMBODIA.

WE SHALL MAKE IT PLAIN THAT HENG SAMRIN'S QUOTE REGIME UNQUOTE CANNOT BE REGARDED AS EXERCISING CONTROL IN CAMBODIA INDEPENDENTLY OF THE VIETNAMESE OCCUPATION ARMY. LIKE YOU, WE SHALL CONTINUE TO OPPOSE VIETNAMESE ATTEMPTS TO SECURE INTERNATIONAL ACCEPTANCE FOR HENG SAMRIN. WE HOLD FIRMLY TO THE VIEW THAT THE KHMER PEOPLE ARE ENTITLED TO SELF-DETERMINATION AND TO LIVE IN PEACE UNDER A GOVERNMENT OF THEIR OWN CHOOSING: AS YOU WILL BE AWARE, WE SUPPORTED THE RECENT U N GENERAL ASSEMBLY RESOLUTION CALLING FOR THE WITHDRAWAL OF FOREIGN FORCES IN CAMBODIA,

I SHOULD LIKE TO ADD THAT WE REMAIN VITALLY INTERESTED IN THE MAINTENENCE OF THE INDEPENDENCE AND STABILITY OF THE ASEAN COUNTRIES, ESPECIALLY THAILAND. THE SITUATION ON THE THAI-CAMBODIAN PORDER GIVES CAUSE FOR CONCERN AND WE SHALL CONTINUE TO DO WHAT WE CAN TO SUPPORT THE THAT GOVERNMENT'S EFFORTS TO DEAL WITH THE REFUGEE PROBLEM. WE SHALL ALSO MAINTAIN OUR SUPPORT FOR INTERNATIONAL EFFORTS AIMED AT SECURING A PEACEFUL RESOLUTION OF THE PROBLEMS OF THE REGION.
