- YOUR TELNO 535: ISRAEL/IRAQ IN THE SECURITY COUNCIL

 1. THE ANSWERS TO THE QUESTIONS IN YOUR PARAGRAPH 3 ARE AS FOLLOWS:
- (I) APART FROM REMOVING SPECIFIC REFERENCES TO ARTICLE 39 AND 41 WE NEED TO AVOID CHAPTER 7 LANGUAGE. WE COULD NOT THEREFORE ACCEPT 'THREAT TO INTERNATIONAL PEACE AND SECURITY'. 'ACT OF AGGRESSION' COULD BE ACCEPTABLE IF IT WERE NOT USED IN A CHAPTER 7 CONTEXT. WE COULD SUPPORT SOMETHING LIKE '....ANY REPETITION OF RECENT ACTS OF AGGRESSION BY ISRAEL CULMINATING IN THE RAID OF 7 JUNE WOULD SERIOUSLY ENDANGER THE MAINTENANCE OF INTERNATIONAL PEACE AND SECURITY...'. THIS FORMULATION WOULD NOT (NOT) COMMIT US TO CHAPTER 7 ACTION IN RESPONSE TO A FUTURE ISRAELI ACT OF AGGRESSION.
- (II) OPERATIVE PARAGRAPH 2 AS IT STANDS, EVEN WITH THE CHAPTER 7 LANGUAGE REMOVED AND WITH THE QUALIFICATION ('WHICH MIGHT ENCOURAGE' ETC ETC) IS FAR TOO BROAD AND VAGUE FOR US TO BE ABLE TO DEFEND. ASSISTANCE CANNOT BE READ IN THE NARROW SENSE OF AID, AND AS DRAFTED THE PARAGRAPH COULD BE READ TO INCLUDE NORMAL TRADE OR CREDITS, ON THE GROUNDS THAT THEY COULD FOR EXAMPLE ALLOW RESOURCES TO BE DIVERTED FOR EXPANSIONIST OR AGGRESSIVE PURPOSES. AND ALTHOUGH IT COULD BE ARGUED THAT THE REQUIREMENT WAS LAID ON STATES AND NOT INDIVIDUALS (EG. ISRAEL'S SUPPORTERS HERE) THE WORDING IS NOT CLEAR. WE COULD SUPPORT SOMETHING LIKE 'CALLS UPON (PROVIDING THIS WAS NOT USED IN A CHAPTER 7 CONTEXT)
