DEINDEXATION

Against the background of the Chancellor of the Exchequer's speech at the weekend we pointed out that there were a number of items being considered by Ministers to bring about further savings in public expenditure. For example, Ministers might wish to consider widening differentials between those in and out of work - eg by raising tax thresholds (which would be expensive) or by deindexation of particular benefits. We could not steer correspondents in a particular direction at the moment but if as the Government had stated, it wished to reduce public expenditure further, then all possibilities had to be reviewed.

BRITISH LEYLAND

We were not aware that any statment was to be made this week on future Government financial support for British Leyland.

SIME MINISTER'S ENGAGEMENTS

The morning Lobby was repeated.

STATEMENTS

We told the Lobby operationally that the statement on nuclear power would probably be tomorrow; the one on Bingham some time this week; and, subject to what happened at Lancaster House, there may be a need for a statement on Rhodesia, which also would be some time this week.

KHASHOGGI AFFAIR

We said that we could not take the Prime Minister's Written Answer any further. The Lobby must assume that the Prime Minister had been given the relevant background information on which to make the judgment that there had been no breach of security. We were not aware if the Prime Minister had spoken to Mr Churchill or if he had written to her. A further Priority PQ on this from Mr Denis Canavan would be answered tomorrow.

PRIME MINISTER'S SPEECH TO THE FOREIGN POLICY ASSOCIATION

We said we would make copies of the speech available to the Lobby as soon as possible tomorrow. We expected the speech to cover the problems of domestic economies in the Western Alliance; the management of the world economy; the modernisation of our defences; seeking agreement with the East; the reduction of energy consumption hand of fossil fuel in particular; mutually advantageous relations with the oil producers; and help to developing countries.

ADDITIONS TO THE WHITE PAPER LIST

We told the Lobby that the 29th Legal Aid Annual Report for 1978/79 would be published on 20 December at 2.30 pm, CFRs 10.30 am the same day.

DHSS - WRITTEN PQ ON SICKNESS BENEFITS

We advised the Lobby to speak to DHSS on the implications behind the Answer.
