ITEM 1. INTELLIGENCE

- 1. SIR TERENCE LEWIN invited the Deputy Chief of the Defence Staff (Intelligence) to update them on current intelligence.
- 2. LIEUTENANT GENERAL GLOVER (Deputy Chief of the Defence Staff (Intelligence)) reviewed the intelligence published in the latest summary (1), and assessed Argentine military capabilities and intentions.

ITEM 2. OWN FORCES

3. REAR-ADMIRAL BROWN (Assistant Chief of the Defence Staff (Operations)) summarised the deployment of the Task Force.

ITEM 3. PUBLIC RELATIONS

- 4. MR McDONALD (Deputy Chief of Public Relations) reported on press coverage, and said an announcement about the establishment of the Government controlled Spanish language radio station would be made that day.
- 5. Summing up a short discussion, SIR TERENCE LEWIN said he would circulate for their information a minute (2) by the Assistant Chief of the Defence Staff (Signals) which set out clearly the practical and technical problems to be overcome in respect of communications for the press. He went on to say they would wish to invite the Deputy Chief of Public Relations to prepare eye-witness interviews about the repossession of South Georgia, for release the next day if appropriate.
