1. FOREIGN MINISTER ROJAS HAS JUST SUMMONED ME TO DELIVER NOTE OF PROTEST AT THE DISCOVERY OF A BURNT OUT RN SEAKING HELICOPTER MARKING ZA.290 ON LAND BUT CLOSE TO SHORE SOME 18 KMS SOUTH OF PUNTA ARENAS QUOTE INDICATING THAT BRITISH UNITS HAD ENTERED CHILEAN TERRITORY AND VIOLATED CHILEAN SOVEREIGNTY UNQUOTE. NOTE ASKS FOR AN EXPLANATION OF THE CASE AND THAT NO FURTHER INCIDENTS OF THIS KIND WILL OCCUR.
