
ITEM 1. INTELLIGENCE MATTERS

- 1. SIR TERENCE LEWIN (Chief of the Defence Staff) invited the Deputy Chief of the Defence Staff (Intelligence) to update them on the current situation in the Falkland Islands and South Georgia.
- 2. LIEUTENANT GENERAL GLOVER (Deputy Chief of the Defence Staff Intelligence)) said that there was further evidence that the Soviets were exploiting the crisis to improve their links with Argentina, and made the following general points:
 - a. A Cuban IL62 aircraft, en route to Buenos Aires, had overflown Brazil without diplomatic clearance and had been forced to land at Brazilia. On board was the Cuban Ambassador to Argentina and a quantity of electronic, photographic and surveillance equipment. There was an unconfirmed report that, although the Ambassador had been allowed to continue on his journey, the equipment had been impounded by the Brazilians.
 - b. A Soviet AGI was shadowing SS CANBERRA off Cape Finisterre.
 - c. Soviet ELINT satellites were probably achieving 20 minutes cover of the Task Force each day.
 - d. One Krivak Class destroyer was operating off the coast of Luanda. She did not appear to be moving South, and it was assessed unlikely that she would do so without tanker support.
 - e. Chile had implemented partial army mobilisation to improve readiness against a threat from both Argentina and Peru. A Chilean Naval force, consisting of a cruiser and 3 destroyers, was under orders to be South of the Straits of Magellan after 19 April 1982.



- 3. Continuing, LIEUTENANT GENERAL GLOVER reviewed Argentine force deployments:
 - a. At Sea. The majority of the Argentine navy remained in mainland ports. Of those at sea, one Type 42 frigate was believed to be standing off from Puerto Belgrano, and an A69 Type frigate, GRANVILLE, remained to the North of the Falklands with orders to prevent any unauthorised entry to Port Stanley. GRANVILLE's exact position was unclear and it was not known if she was in, or remaining on the edge of, the Maritime Exclusion Zone. Two Naval Auxiliaries were believed to be on passage between the Falkland Islands and the mainland, and it was thought two merchant ships remained in Port Stanley harbour. There was an unconfirmed report that the majority of naval units currently in Puerto Belgrano would be ready to sail by mid-week, but nothing to indicate that they would sail once ready for sea.
 - b. Ashore. In addition to the call up of reservists, the Argentine media had now reported the recruitment of volunteers. Troops in the Falkland Islands still numbered around 5,000, and the artillery unit already reported (1) was probably equipped with 105mm Howitzers. The only new deployment on the mainland was the move of 13 x Mirage aircraft to Comodoro Rivadavia.
- 4. In discussion, the following points were made:
 - a. As yet there was no further information on the Argentine oil tanker off Cape Verde which had been discussed (1) the previous day.
 - b. An unconfirmed amateur radio report had been received that the Argentines had mined the area around the Falkland Islands.
 - c. It was important that all those receiving CCTV briefings should be aware of the inherent inaccuracy of the ships' positional information displayed. Some intelligence information could be as much as three

- d. Information on the time it would take for the Argentines to withdraw from the Falkland Islands, should they decide so to do, was required for planning purposes.
- 5. Summing up, SIR TERENCE LEWIN said that they would wish to instruct the Deputy Chief of the Defence Staff (Intelligence) to investigate further the outcome of the Cuban aircraft incident; to obtain details of the Argentine tanker off Cape Verde; to estimate the period of time it would probably take the Argentines to withdraw from the Falklands; and to report any information on Argentine mining around the Falkland Islands. Further, they would wish to instruct the Assistant Chief of the Defence Staff (Operations), in conjunction with the Deputy Chief of the Defence Staff (Intelligence), to ensure that CCTV briefings made clear that ships' positions shown in displays were subject to inherent inaccuracies, and to give, where possible, the reasons for position changes since any previous briefing.

ITEM 2. OWN FORCES

6. There had been no change to the Force Tote Sitrep (2) already published.


SIR TERENCE LEWIN left the meeting after Item 2.

- 7. MR McDONALD (Deputy Chief of Public Relations) reviewed the major articles and editorials in the daily newspapers.
- 8. Continuing, MR McDONALD reported that draft press releases for use following any military engagement had been circulated to the Chiefs of Staff; the Secretary of State had commented that he would not wish to name any ships involved.

ITEM 4. DECISIONS REQUIRED

10. The Committee reviewed the forecast of decisions which had been identified (3). SIR MICHAEL BEETHAM (representing the Chief of the Defence Staff) said that they would wish to invite the Assistant Chief of the Defence Staff (Policy) to produce an outline of the Amphibious Operation Appreciation before the OD(SA) rehearsal scheduled for later that day.

ITEM 5. PRESENTATION TO OD(SA)

11. The Committee agreed that there would be a rehearsal of the presentation to OD(SA) later that day, and that the presentation should be given by the Deputy Chief of the Defence Staff (Intelligence), and the Deputy Chief of the Defence Staff (Operations) utilising information provided by the single Services.

ITEM 6. GIBRALTAR

- 12. SIR EDWIN BRAMALL said that he had reconsidered his Department's advice on the deployment of MILAN to Gibraltar and he believed that both the weapons and the simulator should now be sent. This deployment could be achieved as a routine measure and could be covert.
- 13. SIR MICHAEL BEETHAM said that they would wish to invite the Assistant Chief of the Defence Staff (Policy), in conjunction with the Assistant Under Secretary (Defence Staff), to review this matter.
