YOUR VISIT TO NEW YORK: FALKLANDS

1. YOU DINED AT MY HOUSE ON 2 MAY WITH THE SECRETARY GENERAL, MID WAS ACCOMPANIED BY RAFEE AHMED AND A NOTE-TAKER.

PEREZ DE CUELLAR SAID THAT, FOLLOWING THE SUSPENSION OF HAJG'S MISSION, HE FELT IT HIS DUTY TO FILL THE GAP BY SETTING UP SCHE NEGOTIATING MECHANISM DITHIN THE FRAMEWORK OF SCR 532, IF ONLY TO FCRESTALL DRAMATIC AND UNNERPFUL INITIATIVES FROM CTHERS, THE MEMBERS OF THE SECURITY COUNCIL WERE INCREASINGLY RESTIVE BECAUSE THEY DID NOT KNOW KMAT WAS GOING OR. HE SAW THE DANGERS OF A MEETING OF THE WHOLE COUNCIL, PERMAPS THE ANSWER WAS FOR THE PRESIDENT, OR FOR HIM AND THE PRESIDENT JOINTLY, TO BRIEF THE MEMBERS OF THE COUNCIL INDIVIDUALLY OR IN GROUPS.

3. YOU EATD THAT HE DOORS WERE CLOSED. YOU HAD DISCUSSED A RANGE OF IDEAS WITH HAIG WHO DID NOT REGARD HIS EFFORT AS SEING AT AS END. BUT MEANANTLE OUR ENFORCEMENT OF THE TEX MUST CONTINUE. IF THE ARGENTINES CHALLENGAD IT, THEY WOULD GET A SHARP ANSEER. 4. PEREZ DE CUELLAR SAID THAT HE HAD SEEN ROCK (ARGENTINA) EARLIER TODAY AND GIVEN HIM A LOCUMENT, WHICH HE WOULD GIVE YOU TOO, SETTING OUT IDEAS WHICH HE NOULD LIKE TO DISCUSS WITH BETH PARTIES. HE WOULD NOT GIVE THE DOCUMENT TO AMYONG ELSE NOR REVEAL ITS EXISTENCE TO THE PRESS, HE THEN INVITED ANMED TO INTRODUCE THE DOCUMENT, THE TEXT OF WHICH IS IN MY IMMEDIATELY FOLLOWING TELEGRAM. ANNED SAID THAT IT WAS A PROCEDRUAL FORMULA MICH DID HOT CO INTO THE SUBSTANCE OF THE ISSUES IN DISPUTE AND COULD BE PEGARCED AS CONTAINING "PROVISIONAL MEASURES" UNDER ARTICLE LO OF THE CHARTER. IN ORDER TO CIRCUNVENT THE "CHICKEN AND ESC" PROBLEM RESULTING FROM OUR INSISTENCE THAT THE FIRST STEP MUST BE ARGENTINE WITHDRAVAL AND ARGENTINE INSISTENCE THAT IT MUST BE ACCEPTANCE OF THEIR CASE ON SCHEREIGNTY, THE UN PROPOSED THAT THERE SHOULD BE "SIMULTANEITY" BETWEEN ARGENTINE WITHDRAWAL, THE PEDEPLOYMENT OF THE UK TASK FORCE, THE LIFTING OF SANCTIONS AND THE BEGINS ING OF NEGOTIATIONS. THE UN ASKED FOR RESPONSES FROM US AND ARGENTINA BY 5 MAY, SO THAT THE IR SCHENE COULD COME INTO EFFECT ON 6 MAY.

5. YOU SAID THAT YOU WERE PREPARED TO CONSIDER ANY PROPOSALS BUT THAT YOU HAD THE FOLLOWING INMEDIATE COMMENTS:

A. THE UN TINETABLE SEEMED PRECIPITATE:

B. IT WAS A BASIC CONDITION FOR US THAT THE OUTCOME ON SOVEREIGHTY SHOULD NOT BE PREJUDGED IN ANY WAY. IF, AS ARMED CLAIMED, THE UN SCHEME MET THIS CONDITION, WHAT CHANCE WAS THERE THAT THE ARGENTINES LOULD ACCEPT IT? AT THIS POINT PEREZ DE CUELLER INTERVENED TO SAY THAT, IF WE WOULD RESPOND POSITIVELY TO HIS PAPER, HE WOULD FLY PERSCHALLY TO BUENCS AIRES AND USE ALL HIS INFLUENCE AS A LATIN AMERICAN TO SET THE ARGENTINES TO ACCEPT IT TOO. YOU POINTED OUT THAT IT WAS IMPORTANT TO PICK THE RIGHT TIME, SO THAT THIS ASSET SHOULD NOT BE WASTED.

C. THE UK TASK FORCE HAD BEEN SENT TO PRESERVE THE INTERESTS OF

- THE UK TASK FORCE MAD BEEN SENT TO PRESERVE THE INTERESTS OF THE ISLANDS AND TO ENSURE ARGENTINE WITHDRAWAL. THERE COULD BE NO CUESTION OF A "BALANCED" WITHDRAWAL OF BRITISH AND ARGENTINE FORCES. THE ARGENTINES HAD TO CO FIRST. THERE MIGHT BE SOME "CPTICAL" REDEPLOYMENT OF BRITISH FORCES, AND THE PASSAGE OF WITHDRAWING ARGENTING FORCES, WOULD OF COURSE BE GUARANTEED, BUT EQUALITY OF WITHDRAWAL (FOR EXAMPLE, WITHDRAWING SO MANY ARENTINGUES AND AN EQUAL NUMBER OF BRITISH WAS NOT ACCIPTABLE.
- D. ARRANGEMENTS FOR THE INTERIM ACMINISTRATION WOULD HAVE TO BE AGREED IN ADVANCE. FOLLOWING ARGENTINE REJECTION OF HAIS'S PROPOSALS, THE ARRANGEMENTS FOR THE INTERIM ACMINISTRATION (INCLUDING THE POSSIBILITY OF AN ARGENTINE PRESENCE) WOULD HAVE TO BE LOCKED AT AFRESH

YOU CONCLUDED BY EXPRESSING GRATITUDE FOR THE SECRETARY GENERAL'S IDEAS, WHICH YOU WOULD STUDY CAREFULLY. BUT YOU WANTED HIM TO BE IN NO DOUBT ABOUT WHAT WAS POSSIBLE. YOU GAVE NO UNCERTAKING TO RESPOND BY 5 MAY AND MADE THE POINT THAT THE ARGENTINES SHOULD PEPLY FIRST.

6. PEREZ DE CUELLAR LEFT IT TO ANMED TO LUTROBUCE AND DEFEND HIS PAPER. HE SEEMED TO AGREE WITH MANY OF YOUR COMMENTS ON IT. YOUR FIRMRESS WILL, I THINK, HAVE HAD A SALUTARY AFFECT ON ANMED MO CAN HO LONGER BE UNDER ANY ILLUSIONS THAT HIS SKETCHY AND ILL—THOUGHT OUT IDEAS HAVE MUCH CHANCE OF ACCEPTANCE. NEVERTHELESS, THE FACT THAT THE SECRETARY GENERAL HAS GIVEN YOU AND THE ARGENTINES SOME IDEAS, WHICH WILL CERTAINLY BECOME KNOWN MERE (I SHALL BE SURPRISED IF PEREZ DE CUELLAR FAILS TO ALLUSE TO THEM WHEN HE BRIEFS MEMBERS OF THE COUNCIL). CHOULD ENABLE US TO GAIN A LITTLE MORE TIKE HERE. IT EQUILD BE OFF-SIDE FOR ANYONE TO INTRODUCE A RESOLUTION INTO THE SECUPITY COUNCIL WHEN THE PARTIES WERE CONSIDERING IDEAS PUT TO THEM BY THE SECRETARY GENERAL.
