PRIMAKOV VISIT TO BAGHDAD

1. SECRET - ENTIRE TEXT.

2. SOVIET CHARGE CHETVERIKOV MET WITH THE SECRETARY THE EVENING OF FEBRUARY 13 AND ASKED HIM TO CONVEY TO THE PRESIDENT A LETTER FROM PRESIDENT GORBACHEV TO PRESIDENT BUSH (TEXT PROVIDED IN PARAGRAPH FIVE). PARAPHRASING FROM AN INFORMAL ENGLISH TRANSLATION OF THE LETTER, CHETVERIKOV SAID THAT PRIMAKOV HAD HELD MEETINGS IN

BAGHDAD AND MADE CLEAR TO SADDAM HUSSEIN THAT HE HAD TO COMPLY FULLY WITH U.N. SECURITY COUNCIL RESOLUTIONS. PROPOSED THAT WHEN THE LEADERSHIP OF IRAQ STATED ITS READINESS TO WITHDRAW ITS FORCES FROM KUWAIT AND SET DATES THEN A CEASEFIRE COULD TAKE PLACE. OF COURSE, WITHDRAWAL WOULD HAVE TO BEGIN IMMEDIATELY AFTER THIS. CONTINUING TO PARAPHRASE CHETVERIKOV SAID SADDAM HUSSEIN SEEMED TO BE MORE INTERESTED IN THIS EXCHANGE AND WANTED TO CONTINUE THE DIALOGUE. THEREFORE, HE WAS SENDING A SENIOR IRAQI OFFICIAL TO MOSCOW FOR TALKS. CHETVERIKOV EXPLAINED GORBACHEV'S VIEW THAT, IF THERE WAS THE SLIGHTEST CHANCE OF REACHING AGREEMENT, IT SHOULD BE PURSUED. THUS, WHILE THE TALKS TOOK PLACE IN MOSCOW IT WOULD NOT BE DESIRABLE TO CONDUCT GROUND OPERATIONS IN KUWAIT. GORBACHEV ASSURED THE PRESIDENT IN THE LETTER, CHETVERIKOV SAID, THAT HE WOULD NOT PERMIT THE TALKS TO DRAG ON OR STALL OPERATIONS.

4. THE SECRETARY REPLIED THAT HE UNDERSTOOD THE MESSAGE AND WOULD CONVEY IT TO THE PRESIDENT. HE COMMENTED THAT A MERE STATEMENT OF INTENT TO WITHDRAW FROM KUWAIT WAS NOT ENOUGH. THE JOINT STATEMENT HE AND FOREIGN MINISTER BESSMERTNYKH HAD ISSUED CALLED FOR IMMEDIATE AND CONCRETE STEPS. CHETVERIKOV THEN LOOKED AT THE RUSSIAN TEXT AND SAID THAT IT IN FACT SAID SADDAM WOULD NEED TO ANNOUNCE A "TIME SPAN" FOR WITHDRAWAL. ASSISTANT SECRETARY SEITZ ASKED HIM TO CLARIFY WHETHER THIS MEANT A PERIOD WITH A BEGINNING AND ENDING DATE, AND THE SOVIET CHARGE ASSENTED.
