YOUR TELNO 1037: DE-RECOGNITION OF POL POT: PREMIER HUA GUOFENG'S MESSAGE TO MRS THATCHER.

1. PLEASE DELIVER THE FOLLOWING REPLY FROM MRS THATCHER.

BEGINS:

THANK YOU FOR YOUR MESSAGE OF 5 DECEMBER, IN WHICH YOU REPLIED TO MY MESSAGE ADVISING YOU THAT WE PROPOSED TO ANNOUNCE ON 6 DESEMBER OUR DECISION TO WITHDRAW RECOGNITION FROM THE POL POT REGIME.

I AM SORRY YOU WERE WORRIED AT OUR DECISION. AS I SAID, I GAVE GREAT WEIGHT TO YOUR VIEWS, AS I DID TO THOSE OF THE ASEAN GOVERNMENTS WHO ALSO EXPRESSED THEIR DISQUIET. HOWEVER, I REMAIN CONVINCED THAT A PROCEDURAL STEP SUCH AS WE FELT OBLIGED TO ANNOUNCE ON 6 DECEMBER OFFERS NO ENCOURAGEMENT TO THE VIETNAMESE OR THEIR FRIENDS. I HAVE ASKED OUR AMBASSADOR TO SHOW YOU THE SPEECHES MADE BY GOVERNMENT MINISTERS DURING THE HOUSEOF COMMONS DEBATE. YOU WILL SEE THAT THERE IS NO WEAKENING IN OUR ROBUST OPPOSITION TO VIETNAMESE AMBITIONS. IN THIS WE ARE AGREED.

I HOPE THAT THERE WILL BE FUTURE OCCASIONS WHERE WE CAN AGAIN EXCHANGE OUR THOUGHTS ON THE PROBLEMS OF INDO-CHINA. THE NEED FOR A SOLUTION IN CAMBODIA GIVING THE KHMER PEOPLE THE OPPORTUNITY FREELY . TO CHOOSE THEIR OWN FORM OF GOVERNMENT IS SERIOUS, AND I SHALL CONTINUE TO GIVE IT MY FIRM SUPPORT. WITH BEST WISHES

2. IF ZHANG WENJIN SHOULD REVERT TO POINTS IN PARA 2 OF YOUR TELEGRAM 1036 YOU COULD SAY (A) THAT WE CONSIDERED THE LOSS OF EFFECTIVE CONTROL BY THE GOVERNMENT IN OCCUPIED EUROPE DURING THE WAR TO BE MERELY TEMPORARY. IN ANY CASE, AS BRITAIN WAS ENGAGED IN A WAR FOR OUR NATIONAL EXISTENCE, WE COULD NOT HAVE CONTEMPLATED CEASING TO HAVE ANY CONTACT WITH OUR ALLIES IN EUROPE, WITH WHOM WE WERE WAGING WAR AGAINST A COMMON ENEMY. THE PRESENT POSITION IN SOUTH-EAST ASIA IS ENTIRELY DIFFERENT.

3. WITH REGARD TO POINT (B) OUR DECISION AFFECTING POL POT IS INDEED BASED ON 'TECHNICAL' CONSIDERATIONS CONCERNING OUR CRITERIA FOR RECOGNITION. ANY GOVERNMENTAL DECISION IS LIABLE TO HAVE POLITICAL EFFECTS: BUT WE ARE ANXIOUS THAT OUR DECISION SHOULD NOT BE MISUNDERSTOOD. NOR SHOULD IT BE GIVEN A SIGNIFICANCE WHICH IT DOES NOT HAVE: ONLY IN THIS EVENT WILL THE VIETNAMESE FEEL GRATIFIED.
