FOLLOWING IS TEXT OF MESSAGE REFERRED TO IN M. I.P.T.

DEAR MR. CHANCELLOR,

I AM AFRAID THAT FOR BOTH OF US MY VISIT TO BONN WAS OVERSHADOWED BY THE PROBLEMS OF THE CURRENCY SITUATION, AND I AM SAD THAT THEY SHOULD HAVE OBLIGED ME TO POSTPONE MY TOUR OF BAVARIA. BUT I ENJOYED MY VISIT VERY MUCH, AND I WAS GLAD TO HAVE THE OPPORTUNITY OF DISCUSSING WITH YOU ALL THE SUBJECTS OF COMMON INTEREST TO OUR TWO COUNTRIES. IT WAS PARTICULARLY USEFUL, IF I MAY SAY SO, TO BE ABLE TO TALK OVER THE CURRENCY SITUATION WITH YOU AT A STAGE WHEN BOTH OF US WERE TAKING STOCK OF THE SITUATION AND OF POSSIBLE RESPONSES TO IT.

2. YOUR FINANCE HINISTER WILL HAVE REPORTED TO YOU THE DISCUSSIONS IN BRUSSELS OVER THE WEEKEND, AS SOON AS I ARRIVED BACK FROM BONN OH FRIDAY EVENING I WENT OVER THE GROUND WITH THE CHANCELLOR OF THE EXCHEQUER, AND I DISCUSSED IT FURTHER WITH OTHER COLLEAGUES AND AGAIN WITH HIM BEFORE HE LEFT FOR BRUSSELS. AS YOU WILL HAVE HEARD, HE ADE A STATE ENT IN BRUSSELS ON SUNDAY TO THE EFFECT THAT BRITAIN WANTED TO TAKE PART IN A COMMUNITY SOLUTION, AND WOULD BE READY TO PARTICIPATE IN AN ARRANGEMENT WHEREBY THE PARITIES OF COMMUNITY CURRENCIES MERE FIXED (WITHIN AGREED MARGINS) IN RELATION TO EACH OTHER BUT FLOATED COLLECTIVELY AGAINST OTHER CURRENCIES, PROVIDED THAT ARRANGEMENTS COULD BE MADE IN THE INTERESTS OF THE WHOLE COMMUNITY FOR THE DEGREE OF MUTUAL SUPPORT OR RESERVE POOLING ON THE LIMES YOU AND I DISCUSSED IN BOWN, AND PROVIDED THAT MEMBER COUNTRIES RETAINED FREEDOM TO CHANGE THEIR PARITIES AFTER CONSULTAT-ION WITH THE COUNCIL OF MINISTERS. THIS WILL, I UNDERSTAND, BE AMONG THE PROPOSITIONS TO BE CONSIDERED BY THE COMPETENT BODIES THIS WEEK.

3. AT DINNER AT SCHLOSS GYMENCH ON THURSDAY I REMEMBER SAYING THAT
THERE WERE TIMES WHEN POLITICAL LEADERS WERE CALLED UPON TO TAKE
GREAT DECISIONS, NOT INDEED IN SPITE OF BUT RATHER IN ADVANCE OF
THEIR OFFICIAL AND TECHNICAL ADVISERS, MECAUSE THEY RECOGNISED
POLITICAL OPPORTUNITIES FOR A DEVELOPMENT OF MAJOR STRATEGIC SIGNIFICANCE AND ADVANTAGE: AND THAT I THOUGHT THAT WE MIGHT RAPIDLY
BE APPROACHING SUCH A POINT IN EUROPEAN MONETARY AFFAIRS. FURTHER
REFLECTION SINCE WE MET HAS STRENGTHENED WE IN THIS VIEW.

4. WE AGREED - AND I GATHER THAT THIS IS ALSO PRESIDENT NIXON'S VIEW - THAT THERE IS NO EVIDENCE THAT THE PARITIES ESTALLISHED LAST OATH ALE IMAPPROPRIATE TO THE UNDERLYING ECONOMIC SITUATION EITHER THE YOUR GUN COUNTRY OR IN THE UNITED STATES, BUT HE ALSO KNOW, FROM YOUR EXPERIENCE LAST MEEK, THAT THAT IS NOT ENOUGH TO PREVENT MASSIVE MOVE ENTS OF SPECULATIVE FUNDS. IN PRESENT COMDITIONS, IF WE WANT A COMMUNITY SOLUTION WHICH PRESERVES FIXED PARITIES BETWEEN COMMINITY CURRENCIES, WE HAVE TWO CHOICES: EXTRER TO FIX OUR PARTITIES IN RELATION TO EACH OTHER AND IN RELATION TO THE REST OF THE WORLD. AND TO BE PREPARED AND ABLE TO DEFEND THOSE PARITIES AGAINST SPEC-ULATIVE ATTACK: OR TO FIX OUR PARITIES IN RELATION TO EACH OTHER AND FLOAT COLLECTIVELY IN RELATION TO THE REST OF THE WORLD. IF WE WERE TO ADOPT THE SECOND COURSE, THE ABILITY TO FLOAT AGAINST THE REST OF THE WORLD WOULD PROVIDE US WITH PROTECTION AGAINST SPECULAT-ION BASED ON NON-COMMUNITY CURPENCIES, THOUGH THERE WOULD REMAIN THE QUARTITATIVELY SMALLER RISK OF SPECULATION WITHIN THE COMPUNITY IN CO-MONITY CURRENCIES. IT SEEMS TO ME, HOMEVER, THAT A NECESSARY COMBITION OF SUCCESS OF EITHER COURSE WOULD BE THE AVAILABILITY WITHIN THE COMMUNITY OF FINANCIAL SUPPORT OF THE MOST FAR-REACHING KIND. BY THIS I MEAN MUTUAL SUPPORT ON A VERY LARGE SCALE MITHOUT LIMITS OF AMOUNT, WITHOUT COMPLETIONS AND WITHOUT OBLIGATION TO REPAY OR GUARANTEE. THIS HOULD BE TANTAMOUNT TO A VERY SUBSTANTIAL DEGREE OF MESERVE POOLING: AND, THEREFORE, SO E AT LEAST OF THE SUPPORT SHOULD BE INTEREST FREE. ONLY ON THIS HASIS COULD A COMMUNITY SYSTEM LE P. COF AGAINST SPORT-TERM CAPITAL FLO IS OF THE SIZE YOU MAYE BEN EMPERIENCING. BUT I MELIEVE THAT THE KNUMLEDGE THAT SUPPORT OF THIS KIND AND MAGNITUDE WAS AVAILABLE WOULD STEELF BE SUFFICE TENT TO DETER THE SPECULATORS, SO THAT IT COULD WELL BE THAT IT LOULD NOT IN PRACTICE HEED TO BE CALLED UPON TO HORE THAN A LIMITED EXTENT.

D. I MAS GREATLY HEARTERED WHEN YOU INDICATED TO BE THAT YOU WERE THINKING ON THESE LINES, DECAUSE IT GEEVED TO HE THAT WE WIGHT HAVE WITHIN THE COMMUNITY'S CRASP A POSSIBILITY THAT WOULD CONSTITUTE, BUT ONLY A SIGNIFICANT NEW DEVELOPMENT IN INTERNATIONAL DEFENCES AGAINST SHORT-YERM CAPITAL FLOWS, BUT ALSO A MAJOR STEP FORMARD IN THE PROGRESS OF COOPERATION WITHIN THE EMLARGED COMMUNITY. IT HAS OFTEN BEEN IN MOMENTS OF CRISIS THAT THE COMMUNITY HAS FOUND THE OPPORTMENTIES FOR MAJOR DEVELOPMENT. IT IS OUR RESPONSIBILITY, AS POLITICAL LEADERS, TO RECOGNISE THE MOMENTS WHEN SUCH OPPORTUNITIES CAN BE SEIZED. IF INDEED THIS IS SUCH A MOMENT, THE RESULTING STRENCTHENING OF THE BONDS UNITING THE COMMUNITY WOULD STAND US IN GOOD STEAD IN THE CONTING FONTHS AND YEARS. WHETHER IN OUR RELATIONS WITH THE EAST OR IN OUR RELATIONS WITH THE UNITED STATES AND JAPAN, THE COMMUNITY'S POWER TO INFLUENCE DECISIONS AND EVENTS WILL BE THE GREATER, THE ONE WRITED THE VOICE WITH MILICH THE COMMUNITY SPEAKS.

G. 1 GAT OR THAT THERE IS SOME CONCERN IN THE UNITED STATES THAT, IN SEC.ING A CUROPEAN SOLUTION, WE MAY UNWITTINGLY DAMAGE UNITED STATES INTERESTS. I HAVE TOLD THE PRESIDENT THAT THERE WILL SE PROPER CONSULTATION WITH THE UNITED STATES AND WITH THE JAMANGSE, AND I HAVE ASSUMED HIM THAT IT IS LO PART OF OUR INTENTION TO DAMAGE UNITED STATES INTERESTS. ON THE CONTARY, I BELIEVE THAT THE IMPROVE ENT OF COMESION AND COOPERATION IN THE COMMUNITY CAN ONLY INCREASE EUROPE'S STRENGTH AND USEFULNESS AS A PARTMER IN THE ATLANTIC ALLIANGE: AND I AM SUME THAT THAT IS YOUR BELIEF ALSO.

7. I SHOULD BE VERY INTERESTED TO KNOW WHETHER YOUR THINKING CONTINUES TO CORRESPOND WITH MINE AS CLOSELY AS IT CLEARLY DID WHEN ME MET. INTERNATIONAL DISCUSSION OF THESE MATTERS IS GOING TO BE INTERES OVER THE COSTING DAYS. I AM SURE THAT IT WILL BE A GREAT VALUE TO BOTH OF US AND TO EUROPE THAT ME SHOULD CONTINUE TO SHARE EACH OTHERS THINKING. AND, IF I AM SIGHT IN THINKING THAT A CREAT OPPORTUNITY IS OPEN TO US, WE MUST NOT LOSE SIGHT OF IT AMIDST THE DETAILED DISCUSSION THAT WILL OBVIOUSLY BE REQUIRED.
