cc: Mr. Adam Ridley PRIME MINISTER Doctors' and Dentists' Pay These letters from the British Medical Association and the British Dental Association ask for an assurance that the latest Report of the Review Body on Doctors' and Dentists' Pay will be implemented as soon as possible. The Report was recieved by the previous Government before Easter, but no final decisions were taken on it in the run-up to the Election. However, the previous administration did write to the B.D.A. and B.M.A. reaffirming their commitment to bring doctors' and dentists' pay "fully up to date" by April 1980, and to update the 1978 Review Body's recommendations to take account of inflation over the past year. This year's Report recommends increases of about 26 per cent on average. It also includes recommendations for the new contracts for consultants and medical assistants: these are not altogether straightforward, and this was one reason why no decisions were announced before the Election. I understand that your Party when in Opposition fully supported the previous administration's line on this issue. Mr. Jenkin# will no doubt be giving the Report his early attention, but I suggest a reassuring letter from you to the two Associations would be desirable. I attach drafts accordingly. I wrote to Mr. Callaghan on 30 March 1979 urging in the strongest possible terms that his government's decision on the DDRB's Ninth Report be published at the earliest moment. I copied my letter to your colleague Mr. Patrick Jenkin.

Subsequently, Dr. Grey-Turner, Secretary of the BMA, wrote to Mr. Callaghan on behalf of both our professions reminding him of his government's commitment to update fully the Review Body's 1978 recommended rates of pay and stressing the importance which the medical and dental professions attach to an early announcement of the Government's intentions for the implementation of the Review Body's most recent recommendations.

Mr. Ennals replied on behalf of the Prime Minister, reaffirming the then Government's intention to honour its 1978 commitment.

Mr. Patrick Jenkin wrote to me on 12 April reminding me that when the DDRB's Eighth Report was published the Shadow Cabinet undertook to honour the arrangements set out in the Eighth Report in full. The British Dental Association fully accepts these undertakings but is anxious that there should be no undue delay in correcting the anomalies in doctors' and dentists' pay which have existed now for three years. I, therefore, ask that your Government awards a very high priority to a consideration of and announcement on the DDRB's Ninth Report.

Dear Prime Minister

The previous Government received the 1979 Report of the Review Body on Doctors' and Dentists' Remuneration just before Easter. Despite repeated representations by me, your predecessor decided to leave the report to be published and decisions taken on it after the Election.
