THE MEETING TOOK A DISTINCT TURN FOR THE WORSE OVER THE WEEKEND. THE PROSPECT OF FAILURE SEEMS IMMINENT. ALTHOUGH SOME TENTATIVE CONTACTS HAD DEVELOPED BETWEEN THE LESSER INTERNAL PARTIES AND THE FRONT LINE STATES, THE DTA AND AKTUR HAD BEEN ABLE TO LET OFF STEAM ABOUT IMPARTIALITY, THERE WERE STILL NO SIGNS OF REAL PROGRESS BY SATURDAY (10 JANUARY). ON BEHALF OF THE FIVE, ALLINSON SPOKE PRIVATELY TO FOURIE TO PRESS HIM TO MEET THE FIVE FOR A SERIOUS TALK (WHICH HE HAD HITHERTO AVOIDED), FOURIE AGREED BUT POINTED OUT THAT, ALTHOUGH HE HAD PERSONALLY ADMIRED MCHENRYS SKILL AND ABILITY, THE LATTER'S NAME WAS AN IRRITANT TO THE MINISTERS. THE SOUTH AFRICAN GOVERNMENT WAS ALSO VERY ANNOYED WITH THE FRG OVER THEIR ATTEMPT, ON THE SIDE OF THE MEETING, TO WORK PRIVATELY TO GET A DEAL FOR THEIR ETHNIC MINORITY DIRECT WITH SWAPO. FOURIE ADDED THAT HE WAS DUE TO RETIRE IN OCTOBER AND HE WAS NOT GOING TO STICK HIS NECK OUT AT THIS STAGE IN HIS CAREER. HE HAD TO REPORT VERY FREQUENTLY TO HIS MINISTERS AND IN ADDITION THE DTA HAD BEEN VERY UNWILLING TO COME TO GENEVA AND MUST BE TREATED SERIOUSLY. HE ADDED THAT WHATEVER HAPPENED THERE WOULD BE A DIFFERENT FORM OF GOVERNMENT IN NAMIBIA ONE WAY OR THE OTHER BUT WOULD NOT ELABORATE ON THIS. 3. LATER ON SATURDAY THE FIVE MET FOURIE, EKSTEEN AND OTHER

3. LATER ON SATURDAY THE FIVE MET FOURIE, EKSTEEN AND OTHER OFFICIALS. FOURIE, DESPITE REPEATED DEMANDS BY US, WOULD NOT, OR COULD NOT, SAY WHETHER IF WE USED OUR GOOD OFFICES TO RESOLVE THE ISSUE OF IMPARTIALITY, OTHER PROBLEMS WOULD BE RAISED. HE WOULD NOT MISLEAD US, THE SAID, WE SHOULD SPEAK TO MUDGE AND DU PLESSIS: THEY WERE THE IMPORTANT PEOPLE. WE REMINDED HIM THAT THE SOUTH AFRICANS MUST PLAY THEIR PART TOO. FOURIE SAID HE WOULD PONDER OUR TALK AND DISCUSS THINGS THINGS WITH URQUHART ON THE SUNDAY EXPEDITION.



4. DURING THE EXPEDITION HOWEVER FOURIE HAD NOTHING SIGNIFICANT TO ADD, WHEN OTHERS IN THE SOUTH AFRICAN DELEGATION AND INTERNAL PARTIES WERE PRESSED FOR THEIR REAL REQUIREMENTS, THE IDEA OF A DECLARATION OF INTENT OR GUARANTEE WAS MENTIONED VAGUELY BUT STRESS REMAINED ON THE ISSUE OF CONFIDENCE.

- 5. UNDER PRESSURE, WHICH FINALLY HAD TO COME FROM THE UK DELEGATION OTHER EFFORTS FAILING MUDGE AGREED TO MEET THE FIVE ON SUNDAY EVENING. HE TOLD US FRANKLY THAT HE WAS ONLY WILLING TO PARTICIPATE IN AN ELECTION IF HE HAD AN EQUAL CHANCE WITH SWAPO OF WINNING, AND DID NOT BELIEVE THIS WAS POSSIBLE UNLESS HE HAD MORE TIME THE CLEAR IMPLICATION WAS YEARS RATHER THAN MONTHS. HE PROFESSED SOME INTEREST IN SUGGESTIONS OF AN ENHANCED IMPARTIALITY PACKAGE WITH THE IMPLEMENTATION DATE PUT BACK FOR A MONTH OR SO, AND PROMISED TO TALK TO US AGAIN ON MONDAY (QW JANUARY) AFTER FURTHER REFLECTION.
- G. THE FIVE THEN MET DU PLESSIS AND VAN ZYL OF AKTUR.

  DU PLESSIS WAS FEELING ILL AND THE MEETING ENDED INCONCLUSIVELY BUT IT WAS ABUNDANTLY CLEAR THAT AKTUR WANTED GUARANTEES
  FOR ETHNIC MINORITIES ( TO THE EXTENT OF THE OLD VETO POWER
  FOR EACH RACIAL GROUP IN THE TURNHALLE CONSTITUTION ) BESIDES
  WISHING FOR FURTHER IMPARTIALITY MEASURES, AND TO RAISE
  QUESTIONS ABOUT DMZ AND OTHER MATTERS. THEY PROFESSED NOT
  TO WANT TO WRECK THE MEETING BUT THEIR VIEWS WERE SUCH AS
  TO PUT THEIR PRESENCE HERE IN QUESTION.
- 7. URQUHART HAS TOLD US IN CONFIDENCE THAT FOURIE IS
  EXTREMELY DEPRESSED AND SAYS THAT IMPARTIALITY MEASURES ALONE
  WOULD NOT MEET THE CASE AND GUARANTEES FOR MINORIES BY THE
  FRONTLINE STATES, OAU, NIGERIA, AND SOUTH AFRICA ARE
  NEEDED . URQUHART IS CONTEMPLATING CUTTING THE MEETING SHORT
  TODAY SINCE HE SEES NO WAY OUT, AND HAS TOLD FOURIE SO.
  B. THE FIVE HAVE REVIEWED THE SITUATION AND CAN SEE LITTLE
  HOPE OF PROGRESS NOR EVEN HOW TO BRING THE PIM TO A CLOSE
  WITHOUT DESTROYING THE WHOLE INITATIVE.
- 9. THE FIVE WILL MAKE ANOTHER EFFORT WITH FOURIE THIS MORNING POINTING OUT THAT NEITHER MUDGE NOR DU PLESSIS HAS RESPONDED TO OUR APPROACH (AS SUGGESTED TO US BY FOURIE) IN A WAY WHICH OFFERS ANY REAL HOPE OF PROGRESS. WE WILL
- GO OVER OUR ENHANCED IMPARTIALITY PACKAGE ORALLY BUT IN MORE DETAIL WITH HIM AND PRESS HIM TO GET HIS SIDE'S AGREEMENT TO 1T.
- 10. AT THE SAME TIME REPRESENTATIVES OF THE FIVE HERE RECOMMEND AN URGENT MESSAGE (MIFT) FROM HEADS OF GOVERNMENT TO THE SOUTH AFRICAN PRIME MINISTER SINCE THE PIM APPEARS TO BE IN GRAVE

DURING THE COURSE OF THE DAY WE SHALL BE CONSIDERING, AS IS URQUHART, IF THERE IS ANY WAY IN WHICH THE PIM CAN BE BROUGHT TO A CLOSE ON 14 JANUARY IN A WAY WHICH WOULD PRESERVE THE GROUND GAINED IN PREVIOUS ATTEMPTS AND ALSO THE UNDERSTANDING AND GOODWILL OF THE FRONT LINE STATES. FOR THE MOMENT NO EFFECTIVE ANSWERS HAVE SURFACED.
