## ANGLO/MALAYSIAN RELATIONS

1. WE HAVE BEEN INFORMED THAT AT THE CABINET MEETING ON 30 MARCH
THE DECISION WAS TAKEN TO LIFT RESTRICTIONS ON BRITISH COMMERCIAL
COMPETITION FOR CONTRACTS IN MALAYSIA AND TO IMPROVE THE CLIMATE
OF POLITICAL RELATIONS WITH THE UK. THIS DECISION WAS A DIRECT
OUTCOME OF THE VERY SUCCESSFUL MEETING WITH MRS THATCHER. THIS
INFORMATION WAS GIVEN TO US IN CONFIDENCE BY A MEMBER OF THE
CABINET.

- 2. WE UNDERSTAND THAT THE DECISION IS EXPLICIT AND THAT INSTRUCTIONS HAVE ALREADY BEEN ISSUED TO THE UNIT IN THE PRIME MINISTER'S DEPARTMENT RESPONSIBLE FOR EXAMINING CONTRACTS. BRITISH BIDS WILL IN FUTURE BE TREATED EQUALLY WITH OTHERS AND THE QUOTE BUY BRITISH LAST UNQUOTE POLICY HAS BEEN ABANDONED. IT IS UNLIKELY THAT A FORMAL STATEMENT WILL BE MADE WITHDRAWING THE DIRECTIVE BUT WE ARE ASSURED THAT A SUITABLE MESSAGE TO THIS EFFECT WILL BE PASSED DOWN THE LINE.
- 3. WE ALSO UNDERSTAND THAT AN INVITATION TO THE PRIME MINISTER
  TO VISIT MALAYSIA AS THE GUEST OF THE MALAYSIAN GOVERNMENT IS
  BEING PASSED TO NO 10 THROUGH THE MALAYSIAN HIGH COMMISSION. THE
  MALAYSIANS HOPE THAT MRS THATCHER MAY HAVE AN OPPORTUNITY TO VISIT
  MALAYSIA THIS YEAR, PERHAPS AFTER CHOGM IN NEW DELHI IN NOVEMBER.
