INDUSTRIAL ACTION IN THE COAL INDUSTRY

The Group received a number of oral reports.

THE SECREPART OF STATE FOR ENERGY said that more than 3,300 strikers had returned to work during the previous week. More than 900,000 tonnes of coal had been moved, including the best rail movements of coal since June 1984. The number of new faces reported that day - 892 so far - was high, considering that talks were to resume on the following morning.

The National Coal Board (NCB) thought the following day's preliminary meeting likely to agree a basis for substantive talks with the whole of the National Union of Mineworkers (NUM) National Executive. The Board would require a written record of the meeting to be agreed. Although Mr Scargill was under considerable pressure from within the union, it remained doubtful whether he would compromise his personal stance on uneconomic pits. The drift back to work was expected to resume on a large scale if talks broke down.

THE ATTORNEY GENERAL said that Nobis Financ, the bank holding NUM funds in Luxembourg, was under pressure from the Luxembourg Government not to release the funds to the sequestrators; but this pressure did not, as previously thought, include a threat to the bank's licence.

THE PRIME MINSTER, summing up the discussion, said that it was necessary to wait for the outcome of preliminary talks the next morning between the NCB and NUM. It would be most important in the interests of avoiding future conflict that the terms of any settlement which might eventually result should be clear.

LOCAL AUTHORITY ASSISTANCE TO THE NATIONAL UNION OF MINEWORKERS

The Group considered a Note by the Secretaries (MISC 101(85) 1) covering a Note by the Department of Energy on local authority assistance to the National Union of Mineworkers (NUM).

THE SECRETARY OF STATE FOR THE ENVIRONMENT said that the information attached to MISC 101(85) 1 had been obtained from a number of diverse sources, including the press. There was no evidence of direct financial assistance to the NUM by local authorities. Assistance, much of it in kind, had, however, been provided for purposes connected with the strike. Where assistance had been given, it had often aroused very great local controversy, but there were no clear legal grounds for achien against councillors for acting improperly. The statutory powers on which achievities appeared to be relying - Section 137 of to Local Government Act 1972 and Section 85 of the Local Government (Scotland) Act 1975 - came within the score of the inquiry he had set up into local authorities procedures and practices, and he proposed that they should be re-examined in the light of its conclusions.

THE PRIME MINISTER, summing up a brief discussion, said that Departments should proceed as proposed by the Secretary of State for the Environment.

The Group -

Took note, of the Prime Minister's summing up of their discussion, and invited the Secretaries of State for the Environment, Scotland and Wales to be guided accordingly.
