A EUROPEAN SECURITY STUDY . My dear Frank.

As you will know, there is a considerable interest in what are called 'alternative strategies'. The ideas being mooted vary from totally unrealistic ones, involving abolition, not only of nuclear weapons, but also of conventional armed forces of the current pattern, to sensible concepts of how to improve the capability of conventional forces without involving unrealistic demands on manpower and money. The motive behind all of them is to reduce NATO's reliance on the early use of nuclear weapons.

I have agreed to be a member of the Steering Group of an American sponsored project, which seems to me to be the most responsible of these. Its moving spirit is Professor Carroll Wilson of the Massachusetts Institute of Technology, who was formerly executive officer to Dr Vannevar Bush, for many years head of the U.S.Research and Development Board.

The project is appointing a Director of Studies, who will probably be a retired US officer, with a permanent staff, who, under the general direction of the Steering Group, will produce a number of papers. They will work at the American Academy of Arts and Sciences. Their papers will be considered at a series of 'workshops', with the aim of producing a final report in January 1984.

The study is restricted to NATO's Central Region, and does

not therefore involve maritime warfare.

It is hoped to raise the necessary funds from a number of

American foundations and individual sources.

A perusal of the premises on which the studies will be based (Annex A) and of the list of current and prospective members of the Steering Group (Annex B) will, I hope, persuade you that this is a thoroughly responsible and worthwhile

project. I would be grateful if you and your subordinates would be prepared to help this project when it gets under way.

That the scale, diversity, and destructive power of especially of the USA and the USSR, are not yet adequately comprehended by the public or by national

- capability changing from inability to strike the USA in the 1950's to full parity in numbers and types of nuclear weapons and delivery systems - plus superiority in theatre nuclear weapons in Europe in 1981 - have not yet been adequately assessed.
- That the reliance in NATO strategy on early use of tactical nuclear weapons to repel a Soviet invasion represents the most serious risk of nuclear weapons use either initiated by NATO or preemptively by the Soviets.
- That use of such tactical nuclear weapons could certainly escalate to use of theatre nuclear weapons and then to a strategic exchange causing tremendous destruction of Europe, North America and the USSR and leaving survivors in chaos.
- That potentials exist which have not been adequately 5. exploited to substantially strengthen NATO defenses against conventional mechanized forces.
- That stronger NATO conventional strength would be 6. a significant deterrent to a Soviet attack and could provide a relatively more useable war-fighting force capable of exacting a heavy toll of an attacker's forces in the event of an attack.
- That a study of such potentials with special attention to scenarios for such strategies on the Central Front should be undertaken.

- 8. That such a study can be validly done without disclosure of classified information and therefore can be published in order to encourage wide public discussion.
- 9. That channels of communication can be established for informal consultation with appropriate branches of the armed forces of several NATO countries as well as with NATO and SHAPE.
- 10. That qualified individuals can be enlisted to take part in such a project in various roles.
- 11. That upon completion of such a study there is likely to be sufficient interest in some NATO countries in improved strategies to justify the time and effort involved in making such a study.
