SUMMARY

. ADDEFENDING AS THE MEANED BETWEEN THE GOVERNMENT, PHOLORED AND WHINDS ON THE LEVEL OF PAY SETTLEMENTS FOR 1900 AND 1990, INCLUDING A REDUCTION IN VACE HOREATION (THE SCALE MOBILE SYSTEM). THIS SHOULD LESSEN THE SOCIAL TRESION WHICH HAS GIVEN PIET TO STRIKES AND BETWASTRATIONS THROUGHOUT ITALY. IT GIVES FARFAMIN'S GOVERNMENT A DALLY MEEDED DOOST.

TO SECURE AGREEMENT, MOLEKER, THE GOVERNMENT HAD TO PROTISE
OF CONCESSIONS ON PUBLIC UTILITY TARPES, EXPENDITURE CUTS, ETC.,
UNICH WILL HARE IT HARBER TO ACHIEVE THE PUBLIC PERS ECLIPIO OF
71,000 BILLION LIRE. THERE WILL STILL BE DIFFICULTIES IN GETTING
THE 1933 ECONOMIC PROGRAMME THROUGH PARLIAMENT.

3. ON 22 JANUARY, TWO DAYS AFTER THE GOVERNMENT'S ORIGINAL DEAD-LINE, SCOTTI (UNINISTER OF LABOUR) PUT FORWARD A TAKE IT OR LEAVE IT PROPOSAL TO EMPLOYERS AND UNIONS. IT AIMED TO SHIMD DOWN THE AVERAGE RISE IN PAY IN THE MEXT TWO YEARS TO WITHIN THE GOVERN-MENT'S TARGETS FOR IMPLATION IN 1998 (13 PC) AND 1994 (10 PC). ITS MAIN FEATURE IS A REDUCTION OF AT LEAST 15 PC IN THE SCALA MORILE SYSTEM OF WAGE INDEXATION, WITH SOME PEVISION OF THE WAY THE SYSTEM OPERATES. THIS PROPOSAL BRIDGED WHAT MED APPEARED TO BE A WIDE GAP BETWEEN THE UNIOUS (ORIGINALLY UNMILLING TO CONCESSE MORE THAN 10 PC) AND THE EMPLOYERS (WHO LAST WEEK WEEK WITE STILL MAKING JO PC THEIR NIM-WIND DEMAND). AGREEMENT HAS ALSO BEEN BEACHED ON A CEILING FOR SECTIONAL CONTRACTS OVER THE IDENT THESE YEARS.

4. NEITHER SIDE FOUND IT EASY TO ACCEPT SCOTTI'S COMPROMISE SOLUT-

5. FOR THE HOMENT, NO COALITION PARTY IS PREPARED TO CHITCHISE
HAVE AGREEMENT THAT HAS DEEN REACHED. THE PCI PERCOTOR HAS SEEN
HOTED, FOR SCOTT IT HAS PROVED SOMETHING OF A PERSONAL TRIUMPH,
AND FARFAN IS DEVIOUSLY PELIFYED. ONLY THE MEDIUMICANS, FOR
LECTORAR REAGONS, MANE DESCRIPED THE AGREEMENT AS IMMEDIUMIE.

6. TO SEQUEE THE AGREEMENT, THE COMERNISHET HAS MADE CONCESSIONS IN PLANIED PUBLIC EXPENDITURE CUTS AND TARIFF SUPSIDIES, WHICH WILL NOT HELP ITS EFFORT TO LINIT THE 1983 PERS TO 71,000 SILLION LIRE. THESE CONCESSIONS, WHICH DID NOT TO SMETTER THE PILL FOR THE WHONS, WILL REED TO BE PALANCED BY NEW COTS AND SAVINGES IN THE 1993 SUPDET WHICH, LIKE THE DECREEK/JANUARY ECONOMIC PACAGE (NY TELEGRAY NO.
