THE MINISTERS WARNED WITH CONCERN THAT IN SOUTH AMERICA THERE  
REMAIN FOCUSES OF TENSION BECAUSE OF A COLONIAL PRESENCE IN  
THE SOUTH ATLANTIC, THE DISPUTES INVOLVING SEVERAL COUNTRIES IN  
THE REGION, THE CONTINUOUS DIFFICULTIES BEING FACED BY SOME OF  
THOSE COUNTRIES TO ACHIEVE DEVELOPMENT AND THE EXISTENCE OF  
MILITARY AND POLITICAL COOPERATION BETWEEN SOME OF THE COUNTRIES

~~THE REGION, THE CONTINUOUS DIFFICULTIES BEING FACED BY SOME OF THOSE COUNTRIES TO ACHIEVE DEVELOPMENT AND THE EXISTENCE OF MILITARY AND POLITICAL COOPERATION BETWEEN SOME OF THE COUNTRIES IN THE REGION AND THE APARTHEID REGIME IN SOUTH AFRICA AND THE ZIONIST REGIME IN ISRAEL~~

THE MINISTERS REITERATED THEIR SUPPORT FOR THE DECISION REACHED AT PREVIOUS CONFERENCES AND MEETINGS OF THE NONALIGNED COUNTRIES MOVEMENT TO SUPPORT THE RIGHT OF THE REPUBLIC OF ARGENTINA TO HAVE ITS SOVEREIGNTY OVER THE MALVINAS ISLANDS RESTORED THROUGH NEGOTIATIONS., THEY ALSO REAFFIRMED THE NEED FOR THE PARTIES INVOLVED TO GIVE DUE CONSIDERATION TO THE INTERESTS OF THE INHABITANTS OF THE ISLANDS.

THEY RECALLED THAT THE STRUGGLE AGAINST COLONIALISM, NEOCOLONIALISM, IMPERIALISM, HEGEMONISM, APARTHEID, AND RACISM AND ALL KINDS OF FOREIGN DOMINATION; FULL RESPECT FOR SOVEREIGNTY AND ALL KINDS OF FOREIGN DOMINATION; FULL RESPECT FOR SOVEREIGNTY AND TERRITORIAL INTEGRITY; THE ABSTENTION FROM THE USE OR THE THREAT OF FORCE; AND THE PEACEFUL SOLUTION OF DISPUTES ARE BASIC PRINCIPLES OF THE NONALIGNED MOVEMENT.

THE MINISTERS RECALLING THE STATEMENTS MADE IN THE FINAL COMMUNIQUE OF THE MINISTERIAL MEETING OF THE COORDINATING BUREAU HELD IN HAVANA IN 1982 , RECOGNISED THAT THE MALVINAS, SOUTH GEORGIA AND SOUTH SANDWICH ISLANDS ARE INTEGRAL PARTS OF LATIN AMERICA; AND IN THIS REGARD THEY EXPRESSED THEIR PLEASURE OVER THE SOLIDARITY AND THE FIRM SUPPORT THAT THE LATIN AMERICAN AND OTHER NONALIGNED COUNTRIES GAVE TO ARGENTINA IN ITS EFFORTS TO SOLVE THAT DISPUTE AND PREVENT THE CONSOLIDATION OF THE COLONIALIST SITUATION THAT EXISTS IN THOSE ISLANDS.

THE MINISTERS SAID THAT THE WAY TO DECOLONIZE THE TERRITORIES INVOLVED IN THE MALVINAS CASE IS TO ARRIVE AT A SOLUTION TO THE SOVEREIGNTY DISPUTE BETWEEN THE ARGENTINE AND BRITISH GOVERNMENTS. THEY URGED BOTH PARTIES TO RESUME NEGOTIATIONS WITH THE GOOD OFFICES OF THE UN SECRETARY GENERAL IN ORDER TO ARRIVE AS SOON AS POSSIBLE AT A JUST, PEACEFUL AND PERMANENT SOLUTION TO THE CONFLICT IN CONFORMITY WITH THE PRINCIPLES AND DECISIONS OF THE NONALIGNED MOVEMENT , RESOLUTION 1514, 2065 AND 3160 OF THE GENERAL ASSEMBLY AND SECURITY COUNCIL RESOLUTIONS 502 AND 505.

THE MINISTERS FELT THAT THE MASSIVE MILITARY AND NAVAL PRESENCE AND THE ACTIVITIES OF THE UNITED KINGDOM IN THE AREA OF THE MALVINAS ISLANDS ARE CAUSE FOR SERIOUS CONCERN TO THE COUNTRIES OF THE REGION AND HAVE AN ADVERSE EFFECT ON THE REGION'S STABILITY.
