Sear hickard,

Thank you for your letter of 8th March 1985 regarding Rating and Revaluation in Scotland.

While the statement in the House of Commons by the Secretary of State for Scotland announcing a 3p increase in domestic rate relief was welcome and we are making the most of it, it has done little to stem the flow of critical hostility towards the Party.

As an example of what is happening I enclose the front page of yesterday's Sunday Post, a letter from Councillor William Aitken, past leader of the Conservative Group on Glasgow District Council and a few other sample letters, all of which have been acknowledged. As I say, these are merely samples of constant adverse press and media publicity and hundreds of letters from domestic and commercial rate payers. Even industry is mainly critical - the few gainers seem to keep silent!


I hope we can soon find the breakthrough on a system of financing local government. Meanwhile we shall do what we can.
