#### 5. Central Council Meeting - Newcastle Upon Tyne.

The Secretary reported on the Central Council meeting held on 22nd/23rd March (a copy of the report is annexed to the minutes). The meeting agreed to record its thanks to the Northern Area for their warm welcome and hospitality on this occasion.

## 6. Rt. Hon. Nicholas Ridley M.P., Secretary of State for Transport

The Chairman then welcomed Mr. Ridley who addressed the meeting on current topics and especially the Buses Bill presently before Parliament. After answering a number of questions, the Chairman thanked Mr. Ridley for his attendance and speech, and Mr. Ridley left the meeting.

#### 7. Property Review.

The Chairman invited Sir Oulton Wade J.P., Joint Treasurer of the Party, to speak on the recent report produced by a Committee under the Chairmanship of Mr. Michael Craig-Cooper. Sir Oulton suggested, and it was agreed, that the report should be circulated to all members of the General Purposes Committee for consideration at the next meeting.

# 8. Standing Review Committee.

Sir Donald Walters, the Chairman of the Standing Review Committee, reported on a meeting which had taken place earlier in the day. The Committee was reviewing the National Union Rules and would report in detail later, but they had made a firm recommendation regarding affiliation fees to the National Union as following:

- a) Associations. Fee to be increased from £10 p.a. to £40 p.a. for which in future they would receive the full literature service, worth £30 p.a.
- b) Other Recognised Bodies. Fee to be increased from £5 to £20, but this would not include the literature service.

The Committee approved these increases, to start in 1986.

9. Social Affairs Forum.

Dame Joan Seccombe reported on the discussion for setting up a third Forum covering Social Affairs, and recommended that this be approved by the National Union.

After some discussion on the proposed title for the Forum and the essential need for the Forum to operate at Area as well as National level, the Committee approved nem. con. the setting up of the Forum with Dame Joan Seccombe as its Chairman.

10. Federation of Conservative Students.

The Chairman reported on the events arising from the F.C.S. Conference at Loughborough and read the terms of the proposed motion to set up an enquiry.

Several members of the Committee contributed to the

"This Committee agrees to set up a Committee of Enquiry to investigate the events at the 1985 Loughborough Conference of the F.C.S. and to examine whether the organisation of F.C.S. meets the aims and objects of the National Union, and to make recommendations."

# 11. County Council Elections.

Mr. John Heddle, M.P., Chairman of the Local Government Advisory Committee, reported on the County Council Election Campaign. Mr. John Selwyn Gummer M.P., Chairman of the Party Organisation, stressed the importance of these elections.

# 12. Resolutions from Constituency, Area and Other Organisations.

Seven Resolutions were circulated with the notice, and a further four in a supplementary agenda, which are annexed to these minutes. The Chairman's actions were approved.

# 13. Party Conference - Blackpool, 8th - 11th October 1985.

The Chairman gave a brief report on plans to date. A further meeting with Lancashire Police was to be held shortly.

The meeting agreed that Mr. Jeffery Archer be invited to make the financial appeal at the Conference.

#### 14. Business for the Next Meeting.

The next meeting will be held on 13th June and Mr. Norman Fowler M.P. had agreed to address it.

There being no further business, the meeting closed at 4.15 p.m.
