4. DURING APRIL 16 MEETING BETWEEN DCM AND MFA AMERICAN AND OCEANIAN AFFAIRS DEPARTMENT DIRECTOR ZHANG WENPU DCM RAISED THIS UNBALANCED COVERAGE. DCM SAID HE WISHED TO ECHO THE AMBASSADOR'S APRIL 15 EXPRESSION OF DISAPPOINTMENT AT THE UNBALANCED CHINESE PUBLIC STATEMENT, WHICH CRITICIZED THE US WHILE ONLY BRIEFLY MENTIONING TERRORISM. THE US HAD PRACTICED GREAT FORBEARANCE IN THE FACE OF YEARS OF OUTRIGHT TERRORIST ACTIONS PERPETRATED BY QADHAFI AND HIS REGIME, RESULTING IN THE BRUTAL MURDER OF CITIZENS OF MANY COUNTRIES. THE US HAS CONCLUSIVE EVIDENCE OF LIBYAN INVOLVEMENT IN WHAT HAPPENDED IN BERLIN. ZHANG RESPONDED THAT "YOU MUST HAVE TAKEN NOTICE THAT IN OUR STATEMENT WE EXPLAINED IN VERY CLEAR TERMS THAT WE ARE AGAINST AND OPPOSED TO ANY FORM OF TERRORISM. WE JUST DON'T THINK YOUR WAY OF RETALIATION IS THE WAY OF DOING THINGS." DCM REITERATED STRONG US DISAPPOINTMENT AT THE CHINESE POSITION.

COMMENTS TO VICE FOREIGN MINISTER ZHU ON EMBASSY SECURITY, AND ASKED IF THE CHINESE HAD BEEN ABLE TO MEET EMBASSY REQUESTS, INCLUDING THE HIRING OF LOCAL GUARDS. ZHANG RESPONDED THAT ZHU HAD PHONED HIS COUNTERPART AT THE MINISTRY OF PUBLIC SECURITY SHORTLY AFTER HIS MEETING WITH THE AMBASSADOR. THE LATTER "ATTACHES GREAT IMPORTANCE TO THE EMBASSY MESSAGE," ZHANG SAID, STATING THAT THE EMBASSY WOULD RECEIVE A RESPONSE IN A SHORT PERIOD OF TIME.
