2. BOOK FAIR AUTHORITIES HAD BEEN NOTIFIED AT APPROXIMATELY SEVEN P.M. THAT SUCH A DEMONSTRATION WOULD TAKE PLACE. BOOK FAIR PRESIDENT CASTIGLIONE PERSONALLY WENT TO THE STAND AND STOOD ALONGSIDE U.S. AND ARGENTINE EMPLOYEES FOR THE DURATION OF THE DEMONSTRATION. RBO EDWARD FRANCO AND CULTURAL SPECIALISTS FEDERICO GONZALEZ DEL PINO AND ALICIA FERREIROS WERE IN THE STAND AT THAT TIME.

3. THREE POLITICAL GROUPS WERE IDENTIFIED AS ORGANIZERS OF THE DEMONSTRATION FROM LEAFLETS THEY DISTRIBUTED: THE COMMUNIST PARTY'S YOUTH SECTION, THE "MOVEMENT TOWARD SOCIALISM," AND THE REVOLUTIONARY WING OF THE JUSTICIALIST (PERONIST) PARTY. THE LAST, CLAIMING TO REPRESENT THE "MONTONERO" GUERRILLA UNITS ACTIVE IN THE CIVIL STRIFE OF THE LATE 1960S AND 70S, RECENTLY ANNOUNCED ITS COMEBACK AS A LEGITIMATE POLITICAL ENTITY WITHIN THE PERONIST PARTY.

4. THE ONLY VIOLENT ACT OCCURRED WHEN A VISITOR TO THE STAND CALLED ON THE DEMONSTRATORS TO QUOTE PROTEST WHAT IS HAPPENING IN AFGHANISTAN UNQUOTE. THE VISITOR WAS SHOVED INTO THE CROWD BY AN UNKNOWN PERSON, WITH THE RESULT THAT THE CROWD SURGED FORWARD KNOCKING OVER A DECORATIVE COLUMN WHICH SLIGHTLY INJURED HIM AND A YOUNG UNCLASSIFIED

BRITISH ACTRESS JULIE CHRISTIE, CURRENTLY STARRING IN A FILM BEING SHOT IN ARGENTINA, WAS IN THE FOREFRONT OF THE DEMONSTRATORS, SHOUTING ANTI-U.S. SLOGANS IN ENGLISH -- ONE WAS "DEATH TO REAGAN" -- AND OBVIOUSLY ENJOYING THE SCENE. CURIOUSLY, CHRISTIE HAD VISITED THE STAND ABOUT 30 MINUTES PRIOR TO THE DEMONSTRATION AND HAD CHATTED AMIABLY WITH THE WIFE OF ACAO NICOLAS ROBERTSON.

6. AS THE DEMONSTRATORS LEFT THE FAIR GROUNDS THEY REMOVED THE U.S. FLAG FROM THE ROW THAT INCLUDED THE STANDARDS OF THE PARTICIPATING COUNTRIES AND PROCEEDED TO BURN IT AS THE CHANTING OF SLOGANS CONTINUED.

7. FAIR AUTHORITIES HAVE INFORMED POST THAT THERE WILL BE ANOTHER DEMONSTRATION ON SUNDAY APRIL 20, OFFICIALLY DESIGNATED AS "U.S. DAY" AT THE FAIR. EVERY COUNTRY REPRESENTED HAS A SPECIAL "DAY", WHOSE OFFICIAL PROGRAM
