2. THE RESULT OF THE MEETINGS OVER THE PAST TWO DAYS IS:

ARMS EMBARGO

THE TEN HAVE DECIDED TO IMPOSE A COMPLETE EMBARGO ON THE EXPORT OF ARMS AND MILITARY EQUIPMENT TO ARGENTINA.

TRADE

THE COMMUNITY HAS AGREED TO IMPOSE A COMPLETE EMBARGO ON ALL IMPORTS FROM ARGENTINA. THIS WILL COME INTO EFFECT AS SOON AS THE NECESSARY LEGAL TEXTS HAVE BEEN STUDIED IN CAPITALS AND APPROVED BY THE NORMAL PROCEDURES. BUT THE DECISION TO IMPOSE THE EMBARGO HAS BEEN TAKEN.

GSP

MEMBER STATES HAVE AGREED IN PRINCIPLE TO SUSPEND ARGENTINA FROM THE BENEFITS OF THE COMMUNITY'S GSP. AGAIN THE IMPLEMENTING TEXTS ARE BEING STUDIED AND ARE LIKELY TO BE APPROVED NEXT WEEK.

EXPORT CREDIT GUARANTEES

THIS IS A MATTER FOR NATIONAL ACTION. A MAJORITY OF MEMBER STATES HAVE INDICATED THAT THEY WILL NOT BE PROVIDING NEW EXPORT CREDIT GUARANTEES. OTHERS STILL HAVE THE MATTER UNDER CONSIDERATION. FURTHER DISCUSSION IS LIKELY NEXT WEEK.

MOST MEMBER STATES HAVE REPORTED THAT, ON THE BASIS OF CONTACTS WITH BANKS IN THEIR COUNTRIES, THE PROVISION OF NEW LOANS TO ARGENTINE BORROWERS IN PRESENT CIRCUMSTANCES IS MOST UNLIKELY.
