- 1. THE FEDERAL ECONOMICS MINISTER, GRAF LAMBSDORFF, WHILL BE
 VHISHTIME LONDON ON 1 NOVEMBER AGAINST A BACKGROUND OF
 GROWING SPECULATION HERE THAT HE MAY SOON HAVE TO RESIGN
 BECAUSE OF HIS ALLEGED HINVOLVEMENT IN A LONG-RUNNING SCANDAL
 HINVOLVENG THE FINANCING OF THE POLITICAL PARTIES. THE FRANKFURTER
 ALLGEMENNE ZENTUNG OF 26 OCTOBER HAS REFUELLED SPECULATION BY
 REPORTING ON MITS FRONT PAGE THAT THE QUESTION OF A SUCCESSOR
 HIS UNDER ACTIVE CONSHIDERATION.
- 2. FOR ALMOST TWO YEARS, THE BONN PUBLIC PROSECUTOR HAS BEEN INVESTIGATIONS ALLEGATIONS THAT A NUMBER OF LEADING POLINTAINCHANS FROM THE THREE MARIN PARTIES, MINCLUDING LAMBSDORFF, MIMPROPERLY ACCEPTED FRINANCHAL CONTRIBUTIONS FOR PARTY PURPOSES FROM A LEADING GERMAN COMPANY, FLACK. IN ADDITION, LAMBSDORFF, MIN HAS CAPACITY AS ECONOMICS MANNESTER, MIS ALLEGED TO HAVE GRANTED FLACK A HUGE TAX EXEMPTION OF RETURN FOR DONATHONS TO THE FDP. LAMBSDORFF AND THE OTHERS MINVOLVED HAVE CONSTITUTED PONNED THESE ALLEGATIONS.
- 3. THE CHANCELLOR'S PRESS ADVISER ACKERMANN, WHO HIS ONE OF HIS CLOSEST CONFIDENTES CONFIDENTED TO US THIS WEEK THAT THE PUBLIC PROSECUTOR HAD DECIDED TO BRING FORMAL CHARGES AGAINST ABOUT 6

 PEOPLE INVOLVED IN THE AFFAIR, MINCLUDING LAMBSDORFF AND TWO FORMER SPD FINANCE MINISTERS, MATTHOEFER AND LAHNSTEIN. THE PRESS ARE SPECULATIONG THAT THE PUBLIC PROSECUTOR WILL MAKE KNOWN HIS DECISION BY THE END OF THIS WEEK, BUT THE FEDERAL CHANCELLERY EXPECT THIS TO SLOP UNTIL THE END OF NOVEMBER. IN THE PUBLIC PROSECUTOR DOES BRING CHARGES, THE NEXT STEP WILL BE FOR THE COURT CONCERNED TO DECIDE WHETHER TO PROCEED WITH A TRIVAL. THERE COULD BE SEVERAL WEEKS BETWEEN THE PUBLIC PROSECUTOR'S DECISION AND A DECIDENON BY THE COURT.
- 4. THE GENERAL VIEW HERE IS THAT LAMBSDORFF COULD REMAIN IN OFFICE
 HE THE PUBLIC PROSECUTOR BROUGHT CHARGES BUT THAT HE WOULD
 HAVE TO RESIGN WERE THE COURT TO OPEN THE TRIAL. BOTH ACKERMANN,
 AND THE MINISTER OF STATE AT THE FEDERAL CHANCELLERY, WHO HIS ALSO
 A KEY MEMBER OF THE CHANCELLOR'S KINTCHEN CABINET, HAVE HOWEVER TOLD
 US THAT THE PUBLIC PROSECUTOR EVIDENCE HIS FLORMSY

AND THAT HIS THEREFORE NOT CERTAIN WHETHER A COURT WHILL DECHIDE TO TRY THOSE CHARGED. THEY MAY WELL BE RHIGHT. BUT THE CRHITERHA USED BY THE PUBLIK PROSECUTOR HIN BRHINGHING CHARGES AND BY THE COURT HIN OPENING PROCEEDINGS ARE BROADLY SHIMPLAR, AND HIT HIS UNUSUAL FOR THE COURT NOT TO OPEN PROCEEDINGS HE THE PROSECUTOR BRHINGS A CHARGE.

5. AT THIS STAGE, NO-ONE REALLY KNOWS WHETHER LAMBSDORFF WHAL HAVE TO RESIGN. BUT BOTH CDU AND FDP PARTY HEADQUARTERS ARE TAKNING THE POSSIBLITY HINCREASHINGLY SERMOUSLY. FOR ALL THE CONFIDENCE ON THOSE AROUND THE CHANCELLOR THAT LAMBSDORFF WHAL BE ABLE TO HANG ON, HAT HIS ALSO CLEAR THAT THEY ARE GRAVING MINCREASHING THOUGHT TO POSSIBLE SUCCESSORS. STRAUSS MINGHT LIKE THE ECONOMICS MINNESTRY, AND THE CSU HAVE ALREADY LAND CLAIM TO HET SHOULD LAMBSDORFF.GO.

BUT THE CHANCELLOR WHAL WANT TO KEEP STRAUSS AT BAY AND SHOULD HAT EVER COME TO THE POINT, HIS LIKELY TO PREFER AN FDP SUCCESSOR.
