

Talks with the POA I understand from the Home Offfice that this morning's talks went as well as can be expected. They are to be resumed next Wednesday, and no significant industrial action or other trouble is at present expected over the holiday weekend. In brief, the discussion turned largely on the suspension of 3. prison officers who had disobeyed orders, and procedures for the resumption of talks on the Home Secretary's 22 April letter. the former, the POA agreed to resume normal working on the understanding that, if they did so, the suspensions would be lifted. On the latter, the POA seem anxious to find some way of resuming discussion, provided the Home Office for their part clarify and expand certain proposals in the 22 April letter. There is a certain amount of ritual dancing in this, but the Home Office believe it might provide the POA with the excuse to have another ballot which would get them off the hook of the previous ballot result by which they are currently bound. 4. So far then, so good. There seems a good chance that we shall have a calm period; but we have made stand-by arrangements for contacting and convening officials and Ministers should that prove necessary over the weekend. Temporary Prisons

5. The Ministry of Defence have moved quickly and I understand that Rolleston camp will be ready by next Tuesday night. MOD are also today identifying a second camp, which is likely to be Proteus, near Nottingham. The related emergency Bill to provide powers inter alia to use these camps is also ready and could be introduced the moment it was required (on the usual procedures it would take 3 days to pass, but the Chief whip said last night that in an emergency it could be put through in one day).

 BY INSTITUTING THE LARGEST PRISON BUILDING PROGRAMME IN HISTORY.



TF seen OUTCOME OF NEGOTIATIONS WITH POA: 2 MAY 1986 The Prison Officers' Association (POA) agrees that in calling for 1. the suspension of industrial action they were calling on their members to resume normal working. At the national level the Home Office confirms that return to normal working means that the suspensions from duty are lifted. Both sides agreed that the series of talks which the Home Office 2. are now holding with the POA are designed to work towards a position where there can be simultaneous calling off of industrial action and the discussion of an agenda for the future: before that simultaneous action can take place, however, there has to be clarification of the Home Secretary's letter of 22 April. The POA have indicated the areas in which clarification is needed: it is proposed to continue talks to work out further details of clarification. As for the calling off of industrial action, the Home Office are 3. proceeding on the basis that the POA need a further ballot and that for the purposes of that ballot clarification of the Home Secretary's letter is necessary. 4. It has been agreed that there will be further contact with officials with the aim of resuming the meeting on Wednesday morning.
