MY TELNO 1580: GENEVA NEGOTIFATHONS: NEW SOVIET PROPOSALS

SUMMARY

- 1. SUBSTANTINE US RESPONSE UNLIKELY BEFORE GENEVA ROUND V ENDS
 ON 26 JUNE. BUT THUS DELAY NOT NECESSARILY UNFORTUNATE, AND
 STATE ACCEPT THE NEED FOR FULL US FOLLOW-UP, AND FURTHER CONTACTS,
 BETWEEN ROUNDS. FURTHER EVIDENCE THAT THE WHITE HOUSE TAKES THE
 OFFER SERBOUSLY. SOME OF INTS DETAILS LEAKING OUT, BUT STILL
 UNACCOMPANIMED BY ANY OVERT PENTAGON RUBBRISHING.
- 2. STATE DEPARTMENT CONTACTS TELL US THAT THE HINTER-AGENCY GROUP
 DID NOT HIN THE EVENT AGREE ON ANY SUBSTANTHIVE NEW HINSTRUCTHONS TO
 THE GENEVA DELEGATION, OR EVEN ON A LIEST OF QUESTMONS FOR THEM TO
 PUT, BEFORE TODAY'S (STRATEGIC OFFENSIVE SYSTEMS) PLENARY HIN GENEVA.
 WHILE THIS NO DOUBT REFLECTS THE PREDICTABLE HINTER-AGENCY
 DISAGREEMENTS

HERE, HIT HIS NOT SEEN BY STATE AS A SERHOUS SET-BACK, FOR KAMPELMAN AND CO ARE THOUGHT TO ALREADY HAVE AMPLE FLEXHBILLHITY TO PROBE THE SOVERT 11 JUNE PROPOSALS, AND THE NATURE OF THE LINK WHITH ABMT STRENGTHENING ETC. MOREOVER, SOME HAN STATE THENK HIT GOOD TO GIVE KAMPELMAN AT THEIS STAGE A PRETTY LOOSE REHN: A PRECEISE LIST OF SPECIFIC QUESTHONS WOULD HAVE HAD TO DRAW HEAVILY ON OSD INPUT, AND WOULD THEREFORE HAVE HAD A FAIRLY NEGATIVE THINGE.

- 3. OUR CONTACTS BELIEVE THAT THERE WILL NOT IN FACT BE ANY SUBSTANTINE NEW US INNSTRUCTIONS DURING THIS ROUND, WHICH ENDS NEXT WEEK. BUT THEY ACCEPT THAT THE BALL CANNOT SIMPLY BE KICKED INTO TOUCH FOR THE SUMMER. THE SOVIET TIMING HAS BEEN CLEVER, AND LEAVES THEM WITH A POTENTIAL PROPAGANDA ADVANTAGE, BUT STATE'S HOPE IS FOR AN EARLY SHULTZ/SHEVARDNADZE SESSION AT WHICH A FULL US RESPONSE, OR COUNTER-PROPOSAL WOULD BE MADE: IF SHULTZ/SHEVARDNADZE DOES NOT COME OFF, THEY ACCEPT THAT ANOTHER MEANS OF TAKING FORWARD THE US/SOVIET DISCUSSION MUST BE FOUND IN JULY.
- 4. DETAILS OF THE SOVIET THREE-PART PROPOSALS ARE LEAKING OUT
 TO SPECIALIST US JOURNALISTS. SOME HAVE COME FROM SOKOLOV, THE
 NUMBER 2 AT THE SOVIET EMBASSY HERE, BUT MOST CLEARLY BEAR OSD OR
 STATE DEPARTMENT FUNGERPRINTS, AND WE AGREE WITH SHR B CARTLEDGE
 THAT THE ADMINISTRATION COULD HAVE NO VALUE BREACH OF CONFIDENT—
 MALIETY COMPLAINT ABOUT GORBACHEV'S CENTRAL COMMITTEE PLENUM
 SPEECH. WHAT HE STRIKEING HIS THAT THE WHITE HOUSE/NSC EFFORT TO PROVENT

PREVENT OSD-INSPERED KNOCKIING COPY HAS SO FAR SUCCEEDED. THE
NEAREST THAT PERLE, WHO HIS PRINVATELY CRIMTICAL OF THE SOVIET.
PROPOSALS AS PROPAGANDA-INSPERED, HAS COME TO A PUBLIC COMMENT WAS
WHEN HE ALLEGEDLY TOLD A NORWEGIAN JOURNALMST THAT HE HAD AGREED
NOT TO BE THE FIRST TO CRIMTICUSE THE PROPOSALS.) WE UNDERSTAND
THAT REGAN, HAN A GENERAL LOBBY TERMS BRIEFING ON 13 JUNE, WAS
AT PALINS TO POINT OUT THAT, WHATEVER THEIR PUBLIC REACTIONS TO
THE 27 MAY SALT CONSTRAINT DECUSIONS, THE RUSSIANS HAD NOT REACTED
ADVERSELY HAN PRINVATE, AND HAN THIS CONNECTION STRESSED THAT THE
PROPOSALS FORMALLY TABLED IN GENEVA SHINCE ON AND 29 MAY HAD BEEN
HIGHLY SHIGNIFICANT, AND PROMISING.

CONCLUSION

5. SO FAR SO GOOD. THE CATCH WILL PRESUMABLY BE HE THE
RUSSHANS, HAVING WRONG-FOOTED THE AMERICANS BY SUBSTANTINE
PROPOSALS HISSUED SERNATHM LATE HIN THE ROUND, CHOOSE TO PLAY THEME
PROPAGANDA ADVANTAGE ALL OUT, MEANWHILE STRINGING THE AMERICANS
ALONG ON ARRANGING A SHULTZ/SHEVARDNADZE OR OTHER NON-GENEVA
FINXTURE. HE THE RUSSHANS SEEM TO BE MAKING PUBLIC OPHNHON HEADWAY
WITH A CONTRAST BETWEEN THEMER OWN DETAILED PROPOSALS AND
US SHLENCE/OBDURACY, THE CHANCES OF OSD BEHING ALLOWED/ALLOWING
THEMSELVES TO RUBBISH THESE PROPOSALS WILL RUSE. THIS HILLUSTRATES
THE APPARENT CONTINUING ABSENCE OF ANY RELIABLE (KISSINGER/
DOBRYNAM TYPE) BACK-CHANNEL FOR REAL AND RAPHD NEGOTIMATION, WILTHOUT
THE STATELY AND FORMAL CHARACTER OF THE GENEVA OPERATIONS,
POTENTHALLY A SERIOUS PROBLEM.
