MY TELINO 947: NUCLEAR TESTENSEL NEW US/SOVENET: DENALOGUE?

- 1. THE STATE DEPARTMENT, HAVE CONFIRMED (MOSCOW TELINO 778). THAT GORBACHEVES LETTER DELINVERED TO THE PRESEDENT ON 23 JUNE ACCEPTED THE SUGGESTION PUT BY THE PRESEDENT TO DOBRYMIN DURING HIS FAREWELL CALL IN APRIL (MY TUR) THAT US/SOVIET DISCUSSIONS WITHOUT PRECONDITIONS BE HELD ON NUCLEAR TESTING INSUES. GORBACHEV HAS PROPOSED AN EXPERT LEVEL MEETING IN EARLY JULY.
- 2. THERE HAS BEEN NO US REACTION SO FAR BUT STATE DEPARTMENT OFFICIALIS ASSUME THAT: THE ADMINISTRATION WILL NOW SHORTLY PROPOSE A VENUE AND ALITERNATIONE DATES! PERHAPS HIN AUGUST (JULY HIS CONSHIDERED TOO EARLY). THE ADMINISTRATION HINTEND TO FILELD A TEAM OF TECHNICAL EXPERTS BUT THERE HIS NO AGREEMENT, YET, ON HITS PRECIOUSE COMPOSITION NOR ON WHETHER HIT SHOULD BE LED BY A POLICY OFFICIALL OR A TECHNICAL EXPERT.
- ADMINISTRATION WELL NO DOUBT PROPOSE A DEVALOGUE ON TIBE VERIFFICATION WELL NO DOUBT PROPOSE A DEVALOGUE ON TIBE VERIFFICATION MISSUES. BUT THEY FULLY EXPECT THAT THE RUSSHANS WHILL WHISH TO DUSCUSS CITB-RELATED MISSUES AND OFFICIALS ANTICHPATE THAT THE PRESHDENT'S PROPOSAL FOR A DUSCUSSION QUOTE WITHOUT PRECONDITIONS UNQUOTE MEANS THAT THE ADMINISTRATION ARE BOUND TO ACCEPT THUS. LET THEREFORE NOW LOOKS AS ME CITB MISSUES WHILL SHORTLY BE BACK ON THE US/SOVINET AGENDA ALTHOUGH THE TWO SHIDES WHILL OF COURSE BE APPROACHING THEM AN RADMICALLY DIFFERENT WAYS.
- 5. THE PRESHIDENT'S SUGGESTION AND GORBACHEV'S RESPONSE ARE STIPLLI NOT PUBLIC KNOWLEDGE BUT STATE DEPARTMENT OFFICHALS EXPECT THATS, ASSUMING NO LEAKS IN THE HINTERING THERE WILL BE A PUBLIC ANNOUNCEMENT WHEN DATES AND A VENUE FOR THE MEETING ARE AGREED.
