NEW BURDENS ON LOCAL GOVERNMENT

In accordance with established practice, I am attaching the latest lists of Government initiatives having resource implications for local government which have been notified to my Department during the last six months. The first list contains details of proposals which are likely to result in increases in the demands on local government and the second list identifies measures which are expected to lead to some reduction.

Although the first list shows an increase over that for the preceding period (27 compared with 15) there was a welcome fall from 40 during the corresponding period last year. Some could have very substantial implications for local government expenditure. The second list contains initiatives which should lead to savings for local government. That it is slightly longer than its predecessor - 8 items compared with 5 - is perhaps a sign of grace and I am encouraged that the list is growing rather than diminishing.

There is some way to go before we can be fully satisfied with progress, particularly in quantifying the implications of proposals for local government at a formative stage and then where appropriate seeking the informal advice of the local authority associations. The procedure is nevertheless valuable in focusing attention on the potential impact of policies on local government and it should continue in force.

My officials have received a great deal of co-operation from officials in other Government Departments and I am confident that this will continue. They particuarly welcome early notice of new initiatives so that the new burdens drill can be integrated into the development of proposals. If sponsors do encounter any problems in relating these procedures to their own initiatives my officials are ready to offer whatever assistance they can.

I am copying this to the Prime Minister, members of E(LA) and Sir Robert Armstrong.
