1. ON 11 OCTOBER THE FOREIGN MINISTER GAVE SIR EDWARD YOUDE THE PRESIDENT'S REPLY TO THE PRIME MINISTER'S LETTER. THE ORIGINAL FOLLOWS BY BAG. THE TEXT IS AS FOLLOWS:

"DEAR PRIME MINISTER

I THANK YOU MOST SINCERELY FOR YOUR KIND CONGRATULATORY MESSAGE ON MY ASSUMPTION OF PRESIDENCY ON SEPTEMBER 1, 1960. AND I WOULD ALSO LIKE TO RECIPROCATE THE GOOD WISHES OF THE BRITISH GOVERNMENT AND PEOPLE. I AM PLEASED TO SHARE YOUR SENTIMENT THAT OUR TWONATIONS HAVE ALWAYS ENJOYED GOOD RELATIONS AND THAT CONGRETE CO-OPERATION IN MANY WORTHWHILE FIELDS HAVE STEADILY EXPANDED TO DUR MUTUAL SATISFACTION.

I ALSO TAKE PLEASURE IN REFERRING YOUR LETTER OF JUNE 29, 1980, ADDRESSED TO THE THEN PRESIDENT, H.E. CHOI KYU HAH, WHICH HAS BEEN PLACED BEFORE ME FOR RUNECESSARY COURSE OF ACTION.

AS FOR THE QUESTION OF SUPPLYING THE CONVENTIONAL PARTS
FOR NEW NUCLEAR POWER STATIONS, I WOULD LIKE TO INFORM YOU THAT
THE RECENT INDUSTRIAL REALISHMENT SCHEME OF MY GOVERNMENT
MAKES IT VERY DIFFICULT TO OFF X BRITISH FIRMS ANOTHER OPPORTUNITY
TO SUPPLY THEM FOR THE POWER STATIONS.

HOWEVER, IN COGNIZANCE OF YOUR PERSONAL INTEREST IN THE IMPORTANT COMMERCIAL MATTERS BETWEEN OUR TWO COUNTRIES, I HAVE INSTRUCTED MY MINISTRIES CONCERNED TO HAVE BOTH SIDES ENTER INTO NEGOTIATIONS FOR THE SUPPLY OF EQUIPMENTS AND MATERIALS REQUIRED FOR OTHER SUITABLE PROJECT INSTEAD OF THE PARTICULAR ONE REFERRED TO IN YOUR LETTER.

THE PRIME MINISTER

I am taking the opportunity of the visit to the Republic of Korea of Sir Ian Gilmour to address Your Excellency on an important commercial matter.

I understand that a decision will shortly be taken on the placing of contracts by the Korea Electric Company (KECO) for the supply of two new nuclear units. I believe that the contracts for the nuclear islands for these stations may be awarded as a result of bilateral negotiations. If this is so, I hope that it will be possible to offer British engineering companies a similar opportunity to negotiate for the supply of conventional islands for these two units and that your Authorities will give full consideration to the advantages which the major British manufacturer, GEC, could offer. For over ten years it has been successfully involved with your country's power programme and has supplied over half the turbine generators installed in your nuclear power stations. GEC has unrivalled understanding of the requirements of your electricity industry, and KECO's knowledge of GEC equipment is considerable. A further contract with KECO could lead to an extension of the licensing arrangements which GEC already has with Hyundai Heavy Industries, to a further transfer of technology, and to an increased share of manufacture in Korea.

These are technical advantages which speak for themselves.

I would moreover regard it as firm evidence of the good relations

our two countries have always enjoyed if your Authorities were to invite GEC to enter into discussions with a view to the conclusion of a negotiated contract. I very much hope that they will do so.
