SUMMARY

1. STATEMENT BY WALESA EMPHASISES POLITICAL NATURE OF CLOSURE OF SOLIDARITY'S BIRTHPLACE. NO CALL FOR STRIKES.

DETAIL

2. WALESA HAS ISSURED THE FOLLOWING STATEMENT:

THE DECISION TAKEN ON 29 OCTOBER ON THE LIQUIDATION OF THE LENIN SHIPYARD IN GDANSK EFFECTS THE ENTERPRISEIN WHICH BEGAN THE PROTEST OF THE WORLD OF LABOUR AGAINST THE PROFOUND DISTORTIONS OF OUR LIFE, AND WHERE THE AUGUST AGREEMENTS WERE SIGNED. THIS ENTERPRISE, THE CRADLE OF SOLIDARITY, IS A SYMBOL OF THE STRUGGLE OF THE WORLD OF LABOUR AND OF THE WHOLE OF SOCIETY FOR THE DIGNITY OF WORK, FOR THE DEEP REFORMS IN SOCIAL, ECONOMIC AND POLITICAL LIFE. PRIME MINISTER RAKOWSKI'S DECISION WAS NOT DETERMINED BY ECONOMIC FACTORS. THE POLISH ECONOMY REQUIRES RESTRUCTURING AND FUNDAMENTAL CHANGES. THE INDEPENDENT TRADE UNION SOLIDARITY ALWAYS SUPPORTED AND STILL SUPPORTS SUCH CHANGES. SOLIDARITY WILL DEFEND THE ENTERPRISE WHICH IS FOR IT AND FOR THE WHOLE NATION A SYMBOL OF THE STRUGGLE FOR A NEW BETTER POLAND. WE ARE READY TO SUPPORT THE WORKERS COUNCIL IN EFFORTS AIMING AT RESTORING THE ENTERPRISE'S HEALTH, APPOINTING MANAGENMENT ON THE PRINCIPLE OF, COMPETENCE AND NOT OF THE NOMENCLATURA, A CHANGE IN THE DERECTIONS OF PRODUCTION TOWARDS A FUNDAMENTAL IMPROVEMENT IN THE EFFECTIVENESS OF WORK. THE PRIME MINISTER'S DECISION COULD BE REGARDED AS A POLITICAL PROVOCATION AIMED AT THE IDEA OF RECONCILIATION, AT THE ROUND TABLE, SERVING THE CREATION OF TENSION AND CONFLICTS AND NOT THE SOCIAL CALM, WHICH THE AUTHORITIES SAY THEY ARE PURSUING.

COMMENT

3. WALESA'S STATEMENT PLACES THE CLOSURE IN AN ENTIRELY POLITICAL CONTEXT, LAYING THE BLAME FOR THE SHIPYARD'S DIFFICULTIES ON THE

PAGE 1 RESTRICTED SYSTEM AND SEEING THE DECISION AS A BLOW AIMED AT SOLIDARITY. HE DOES NOT CALL FOR STRIKE ACTION BUT DOES COMMIT SOLIDARITY TO DEFENDING THE SHIPYARD. HE PROPOSES ACTION THROUGH THE WORKERS COUNCIL (OR WORKERS SELF MANAGEMENT) AS A WAY OF DEALING WITH THE YARD'S PROBLEMS. HIS STATEMENT ALSO REFLECTS THE VIEW NOW INCREASINGLY HELD, THE THE ROUND TABLE IS, IF NOT DEAD, THEN INDEFINITELY POSTPONED. THE GOVERNMENT'S DECISION REFLECTS THIS.

WALESA SOME ECONOMIC LESSONS. THE AUTHORITIES NO DOUBT HOPE TO SECURE THE PRIME MINISTER'S ENDORSEMENT FOR THEIR ACTION. THEY MAY ALSO HOPE TO EMBARRASS HER, AND MAKE IT MUCH MORE DIFFICULT FOR HER TO EXPRESS PUBLIC SUPPORT FOR SOLIDARITY BY POSING IN THE MOST BLATANT WAY SUCH A CHALLENGE ON ECONOMIC POLICY. IN THE WORST CASE, AN OCCUPATION IN THE SHIPYARD COULD HAVE IMPLICATIONS FOR THE PRIME MINISTER'S VISIT TO GDANSK.

9. THERE IS LIKELY TO BE CONSIDERABLE INTEREST IN HMG'S REACTION TO THIS STEP, PARTICULARLY GIVEN OUR PERSISTENT CALLS FOR IMPLEMENTATION OF THE ECOMONIC REFORM. I DO NOT THINK IT IS REALLY FEASIBLE TO SEPARATE THE ISSUES OF SOLIDARITY AND ECONOMIC REFORM, AND INDEED WE HAVE, RIGHTLY, SAID THAT POLITICAL AND ECONOMIC REFORM SHOULD GO HAND IN HAND. I SUGGEST ANY PUBLIC COMMENT IS BASED ON THE FOLLOWING LINE:

WE HAVE CALLED FOR REFORM OF THE POLISH ECONOMY. WE HAVE NOTED A 500 THE ACTION TAKEN ON THE LENIN SHIPYARD. WE CANNOT JUDGE THIS STEP IN ISOLATION. IT NEEDS TO BE SEEN AS PART OF A BROADER POLICY. WE CONTINUE TO BELIEVE THAT DIFFICULT ECONOMIC DECISIONS LIKE THIS MUST GO HAND IN HAND WITH POLITICAL REFORMS TO ENSURE THAT THEY HAVE SUPPORT OF SOCIETY AND THAT SOCIETY AS A WHOLE deuries BELIEVES THEY WILL BRING LONG TERM BENEFITS. IN THIS CONTEXT, WE CONTINUE TO BELIEVE THAT THE SOLIDARITY MOVEMENT, AND OTHERS WHO STAND OUTSIDE THE POLITICAL ESTABLISHMENT IN POLAND, SHOULD BE GIVEN AN APPROPRIATE OPPORTUNITY TO PLAY A ROLE IN THE POLITICAL LIFE OF THE COUNTRY.
