SUMMARY

1. WHITH POHNDEXTER GONE, THE PRESS ARE NOW GUNNING FOR REGAN AND CASEY. THE POLLS SHOW THE PRESIDENT'S STANDING SLIPPING FURTHER.

DETAIL

- 2. MEDINA HINTEREST CONTHNUED UNABATED ON 27 AND 28 NOVEMBER
 DESPHITE THE THANKSGHWHING HOLHDAY, WHINCH TOOK THE PRESHIDENT TO
 CALLIFORNINA AND CONGRESSHONAL LEADERS BACK TO THEMR DISTRIBUTS.
- 3. THE PRINCEIPAL MEDITA QUEST HIS FOR EVHIDENCE THAT OTHER ADMINISTRATION FINGURES, IN ADDITION TO POHNDEXTER AND NORTH, KNEW OF THE HEAN/NECARAGUA OPERATION. THE SPOTLINGHT HIS NOW ON REGAN AND CASEY. UNHIDENTHIFHED WHATE HOUSE SOURCES ARE QUOTED AS ALLEGING THAT NORTH HAD BRANEFED REGAN ON THE CLANDEST HINE CONTRA-FINANCHING OPERATION. REGAN HAS DENALED THATS CATEGORICALLY, BUT THE PRESS RECALL EARLINER REGAN PRONOUNCEMENTS, EG QUOTE HE BECOME ONE OF THE FEW WHO KNOW THE FULL STORY UNQUOTE (16 NOVEMBER).
- 4. THERE ARE THREE CHA-RELATED STORMES.
- THAT CASEY WAS NOT AWARE OF THE CONTRA FUNDING OPERATION IN NOW BEHING QUESTIONED. PORNDEXTER HIS REPORTED TO HAVE SAIND PRINTALLY THAT CASEY WAS QUOTE HEAVING HINVOLVED UNQUOTE HIN THE HIRANHAN OPERATION AND CASEY HIMSELF HAS ACKNOWLEDGED THAT HE WAS AWARE OF QUOTE GOSSIP UNQUOTE ABOUT THE SECRET TRANSFER OF FUNDS TO THE CONTRAS.
- 6. SECOND, CASEY'S EVANDENCE TO CONGRESS LAST WEEK MIS NOW SAND TO HAVE MINCLUDED AN ADMINISTRATION THAT THE CHA SET UP A SWASS BANK ACCOUNT FOR MRANHAN PAYMENTS FOR US ARMS SUPPLIES.
- THE DEPUTY CHA DIRECTOR MCMAHON, WHO RESINGNED, FOR REASONS
 THAT ARE STALL OBSCURE, AND FEBRUARY.

- 8. DEMOCRATS CONTHINUE TO CALL FOR AN INDEPENDENT HINVESTINGATHON, AND/OR THE APPOINTMENT OF A SPECIMAL PROSECUTOR. THE ADMINISTRATION HIS TAKING THE LIMIT THAT THE FURST TASK, (IN WHINCH THE JUSTINGE DEPARTMENT HAVE NOW BEEN JOHNED BY THE FRIED, AND TO ESTABLINGH AN AUTHORISTATIONE FACTUAL RECORD. MEANWHILE, THE TOWER COMMINSSION HAS BEEN ASKED TO COMPLETE HITS REPORT HIN 30-45 DAYS.

 WEEK ABOUT THE DAWERSHON OF MERANMAN MONEY TO THE CONTRAS.
 EMIGHT OUT OF TEN THOUGHT THAT THE POWNDEXTER AND NORTH
 RESINGNATIONS WOULD NOT END THE CONTROVERSY, AND SEVEN OUT OF
 TEN DISAPPROVED OF THE PRESIDENT'S HANDLING OF THE EPISODE.
 HIS OVERALL APPROVAL RATING SLAPPED TO 53 PER CENT (DOWN
 14 POWNTS ON SEPTEMBER). AND THE MINFLUENTIMAL CONSERVATIONE
 COMMENTATOR GEORGE WHILL DESCRIBED THE WHATE HOUSE AMBRIENCE AS
 QUOTE A RESULT OF PRESIDENTIMAL DELEGATION TO THE POWNT OF
 HINATTENTIMON UNQUOTE, AND CALLED ON THE PRESIDENT TO ACCEPT THE NEED
 FOR TOTAL AND MIMMEDIMATE DISCLOSURE OF ALL! THE FACTS.
