Your minute of 29 April to Sir Robert Armstrong noted that the Prime Minister would like to see any statement at Venice on terrorism strengthened and extended to cover more than civil aviation aspects. Since the Personal Representatives meeting from 30 April to 2 May, the Italians have now prepared the text of a draft statement on terrorism to be made at Venice \* (attached).

The Foreign Secretary is clear that the draft statement needs to be made much more robust (as well as the English being improved). We have therefore done additional work on the Italian draft, in preparation for the meeting of Summit Seven Political Directors from 14-17 May and the final meeting of Personal Representatives immediately thereafter. I attach our redraft, which the Foreign Secretary himself has not yet seen. He will wish to discuss this text, and our tactics at Venice over terrorism, with the Prime Minister tomorrow morning.

It has been agreed that Terrorism Experts should also be in Venice on 14 May to work on the text on international terrorism. Duncan Slater, the AUSS responsible for counter-terrorism within the Office, will represent the UK. We shall therefore need to give him clear instructions by the end of 13 May.

## UK DRAFT OF SUMMIT SEVEN STATEMENT ON INTERNATIONAL TERRORISM

- 1. The Heads of State and Government reaffirm their condemnation of international terrorism in all its forms and of all those, including governments, who sponsor or support it.
- 2. They agree that the following principles must govern their common fight against terrorism:-
- No cause can justify terrorist acts.
- No concessions under duress should be made to terrorists or their sponsors.
- No state which supports terrorism can expect normal relations with the Summit Seven countries.
  - 3. Effective measures have already been agreed amongst the Seven to combat terrorism. Heads of State and Government resolve to apply further measures if new evidence of state involvement in terrorism emerges.

- 4. The Heads of State and Government note the progress made over the last year in bringing terrorists to trial and punishing them for their crimes. Nevertheless, terrorism continues to pose a threat. They are determined to intensify their combined efforts to combat that threat. There should be solidarity amongst the Seven in their efforts to prevent terrorist crimes and to bring the guilty to justice.
- 5. The Heads of State and Government regard every act of hostage taking and abduction as abhorrent. All those being held should immediately be released, without conditions.
- 6. The Heads of State and Government reaffirm the right of their citizens to work and travel freely wtthout the fear of terrorist outrage. They will therefore step up their efforts to improve the safety of air travel.
- 7. The Heads of State and Government recall that in their Tokyo Statement on International terrorism last year they agreed to make the 1978 Bonn Declaration more effective in dealing with all forms of terrorism affecting civil aviation. They are now jointly resolved that their Governments shall take immediate action to cease all flights to any country which refuses extradition or prosecution of those who have committed offences described in the Montreal Convention for the suppression of unlawful acts against the safety of civil aviation, or which does not return the aircraft involved.

At the same time, their governments will initiate action to halt all incoming flights from that country or by the airlines of that country. [They intend also to extend the Bonn Declaration in due course to cover any future relevant amendment to the above convention or any other aviation conventions relating to the extradition or prosecution of the offenders.] The Heads of State and Government urge other Governments to join them in this commitment.

ME KNOW IF YOUR EXPERT LET ON TERRORISM WILL BE AT THE MEETING: IN ANY CASE MR. FERRARIN PRESENT WILL BE WITH ME AT STRA. THE EXPERTS WILL MEET DINNER AT THE DANIELI HOTEL AT 8.30 P.M. ON ACCORDING TO THE DECISIONS TAKEN IN MAY 14TH. CERVO BY THE PERSONAL REPRESENTATIVES, THIS PORTO INFORMAL OCCASION AND NOT A MEETING WILL BE AN OF THE GROUP OF EXPERTS ON TERRORISM AS SUCH. THE HEADS OF STATE OR GOVERNMENT, REAFFIRMING THEIR CON-

DEMNATION OF INTERNATIONAL TERRORISM IN ALL ITS FORMS. OF ITS ACCOMPLICES AND OF THOSE, INCLUDIN GOVERNMENTS, WHO SPONSOR OR SUPPORT IT, ARE RESOLVED TO FURTHER INTEN-SIFY THEIR JOINT EFFORTS TO COMBAT INTERNATIONAL TERRORISM. THEY ONCE AGAIN DECLARE THAT TERRORIST ACTS ARE NEVER JUSTIFIED AND DO NOT SERVE ANY POL'ITICAL CAUSE AND THAT NO STATE WHICH SUPPORTS TERRORISM CAN EXPECT NORAL RE-LATIONS WITH THE SUMMIT SEVEN COUNTRIES. THEY ALSO REAFFIRM THEIR DETERMINATION TO APPLY, IN RESPECT OF ANY STATE CLEARLY INVOLVED IN SPONSORIN OR SUPPORTING INTERNATIONAL TERRORISM, EFFECTIVE MEASURES

WITHIN THE FRAMEWORK OF INTERNATIONAL L'AW. THEREFORE, THE HEADS OF STATE OR GOVERNMENT AGREE: 2. A) THAT THERE SHALL BE NO CONCESSIONS UNDER DURESS TO

TERRORISTS OR THEIR SPONSORS.,

B) THAT EVERY JOINT EFFORT MUST BE DONE IN ORDER TO COM-BAT THE TAKING OF HOSTAGES AND TO PREVENT THE SPREADING OF SUCH AN UNJUSTIFIABLE AND HATEFUL PRACTICE., C) THAT THERE MUST BE IMPROVED POLICE AND INTELLIGENCE COOPERATION AND EXCHANGES OF INFORMATION TO PREVENT TERRORISM AND TO BRING THE GUILTY TO JUSTICE., D) THAT THEY WILL CONTINUE THEIR EFFORTS TO IMPROVE THE SAFETY OF AIR TRAVEL AND PARTICULARLY TO SCRUTINIZE MORE CLOSELY THE ACTIVITIES OF AIRLINES OPERATED BY STATES SPONSORING TERRORISM.

THE HEADS OF STATE OR GOVERNMENT NOTED THE IMPRESSIVE PROGRESS MADE OVER THE L'AST YEAR IN BRINGING THE FORCE OF THE RULE OF LAW TO BEAR ON TERRORISM. THESE ACTIONS PROVIDE IMPORTANT EVIDENCE THAT OUR DEMOCRACIES HAVE THE INNER STRENGTH TO COMBAT TERRORISM WHILE MAINTAINING DEMOCRATIC LEGAL GUARANTEES FOR THEIR PEOPLES AND THOSE WHO ARE SUBMITTED TO THEIR JURISDICTION. THEY ALSO NOTED WITH SATISFACTION THE PROGRESS MADE IN STRENGTHENING INTERNATIONAL OBLIGATIONS FOR COMBATTING TERRORISM, PARTICULARLY IN FIELDS OF AIRPORT AND MARITIME SECURITY.

FURTHERMORE, IN VIEW OF MAKING THEIR COMMITMENT IN FIGHT-4. ING TERRORISM EVEN MORE EFFECTIVE, THE HEADS OF STATE OR GOVERNMENT PLEDGE THAT EACH OF THEIR STATES WILL: A) FIGHT TERRORISM THROUGH ITS LEGAL SYSTEM AND WILL NOT ALLOW TERRORISM TO SURVERT DEMOCRATIC LEGAL GUARANTEES AND PRCCEDURES ..

B) PURSUE EFFORTS TO COOPERATE ON THE INVESTIGATION, AP-PREHENSION AND PROSECUTION OF TERRORISTS.,

RING TERRORISTS TO JUSTICE WITHOUT REGARD TO THE ALL'EED POL'ITICAL MOTIVATIONS FOR THE CRIMES THEY COMMIT., IN
THAT REGARD, EACH STATE RENEWS ITS COMMITMENT TO PROSECUTE
OR EXTRADITE ACCORDING TO NATIONAL LAWS AND RELEVANT INTERNATIONAL CONVENTIONS THOSE PERSONS APPREHENDED FOR ACTS OF
TERRORISM.,

D) PROVIDE EACH OTHER THE GREATEST MEASURE OF ASSISTANCE WITH CRIMINAL PROCEEDING AGAINST TERRORISTS, INCLUDING SUPPLYING EVIDENCE AT THEIR DISPOSAL NECESSARY TO ENSURE SUCCESSFUL PROSECUTION AND CONSISTENT WITH NATIONAL LAWS., E) INTENSIFY EFFORTS TO IMPEDE THE MOVEMENT OF TERRORISTS

THROUGH INCREASED COOPERATION.

5. THE HEADS OF STATE OR GOVERNMENT RECALL THAT IN THEIR TOKYO STATEMENT ON INTERNATIONAL TERRORISM THEY AGREED TO MAKE THE 1978 BONN DECLARATION MORE EFFECTIVE IN DEA-L'ING WITH AL'L' FORMS OF TERRORISM AFFECTING CIVIL AVIATION. TO THIS END, IN CASES WHERE A COUNTRY REFUSES EXTRADITION OR PROSECUTION OF THOSE WHO HAVE COMMITTED OFFENCES DESCRI-BED IN THE MONTREAL CONVENTION FOR THE SUPPRESSION OF UNLAWFUL ACTS AGAINST THE SAFETY OF CIVIL AVIATION AND/OR DOES NOT RETURN THE AIRCRAFT INVOLVED, THE HEADS OF STATE OR GOVERNMENT ARE JOINTLY RESOLVED THAT THEIR GOVERNMENTS SHALL TAKE IMMEDIATE ACTION TO CEASE ALL FLIGHTS TO THAT COUNTRY. AT THE SAME TIME, THEIR GOVERNMENTS WILL INITIA-TE ACTION TO HALT ALL INCOMING FLIGHTS FROM THAT COUNTRY OR FROM ANY COUNTRY BY THE AIRLINES OF THE COUNTRY CONCERNED THEY INTEND ALSO TO EXTEND THE BONN DECLARATION IN DUE TO COVER ANY FUTURE RELEVANT AMENDMENT TO THE ABOVE CONVENTION OR ANY OTHER AVIATION CONVENTIONS RELATING TO THE EXTRADITION OR PROSECUTION OF THE OF-FENDERS.

THE HEADS OF STATE OR GOVERNMENT URGE OTHER GOVERNMENTS TO JOIN THEM IN THIS COMMITMENT.
