PRIME MINISTER

The Foreign Office want you to send the attached reply to Mr. Nakasone's message about the latest Japanese package of measures.

I am extremely doubtful whether it is worthwhile to do so:

- we still have not worked out what the package <u>really</u> amounts to;
- any words of welcome which you use, however cautious, will be used by the Japanese to deflect pressure on them at Venice. It is their usual tactic: release an incomprehensible package a few days before an Economic Summit, get a few governments to say that it is "welcome" and sit back and smile smugly at the Summit itself.

I think it is better that Nakasone should be given no comfort in advance, and that you should tackle him at dinner the first night and say what is <u>really</u> important is that the Japanese should be ready to give <u>explicit</u> undertakings in the Economic Declaration of the Summit itself.

Agree not to reply in advance?

The Foreign Secretary believes that whilst the latest Japanese package contains very large numbers, and although we have questioned Japanese officials about the figures, it is not possible to forecast its effect at all precisely, especially on imports. But we are reasonably satisfied that it goes further than previous packages, and represents a positive step towards strengthening domestic

demand in the Japanese economy and reducing their trade surplus. The Japanese themselves clearly believe that this package is different. This assessment is shared by Treasury officials.

The Americans have already gone on record as welcoming the package, while recognising that some details remain obscure. The package has apparently been favourably received by the financial community. The Foreign Secretary does not think that we should be as uncritical as the Americans. But it would be right to recognise the efforts which Mr Nakasone has made, give a cautious welcome to them, but emphasise that the important thing is that the measures should have - and be seen to have - the effect which the Japanese intend.

Since the Prime Minister may not in practice have the opportunity to speak to Mr Nakasone in Venice, the Foreign Secretary suggests that the Prime Minister might wish to send him a message in advance. I attach a draft.

I am also sending copies of this letter and its enclosures to Alex Allan (HMT), Tim Walker (DTI) and Trevor Woolley (Cabinet Office).
