VENICE ECONOMIC SUMMET: CANADIAN APPROACH

SUMMARY

1. MULRONEY LIKELY TO CONCENTRATE ON AGRICULTURE AND SOUTH
AFRICA. VENICE SEEN AS SETTING THE STAGE FOR THREE MAJOR INTERNATIONAL GATHERINGS UNDER CANADIAN CHAIRMANSHIP, IE FRANCOPHONE
SUMMIT, CHOGM AND 1988 ECONOMIC SUMMIT.

- 2. MULRONEY'S DOMESTIC RATIONG REMAINS LOW. THOUGH HE APPEARS TO HAVE STOPPED THE SLIDE, HE REMAINS WELL BEHIND THE TWO OPPOSITION PARTIES IN THE POLLS. HIS RECOVERY PLAN IS BASED, INTER ALHA, ON A CONSTITUTIONAL RECONCILIATION WITH QUEBEC (NOW APPARENTLY ACHIEVED), A NEW AND COSTLY DEFENCE POLICY (WHITE PAPER PUBLISHED TODAY), TAX REFORM (TO BE PRESENTED TO PARLIPAMENT ON JUNE 13) AND AN ACCEPTABLE TRADE AGREEMENT WITH THE U.S. (CURRENT DEADLINE EARLY OCTOBER). HE WILL COME TO VENICE PERSONALLY BUOYED UP BY HIS SUCCESS IN GETTING QUEBEC BACK ENTO THE CONSTITUTIONAL FOLD. HE WILL BE LOOKING TO VENICE TO ENHANCE HIS STANDING, WITH DOMESTIC OPENION, AS A RESPECTED WESTERN LEADER WITH A SEAT AT THE TOP TABLE.
- AGRICULTURAL ASSUES WILL BE HIGH ON HIS AGENDA. LOW
 INTERNATIONAL GRAIN PRICES ARE CAUSING SOCIAL AND ECONOMIC UNREST
 IN THE PRAIRIE PROVINCES. THE FEDERAL GOVERNMENT HAS HAD TO PROVIDE
 SUBSTANTIAL FUNANCIAL ASSISTANCE, WHICH THE EXCHEQUER CANNOT
 REALLY AFFORD, WITH MORE DEMANDS IN THE PIPELINE. HE WILL REPORT
 ON THE RECENT CAIRNS GROUP MEETING IN OTTAWA TO SHOW THAT OTHERS
 ARE AFFECTED. MULRONEY WILL BE PRESSING FOR EARLY RESULTS IN
 GATT ON AGRICULTURE AND SPECIFICALLY ACTION BY THE EUROPEAN COMMUNITY
 AND THE UNITED STATES. HIS THEME WILL BE: COMPETITION NOT
 BETWEEN TREASURIES, BUT BETWEEN FARMERS. HE WILL BE AWARE THAT HMG
 ALSO WANT TO SEE EARLY PROGRESS. HE WILL PROBABLY

 JOHN IN CRITICISING THE PROPOSED EC OIL AND FATS TAX. MORE
 GENERALLY, HE WILL WELCOME ANY ACTION THE SUMMIT CAN TAKE TO HELP
 STEM PROTECTIONIST PRESSURES, ESPECIALLY IN THE U.S..

- 4. HAVE LITTLE TO ADD TO MY TELNO 291 ON CANADIAN INTENTIONS
 TOWARDS SOUTH AFRICA. HAVING TRAILED HIS COAT PUBLICLY, IT WILL BE
 DIFFICULT FOR MULRONEY TO BACK DOWN WITHOUT LOSING FACE. THAT IS HIS
 WORRY. HE COULD HOWEVER SEE AN ESCAPE ROUTE IN THE SUGGESTIONS
 MADE BY THE HTALIANS FOR A PASSAGE ON SOUTH AFRICA IN THE VENICE
 COMMUNIQUE (PARA 2 OF ROME TELNO 349).
- AT THE FORTHCOMING MEETINGS OF THE FRANCOPHONIE, CHOGM AND THE

 1988 ECONOMIC SUMMENT. HE WILL HOPE TO SEE TRENDS AND THEMES
 EMERGING FROM VENICE WHICH CAN BE CARRIED THROUGH THIS SUCCESSION
 OF MEETINGS. ONE OF HIS MOTIVES ON SOUTH AFRICA IS TO SET SOME
 ACTION IN TRAIN THAT WOULD ENABLE HIM, AT THE FRANCOPHONIE AND CHOGM,
 TO ARGUE THAT THERE IS NO CALL FOR FRESH INSTRUMENT FROM ENTHER
 BODY SINCE THE SUMMENT SEVEN, WHO HAVE MUCH MORE CLOUT, HAVE THE
 SITUATION UNDER REVIEW. MORE HELPFULLY, HE WILL ALSO BE PRESSING
 FOR A POSITIVE STANCE ON THE DEBT OF THE POOREST COUNTRIES
 ESPECIALLY IN SUB-SAHARAN AFRICA.
