MR MARK FISHER: To ask the Minister for the Arts, when he intends to publish the report on the Arts in the Inner Cities, by Mr Paul Collard.

DRAFT ANSWER

I have considered a survey submitted by Mr Paul Collard and am placing a copy in the Library, together with a working document by the Arts Council, which I warmly welcome.

The Government does not accept many of the statements or recommendations in Mr Collard's survey, in particular those elements which over-emphasise central intervention and the role of the public sector. I do not intend to publish it.

The Government believes that the arts can play an important part in helping to revitalise the inner cities, particularly where they have the support of local and private sector interests.

Arts bodies do, however, need to present more clearly what they have to offer. I shall be considering how best to assist this over the next few months.

DRAFT ANSWER

Recent work confirms my view that the arts make a useful contribution to the implementation of the Government's strategy for the inner cities.

This work includes a survey submitted by Mr Paul Collard and a working document by the Arts Council. Neither document is suitable for publication but I am placing copies of both in the Library.

The Government does not accept many of the statements in Mr Collard's document or the centralising tendency of his recommendations. I am convinced that projects in the Inner Cities must come from the initiative of local and private sector interests! discussions I had in Newcaslte last week strongly confirm that view.

The need is for Arts bodies to present a coherent and effective account of what they have to offer. I shall be considering how best to assist in this over the next few months.

ARTS IN THE INNER CITIES

I spoke to your office earlier today about your Minister's planned statement about the place of the arts in inner cities regeneration, as described in your letter of 4 February to Nigel Wicks.
