PRIME MINISTER

Dear Anthony

I enclose a copy of John Plender's interview with Sir Geoffrey Howe together with the two excerpts we have included in the programme. They both appear in the second half where we deal with the Social Charter and the European Monetary System.

REFERENCE TO THE SOCIAL CHARTER

I think it's very important to try and persuade British commentators like yourself to diminish your obsession with the risk of isolation. (EDIT) If you take the Social Charter, that debate is shifting very substantially all the time. And the discussions that I've had with Jacques Delors and others, one's been able to make a significant impression by saying "look, these nations of Europe, come from tremendously different traditions, they've tremendously different ways of doing things. (EDIT) They must have different approaches to things like the Social Charter.

REFERENCE TO EMS

What I say is that the more closely we are participating in the exchange rate mechanism and in a sense the sooner we are fully engaged in it, the more likely we are to have a substantial influence on what's happening. I don't say that outside it we have no influence. Heavens above, we've - we've exercised a great deal of influence on a lot of the discussions in Europe over the last ten years. But in the monetary field, if the exchange rate mechanism is a part to which others are able to belong, then clearly inside rather than outside is a more influential position to be. Hence I repeat, there is no argument at all about the principle of membership. We've set out very clearly the conditions against which we shall judge when we join the - the institution to which we're committed.

(Q: Is there any likelihood at all that we might find our way into the exchange rate mechanism before the next election?)

Oh it must be a - real possibility, surely, yes. We have to make our judgement on the fulfilment of the conditions. I can't now tell you when that date will be, but I'm certainly not going to exclude any date from being in that category.
