RIYADH TELNO 14 TO FCO : EC DISCUSSION AT LUXEMBOURG - MITTERRAND'S NEW YEAR MESSAGE

## SHMMARY

- 1. MITTERRAND'S NEW YEAR MESSAGE BALANCES FRENCH READINESS FOR USE OF FORCE WITH NEED TO GO ON WORKING FOR PEACE.
- 2. PRINCE SAUD'S ALLUSION TO MITTERRAND'S 1 JANUARY SPEECH IS A REFERENCE TO THE PRESIDENT'S TRADITIONAL NEW YEAR'S EVE MESSAGE TO THE FRENCH PEOPLE, THE TEXT OF WHICH APPEARED IN TODAY'S ''LE MONDE''. THIS WAS IN LARGE PART AN ATTEMPT TO INSPIRE CONFIDENCE IN THE FRENCH PEOPLE IN THE ROLE OF FRANCE IN THE WORLD TODAY. IT CONTAINED NOTHING NEW ON THE GULF BUT CONSOLIDATES THE THEMES MITTERRAND HAS DEVELOPED SINCE THE CRISIS BEGAN, INCLUDING FRENCH READINESS TO RESORT TO FORCE IF NEED BE.
- 2. FOLLOWING WERE MITTERRAND'S MAIN POINTS ON THE GULF :-
- IF IRAQ WERE ALLOWED TO VIOLATE THE RIGHTS OF A PEOPLE TO SELF-DETERMINATION, NOTHING WOULD PREVENT THE STRONG FROM CRUSHING THE WEEK ANYWHERE ELSE IN THE WORLD:
- FRANCE WOULD APPLY THE SECURITY COUNCIL RESOLUTIONS, INCLUDING BY RESORT TO FORCE IF NEED BE:
- BUT ''I STILL BELIEVE IN THE CHANCES OF PEACE''. FRANCE WOULD WORK FOR THIS TO THE END, WHILST STANDING FIRM ON THE PRINCIPLES:
- IRAQ SHOULD REALISE THAT WHILST KUWAIT REMAINED OCCUPIED NOTHING WAS POSSIBLE: ONCE KUWAIT WAS EVACUATED EVERYTHING WOULD BECOME POSSIBLE: A TIME OF DIALOGUE WOULD THEN OPEN UP. ''I FAVOUR THE ORGANISATION THEN OF ONE OR SEVERAL INTERNATIONAL CONFERENCES FROM WHICH NOTHING WOULD BE EXCLUDED NEITHER ISRAEL'S RIGHT TO RECOGNITION AND SECURITY, NOR THE RIGHT OF THE PALESTINIANS TO POSSESS THEIR OWN COUNTRY, NOR THE RIGHT OF LEBANON TO ITS INTEGRITY, NOR THE RIGHT OF ALL, INCLUDING IRAQ AND KUWAIT, TO LIVE IN PEACE....''
- IN THIS WORK OF PEACE FRANCE BECAUSE SHE HAD BEEN PRESENT AT THE DIFFICULT TIME WOULD PLAY HER DUE ROLE (AS SHE HAD FOR
