GULF: MEDIA ARRANGEMENTS

GUT its points

You will recall that at OPD(G) on 3 January you said, in your summing up of the discussion of the current international situation, that when certain briefing being prepared by the FCO and JIC was available Ministerial colleagues should be encouraged to give interviews, and that this action should be co-ordinated through the network of Information Officers within Departments. Earlier this week I discussed with colleagues - including the Foreign and Defence Secretaries, the Chancellor of the Duchy of Lancaster and the Chief Whip - the machinery that would be needed to ensure that the Government's press line was properly co-ordinated over the whole range of issues arising from the crisis, in the event of hostilities and also in the run-up to them. We took as our starting point the proposals put forward by the Cabinet Secretary in his minute of 4 January to Mr O Donnell.

It has already been agreed that the Ministry of Defence will take the lead in respect of military operations in the Gulf, Equally, on matters which are the responsibility of one Departmental Minister only, it is up to that Minister to produce a suitable press line promptly, consult a you or other colleagues if he judges that the matter is sufficiently important. This seid, it is clear that as the pace of events accelerates the Government, will be under pressure to respond publicly, very quickly, to a wide range of developments. Machinery and procedures for co-ordinating this response, and ensuring that we are not wrong-footed, should therefore be put in place as soon as possible.

Those present at my meeting endorsed two proposals by the Cabinet Secretary for which I now seek your approval. The first is that your Press Secretary should chair a daily meeting of Information Officers. The nucleus of attendance would be from the FCO, MOD, Central Office of Information, Cabinet Office and Department of Energy; representatives of other Departments involved in aspects of the conflict (eg the Department of Transport and the Home

Office) could be invited when necessary. This meeting ought to take place early in the day and before OPD(G) meet.



The second proposal is that a Ministerial Group should be established under my chairmanship to ensure that Government supporters have the briefing they need and are appearing regularly to put across the Government's case. This should not cut across the arrangements for the Defence Secretary to take the lead on day-to-day operational news from the Gulf or for other Ministers to take the lead on matters within their departmental responsibility. (During the Falklands conflict there was a similar group under Cecil Parkinson's chairmanship which met to co-ordinate Ministerial media appearances in order to avoid bunching and periods of silence). The membership should include Ministers from the FCO and MOD, the Chancellor of the Duchy of Lancaster and the Chief Whip with the support of your Press Secretary and other Information Officers. The Cabinet Secretary suggests the attached composition and terms of reference for this Group.



The Cabinet Secretary has also suggested that it might be useful if part of the daily OPD(G) meetings were devoted to media handling matters and if your Press Secretary were to attend for this item before taking the No 10 Lobby. I think that this would be helpful if you are agreeable.

It would be helpful if we could settle these arrangements when OPD(G) meet on 10 January.
