The minute of 16 June from the Secretary of State for the Environment discusses the follow-up to the Government's decisions on the future organisation and financing of local government. It appears to be in accordance with collective decisions; but no doubt the Ministers concerned will take up any points of difficulty.

The Secretary of State also makes proposals on the Cabinet Committee organisation to take work forward. This minute is concerned with that aspect.

Control and Reform of Rates

The Secretary of State says that he doubt's whether it will be necessary to establish a special Cabinet Committee to oversee work on the control and reform of rates, since the decisions of principle have been taken. The Ministerial Sub-Committee on Local Government Finance (E(LF)) will be there to resolve any issues should that prove necessary.

Abolition of GLC and MCCs

The Secretary of State proposes the establishment of a new Ministerial Group to oversee the preparation of legislation and to take remaining policy decisions. I think that this would be advantageous, and recommend the establishment of a Group in the MISC series. Its membership might be as follows.

- 5. There are other Ministers with less central interests in the subject; they would receive copies of papers and be invited to attend meetings as necessary.
- 6. For the title of the Group I suggest: 'The Ministerial Group on the Abolition of the Greater London Council and the Metropolitan County Councils'. It is long; but I think that accuracy is important: if, for example, it became known that a 'Group on the re-organisation of local government' had been set up, there could be serious misunderstandings.
- 7. If you agree, I will put the necessary arrangements in hand. You will no doubt wish to reflect your decisions in any reply to the Secretary of State for the Environment.
