COMMUNITY CHARGE

I attach a table comparing the community charge that would be payable by each elector in each district with average rate bills in 1986-87. I also attach an extract from the Paper 'Paying for Local Government' about the effects in Scotland of the 1985 revaluation. The points below in support of a move to a community charge and against the alternatives draw on these.

In Favour of the Community Charge

- it will spread the burden of local taxation over all local electors;
- it will be fairer because larger households who use more local services will pay more;
- it will also be fairer because households with several earners will pay more than a single person, for example, pensioner households;
- it will benefit those living alone, particularly pensioners, who at present are unfairly penalised by rates. In all but 5 local authorities the community charge for a single person should be less than the average rate bill;
- and two adult households will pay less in community charge than the present average rate bill in almost two thirds of local authorities (65%);
- it will encourage responsible decisions by local authorities because all electors will be required to

contribute something towards the financial consequences of these decisions;

- housing benefit will meet 80% of the charge for the least well off;

It has fewer disadvantages than the other main options for change - local income tax or a reformed rating system.

Against A Reformed Rating System

- Rates based on capital values would involve massive increases in rates bills in London and the South East out of all proportion to ability to pay. Average house prices in Greater London (December 1986) are more than double those in Yorkshire and Humberside whilst average incomes are only a third higher (1985 FES). Pensioners would be particularly hard hit.
- A revaluation of rateable values on the present basis of rental values would also lead to larger increases in the South East since rateable values have not been revised for 14 years. The revaluation in Scotland in 1985, which covered only 7 years led to increases in rates bills for some ratepayers of more than a third [NB but some community charge bills will increase by at least this amount].
- And either sort of revaluation would lead to the unpredictable changes in individual rate bills unrelated to local authority spending decisions;
- Any redistribution of rates income to match it more closely with earnings is likely to lead to the opposite effect - an increase in rates bills in the North - since rateable values there are lower in relation to incomes than they are in the South (eg Guildford average rateable

value 2½ times higher than that of Easington but incomes in South East region only 1½ times those in North (1985 FES)).

- Rates bear little relationship to ability to pay. The single pensioner pays as much as the family next door with earning parents and two earning adult children

Against a Local Income Tax

- A local income tax would either involve establishing a new local bureaucracy to collect the tax, with Town Hall officials requiring details of every resident's income;
- Or would be levied as a surcharge on National Income Tax. This would have a damaging effect on incentives and weaken the accountability of local electors to their electorate. Many taxpayers would probably be unaware how much of their tax bill was the responsibility of their local authority.

8.18 While revaluation does not of itself alter the total to be raised from all ratepayers in Scotland, it affects the bill paid by the individual ratepayer in a number of ways. Most obviously property in the area as a whole. Changes in the aggregate of rateable values between local authorities affect the distribution of the resources element of rate support grant (paragraph 8.11) and so change the amount which each authority has to take from ratepayers locally. There may be major switches in the relative share of total value borne by different sectors—domestic, commercial, industrial etc—leading to changes in the scale of domestic rate relief or industrial de-rating. The combined impact of these changes, quite aside from any real movement in the pattern of local authority spending, may easily face someone with a rates bill increasing by a factor of 50% or even 100% or more in a single year.

8.19 Initial figures from the 1985 revaluation suggested that over Scotland as a whole the share of rateable value in the domestic sector would increase sharply with a corresponding decline in the share of the industrial sector. The Government increased the domestic element of rate support grant (paragraph 8.10) eightfold in 1985/86 to ease the impact of revaluation and adjusted Scottish industrial derating from 50% to 40% to maintain parity with industry elsewhere in Britain. After allowing for these adjustments, domestic ratepayers were still faced with 1985/86 rate bills rising on average by 11% in Grampian, 15% in Borders and Dumfries and Galloway, 20% or more in Tayside, Fife and Strathclyde. Such changes bore no relation to the movements in local authority spending in these areas, which ranged from an increase of around 3% in Tayside to some 6% in Dumfries and Galloway and Fife. Revaluation has faced very many Scottish householders with what are seen as quite arbitrary and unpredictable impositions.

8.20 Average movements at the regional level mask even more dramatic increases falling on individual ratepayers. The average domestic valuation in Scotland increased on revaluation by a multiplier of almost 2.7, but 130,000 Scottish householders faced multipliers of more than three times their previous rateable values. The degree of fluctuation about the average was still more marked in the commercial and industrial sectors. To mitigate the impact on those ratepayers hardest hit by revaluation the Government introduced legislation during the summer of 1985 to establish a special scheme of Revaluation Rate Rebates. Under this, 1985/86 rate bills were limited to the amount payable on three times the 1984/85 valuation of a property with a central Government subsidy making up the difference where the valuation had increased by a multiplier of more than three, subject to a maximum of £10,000 for any single property. Despite the benefit of this to those worst affected by revaluation over 100,000 householders in Scotland have faced increases of more than one third in their rate bills between 1984/85 and 1985/86. In part this reflects the way in which some authorities increased their spending after revaluation, but is primarily the result of above average increases in rateable values.

8.21 Against this background it is no surprise that the 1985 revaluation has forcibly reminded many Scottish ratepayers of the defects in the rates as a means of paying for local government. There has been widespread loss of public confidence in the present Scottish rating system and a vociferous demand for reform.
