Mr. Turnbull No. 10 - COMMUNITY CHARGE LIABILITY Mr. Catford Westminster City Council are now in the process of sending out registration forms for the community charge, which comes into effect next April. They have sent to the Treasury a combined form covering Nos. 10, 11 and 12 Downing Street, and the Treasury itself. I have agreed with the Chancellor's office that they will return this form to Westminster, not completed, and ask the Council to send out separate forms for the different properties. I should be grateful if, when the new form for No. 10 is received, I could be alerted. I have already let the Prime Minister have a note about the likely community charge position in relation to all her residences, and would like to remind her of this in conjunction with the registration form when it arrives. # LIABILITY OF PRIME MINISTER AND MR. THATCHER TO COMMUNITY CHARGE

- The Prime Minister and Mr. Thatcher will obviously be liable to a personal community charge like everyone else.
- 2. The precise assessment of liability both for the personal charge and for second homes rests with the relevant charging authorities; it is for them to reach the final decision on which is the Prime Minister's main residence. The registration forms in relation to No.10 and Dulwich will be completed in the normal way so that the charging authorities can make their determinations.
- 3. The position at Chequers will be handled by the Trustees in conjunction with the relevant charging authority.
- 4. [If specifically asked] The Thatchers have returned a completed form in relation to Dulwich.
