LOCAL AUTHORITY CURRENT: 1991-92 TOTAL STANDARD SPENDING DISTRIBUTION BETWEEN SERVICES

Thank you for your letter of 21 September about Service Shares for 1991-92. In your letter you seek agreement to a distribution methodology that would give Education Standard Spending of f17,467m.

This is the figure that the Government will have to defend as adequate for the delivery nationally of education services in 1991-92 and as a sound basis for the education component of standard spending assessments. I am greatly concerned in this context that the figure represents a fall of over 1% in education's share of TSS compared to 1990-91 (46% to 44.8%) at a time when there are very severe pressures on education budgets and a growing public campaign for increased spending.

Using this year's budgets as a way of allocating next year's TSS is tantamount to rewarding services for overspending, which hardly seems compatible with our overall philosophy on local authority financing. I would much have preferred to see a pure TSS-based distribution which would give Education a share significantly above the Option III level, and broadly equilivant to this year's in proportional terms. Your letter does not give a comparison with 1990-91 standard spending, but it is important to note that your proposed option gives the other services block a 25.6% increase on this year's standard spending allocation and PSS a 22.6% increase, compared with 15.8% for education.

However, I recognise that it is very difficult to resolve the conflicting interests of different Departments in the service share distribution. I further recognise that the distribution you are proposing does make reasonable allowance through topslicing for the cost of a teachers' pay settlement in 1991-92. I am therefore prepared, but I must say very reluctantly in view of the points I have made, in the interests of reaching agreement, to go along with option II provided other colleagues are also willing to do so. I could not, however, accept any further erosion in education's share and would expect education to get a full proportionate allocation of any small further upward adjustment that might be possible when figures are finalised.

My agreement is also subject to the continuation of the direct funding of the current Work-Related Further Education Programme by the Department of Employment (either via the Training Agency or TECs). That funding supports mainstream local authority FE provision and is netted off for the purposes of the Education Standard Spending total. I do not believe on training policy grounds that we can assert that local authorities no longer need to make this provision. That being so a reduction in the programme would imply a new spending burden on local authorities, which has not been taken into account in setting TSS or in the proposed service share distribution.

The illustrative effects of this package on SSAs, are shown in the attached table.

These figures are based on the service split within TSS described as Option (ii) in Norman Lamont's letter of 21 September the effect of using the Option (ii) service split, rather than Option (i), which I prefer, is very little in terms of the distribution of SSAs. The SSA figures are not final as there are still data changes to be incorporated, in particular student and pupil numbers.

It is essential that we quickly reach decisions on the SSA package so that we can formally consult local authorities at the end of October with a view to a full settlement before Christmas. There is a long lead time in making calculations and preparing the necessary documents. I would be grateful for your views and those of colleagues to whom I am copying this letter on their own aspects of the package, by Location of Cotober if possible. I apologise for this tight deadline, but it is necessary if we are to achieve a pre-Christmas settlement.

EFFECT OF PROPOSALS FOR CHANGES TO SSA METHODOLOGY The table below shows the effect of the proposals for changes to SSA methodology set out in the Secretary of State for the Environment's letter. The table shows: Column 1: provisional 1991/92 SSAs in £ per adult with no changes in methodology, TSS of £39bn and based on the service split of TSS in Option II of the Chief Secretary's letter of 21 September; Column 2: the effect of the proposed methodology changes in £ per adult; the resulting 1991/92 SSA in £ per adult Column 3: after methodology changes; the increase in SSA between 1990/91 and 1991/92 Column 4: with the proposed methodology, in £ per adult; Column 5: the increase in SSA between 1990/91 and 1991/92 with the proposed methodology, as a percentage. All SSA figures are provisional as there are further indicator data changes to come, particularly on population in different age bands, numbers of school pupils and relevant population. Changes to community charges will depend on budget decisions by individual authorities and decisions still to be taken on charge capping in 1991/92. The effect of changes in SSA methodology shown in the tables would, for given budget decisions by local authorities, feed through £ for £ into community charges. An increase in SSA due to methodology changes would reduce the charge in its area from the level which would be set if there were no change in SSA methodology.
